1. CALL TO ORDER

The meeting was called to order at 9:05 a.m. by Mayor Hazel McCallion, with the saying of the Lord's Prayer.

5. PRESENTATIONS

(a) Salt Institute's 2008 Excellence in Storage Awards to Transportation & Works

Department

Mayor Hazel McCallion presented the Transportation & Works Department with two Salt Institute's 2008 Excellence in Storage Awards to the Transportation & Works Department in recognition of the City's high standards of environmental consciousness and effective management of winter materials storage at its Clarkson and Mavis Works Yards.

Joe Pitushka, Director, provided background on the awards. The Clarkson Works Yard is one of four award winners in Canada to receive the Salt Institute's 2008 Excellence in Storage Award, recognizing its outstanding salt-storage facilities (salt domes) as well as its environmentally-conscious policies and procedures related to snow-clearing operations.

The Mavis Works Yard is one of only two award winners in Canada to receive the Salt Institute's 2008 Continuing Excellence in Storage Award for sustaining an award-winning program that minimizes the environmental impact of its snow-clearing operations.

Mayor McCallion stated that she was pleased to hear that the department received an award for its environmentally sound practices in storage and maintenance when salting of roads is not good for the environment.

A photograph with staff from the Transportation and Works Department was taken while accepting the award.

6. <u>DEPUTATIONS</u>

(a) Opportunities in the Global Marketplace for Canada's Nuclear Industry and its potential economic impact on Mississauga

Dr. Neil Alexander, President of the Organization of CANDU Industries addressed Council to present an overview of Canada's nuclear industry's worldwide expansion and its potential positive impact on the economy of Mississauga. He spoke about the benefits of nuclear energy to Ontario, noting that there is a plant here in Mississauga. Using a power point presentation, Dr. Alexander showed a slide of the plant in China which was built by the plant in Mississauga and has been in operation for 5 years. He stated that building a new nuclear plant in Ontario will revitalize Canada's nuclear industry, inject billions of dollars into the economy and create thousands of new jobs as most of the parts for the nuclear plant are pre-fabricated in manufacturing businesses locally so that they can be regularly inspected. Further, he pointed out that many of these individuals are also residents of Mississauga. Dr. Alexander explained that more than 3000 people in Mississauga already work in jobs related to the nuclear industry and there is a potential for many more to be created. He also pointed out that these jobs require skills that can be transferred from ailing sectors like the automotive industry. Copies of his presentation were distributed to Council.

Further, Dr. Alexander explained that CANDU Industries represented 117 Canadian companies that supply goods and services for the CANDU reactors and using powerpoint slides, he showed future global markets where CANDU could play a significant role, there by benefiting, Mississauga, Ontario and Canada.

Mayor Hazel McCallion agreed that there was a need to look at the current economy and how companies who have been affected by its downturn can retool to use their facilities for other products. She noted that the aerospace industry was also expanding and the retooling of companies that manufactured auto parts to address the aerospace industry needs was beneficial to keeping people employed and wished CANDU well in establishing themselves in the world market.

(b) Safe City Mississauga

Brad Butt, Chair, Board of Directors, Safe City Mississauga, introduced Teresa Burgess-Ogilvie, the new Executive Director, and provided a brief update on the work of the organization.

Teresa Burgess-Ogilvie also addressed Council and shared some of the Safe City goals, thanking council for their support in the past and future.

Councillors Pat Saito and Sue McFadden who are on the Safe City Board welcomed her and expressed confidence in having her as a new Director.

Councillor Pat Saito thanked Brad Butt for his contributions in volunteering for Safe City.

Councillor Sue McFadden thanked Sheila Wilson for her dedication and hard work until a new director was on board. Also she thanked Ashley Lyons who is a Program Manager with Safe City.

Councillor Katie Mahoney stated that she was part of the previous Crime Prevention organization and was pleased to have Teresa Burgess-Ogilvie on board given her strong beliefs in living in a safe city and offered to assist her if needed. She too thanked them for all their past hard work.

Councillor Carolyn Parrish stated that the City of Mississauga was fortunate to have some strong people in Mississauga such as Brad Butt who volunteer and are so reliable.

Councillor Nando Iannicca also thanked Mr. Butt for his on-going volunteerism and for having contributed so much to the Ward 7 community.

Mayor McCallion also extended her compliments to Brad Butt and recognized the outstanding contribution he has made by way of volunteering in Mississauga.

(c) 2008 Tree Lighting Ceremony and Rotary Festival of Lights

Melissa Di Carlo, Manager, My Mississauga, presented the 2008 Tree Lighting Ceremony Plans and introduced Lyn Lewis, Rotary Club of Mississauga to speak about the Rotary Festival of Lights. She distributed copies of the presentation to members of council.

Ms. Di Carlo advised that this year there will be more lights and more entertainment than ever before. Five donated trees will light up the Civic Square. She thanked all departments who worked with her on this project and listed the sponsors who made contributions to the event.

Lyn Lewis introduced this year's "forest of lights" and advised that there will be changes made to the light formations with more lights on the upper level. She advised that they wish to make it a festive winter fair in the City Centre.

Mayor Hazel McCallion thanked the Rotary Club for this initiative complimenting that the Civic Square would look beautiful. Further, she affirmed that the trees are donated by residents when they need to cut it down for a reason. She was advised that there is now a waiting list of people who wish to donate their trees for the civic square.

Councillor Sue McFadden reminded that an elaborate colour package was distributed to the Councillor and every effort to reduce printing costs should be made.

(d) Sign By-law – Mobile Signs

Ian Duffy, President, Magnetsigns, addressed Council on behalf of his company and three other sign companies with respect to their concerns relating to mobile signs as regulated by the current Sign By-law. He advised that previously he asked that the City consider making two changes to the bylaw i.e. modification to the distance separation and the number of mobile signs permitted per frontage/property. Also, they requested that they be permitted to continue to use at least two colours in the mobile signs. Correspondence was included with the Agenda for information.

Mr. Duffy stated that the industry believed that since the by-law was introduced, the quality of colour signs and letters has improved and colour in the signs made the message more visible. Further, he noted that several businesses are located within a single property (plaza) and the by-law restricts the number of signs per year on the property with long blackout periods, leaving some of the businesses without the opportunity to advertise. The lack of access to mobile signs hampers many small businesses and urged that these restrictions be reviewed as they negatively impact small businesses that typically use this type of advertising.

Mr. Duffy read out three letters from businesses who supported the concerns raised with respect to the sign by-law i.e. Pizza Pizza, a car lube company and the Erin Mills Development who particularly expressed concerns with the long black out periods and suggested that in a multi tenant plaza, the blackout periods be shortened so that more businesses could have an opportunity to advertise using mobile signs.

Councillor Pat Saito advised that she could not support adding of colour as she felt that the black and white signs worked just as well. She advised that the city had to put in the controls because there was a mess of mobile signs all over with excessive neon coloured lettering. The councillor supported the review of the by-law as it related to the number of signs per plaza frontage.

Councillor Carolyn Parrish felt that the colours in the signs drew attention to the message and created a level playing field, adding that she could support two colours on a sign as before. Further, the Councillor requested that any modification to the Sign By-law be done as soon as feasible as Christmas was fast approaching.

Councillor Maja Prentice felt that the current by-law has reduced the proliferation of signs and it was time review the specific concerns. She stated that businesses in her Ward have expressed concern that they need signs but cannot get access to one because of the regulations in the by-law. She did not wish the proliferation of signs to re-occur, however, she supported some adjustments to the by-law to help these businesses. Councillor Prentice also agreed that some colour in the sign attracted attention and suggested that staff advise on how some interim solutions could be made to assist given that Christmas was 5 weeks away.

Ian Duffy summarized his request to grant permission for two colours per sign and that they be granted an extension to the deadline of the current by-law.

Discussion took place with respect to the requirements of the Municipal Act and notification requirements of any amendments to the current by-law. Members of Council were advised that staff would be required to follow a formal public process with appropriate notification.

Direction was given to staff to see how they can address the concerns raised by the deputant, Ian Duffy, Magnetsigns, in a timely manner.
