MATTERS CONSIDERED:

1. Parking Prohibition Copperwood Lane and Callaway Lane (Ward 10)

Corporate Report dated October 1, 2008 from the Commissioner of Transportation and Works with respect to a proposed parking prohibition, Copperwood Lane and Callaway Lane.

RECOMMENDATION

That a by-law be enacted to amend By-law 555-2000, as amended, to implement a parking prohibition on both sides of Cooperwood Lane between Waterwind Crescent (south intersection) and Waterwind Crescent (north intersection) and on both sides of Callaway Lane between Sunlight Street and Bala Drive.

Councillor Katie Mahoney moved approval of the recommendation in the subject Corporate Report. The motion was voted on and carried.

2. <u>Bicycle Lanes and Parking Prohibition on Credit Valley Road (Ward 8)</u>

Corporate Report dated September 19, 2008 from the Commissioner of Transportation and Works with respect to proposed bicycle lanes and parking prohibition on Credit Valley Road.

RECOMMENDATION

That a by-law be enacted to amend By-law 555-2000, as amended to:

- 1. Implement bicycle lanes on both sides of Credit Valley Road between Erin Mills Parkway and Tavistock Court.
- 2. Prohibit parking on the south side of Credit Valley Road from Idlewilde Crescent (east leg) to Tavistock Court.

3. Smart Commute Mississauga Discounted Monthly Transit Pass Proposal

Corporate Report dated October 1, 2008 from the Commissioner of Transportation and Works with respect to the Smart Commute Mississauga Discounted Monthly Transit Pass Proposal.

RECOMMENDATION

- 1. That the deputation by Mr. Glenn Gumulka, Executive Director, Smart Commute Mississauga to General Committee at its meeting on October 15, 2008 with respect to the Smart Commute Discounted Monthly Transit pass proposal be received for information.
- 2. That the Commissioner of Transportation and Works and the City Clerk be authorized to execute an agreement with Smart Commute Mississauga to administer an 18-month pilot to provide matching transit discounts to Smart Commute Mississauga member organizations as outlined in the report to General Committee dated October 1, 2008 from the Transportation and Works Department.

- 3. That Smart Commute Mississauga be recognized as the exclusive selling agent of discounted transit passes and as such be eligible to collect a standard agent's fee on pass sales.
- 4. That the Transportation and Works Department report to General Committee on the results of the pilot trial pass discount to Smart Commute Mississauga member organizations program following the first year of operation.
- 5. That all necessary by-laws be enacted.

Mr. Glenn Gumulka, Executive Director, Smart Commute Mississauga appeared before Committee with respect to the Smart Commute Mississauga Discounted Monthly Transit Pass Proposal. Mr. Gumulka advised that the primary objective of Smart Commute Mississauga is to work with employers in the City of Mississauga and their employees to choose healthy sustainable transportation choices by reducing single occupancy vehicle use, which will lead to a reduction of air pollution and greenhouse gas emissions.

Mr. Gumulka described the proposed pilot program, noting that it provides an opportunity for Smart Commute Mississauga to collaborate with Mississauga Transit in the development and assessment of an employer based initiative aimed directly at promoting public transit use. He explained that in order to receive a discount, employees of participating companies are required to make a 12-month commitment to the program as a condition of participation. As such, the Program will provide a constant stream of predictable revenue for Mississauga Transit.

Mr. Gumulka noted that employers who offer a 25% transit pass discount to their employees would qualify for the maximum proposed matching discount of 15% by Mississauga Tansit. He advised that the proposal also includes an Emergency Ride Home Program, and explained how the program will be administered.

Mr. Gumulka noted that Smart Commute Mississauga has gathered data from over 3,000 employees in the City of Mississauga via commuter surveys, which demonstrated that there are individuals who are willing to try using public transit as a means to commute to work. Mr. Gumulka advised that the data collected suggest that discounted transit passes available through employers, coupled with an Emergency Ride Home Program may provide the key incentives to unlock some of the latent demand that currently exists.

Mr. Gumulka advised of that if the program is successful, Smart Commute estimates that there could be a reduction of 500 single occupant vehicles from city streets. He further advised that a discounted proposed transit pass program would demonstrate a commitment to supporting both the use of public transit, and working towards thinking in an environmentally responsible manner. He concluded that shifting commuters to sustainable modes of transportation, is a vital step to easing traffic gridlock in the City of Mississauga and would reduce air pollution and greenhouse gas emissions. There were no questions or comments from Committee.

Councillor Maja Prentice moved approval of the recommendation in the subject Corporate Report. The motion was voted on and carried.

4. Fees and Charges: Mississauga Transit Fares Proposed Fare Increase (effective January 26, 2009)

Corporate Report dated October 1, 2008 from the Commissioner of Transportation and Works with respect to proposed Mississauga Transit fare increases.

RECOMMENDATION

- 1. That the deputation made by Mr. Harbans Singh to General Committee at its meeting on October 15, 2008 with respect to the proposed Mississauga Transit fare increase be received for information.
- 2. That effective January 26, 2009, Mississauga Transit fares and related charges be set as detailed in Appendix 1 of the report dated October 1, 2008 to General Committee from the Commissioner of Transportation and Works.
- 3. That a by-law be enacted to establish the proposed 2009 Mississauga Transit fares and related charges as detailed in Appendix 1 of the report dated October 1, 2008 to General Committee and repeal Mississauga Transit Fares By-law 408-07.
- 4. That the Transportation and Works Department reply to the petition submitted by Mr. Mahmud Ahmad and inform him of the reasons for the previous 25% increases to the seniors' annual transit pass and the new 2009 rate.

Mr. Harbans Singh appeared before Committee with respect to the proposed Mississauga Transit fare increase. Mr. Harbans gave a brief history of recent senior transit fare increases in the City of Mississauga. He compared the rise of the senior transit fare to rising gas prices and commented that the senior transit fare has increased exponentially. He expressed concern about the increase and requested further information.

Mr. Martin Powell, Commissioner of Transportation and Works, responded to Mr. Singh's concerns. He noted that in the past the Mississauga seniors' fares had been the lowest in the entire Greater Toronto Area (GTA) and that there had been gradual increases to make the Mississauga Transit Senior Fare comparable to other transit systems operating in the GTA. Councillor Prentice requested that Mississauga Transit provide Mr. Singh with a copy of the Corporate Report, including the appendix, which

benchmarked Mississauga Transit fares to other fares in the GTA. She commented that the appendix shows that when compared to other transit systems in the GTA, the proposed fare increase is reasonable.

Councillor Pat Mullin moved approval of the recommendation in the subject Corporate Report. The motion was voted on and carried.

17. Committee of Adjustment Member Remuneration Review

Corporate Report dated October 3, 2008 from the Commissioner of Corporate Services and Treasurer with respect to a review of Committee of Adjustment Member Remuneration.

Councillor Carolyn Parrish pointed out that to keep track of the Committee of Adjustment mileage claims submitted for each meeting may become tedious and suggested that a flat mileage rate of \$40.00 per meeting be awarded to the Committee. Further, she suggested that Committee of Adjustment remuneration be adjusted annually, with a cost of living allowance similar to that received by Members of Council. Councillor Iannicca expressed support for Councillor Parrish's amendments, and commented on the nature of work completed by the Committee of Adjustment. He requested that the \$40.00 mileage amount be based on the City's mileage rate, and therefore it may be adjusted accordingly to gas prices and other contributing factors. In response to a question from Councillor Prentice, Ms. Brenda Breault, Commissioner of Corporate Services and Treasurer clarified that the \$40.00 amount would only be awarded to those members who attend the meeting. She commented that an annual adjustment as opposed to one made every four years is a reasonable request and can be accommodated.

Mayor Hazel McCallion complimented the work done by the Committee of Adjustment and expressed support for the proposed remuneration changes. Councillor Carlson noted that he had initially raised the issue of Committee of Adjustment remuneration and expressed support for the amendments, and commented on the work, and sound decisions made by the Committee of Adjustment. Councillor Pat Mullin expressed support for the amended recommendation and noted that the issues before the Committee have increased in their complexity. Councillor Saito commented that the remuneration adjustment was long overdue, and described the extensive preparatory work and onsite visits conducted by members of the Committee.

Councillor Mullin advised that within the Credit Valley Conservation, the current City of Mississauga members have taken a leadership role. She highlighted some of the critical issues facing the Credit Valley Conservation and noted their particular challenges. She commented that the composition of the CVC should be evaluated carefully, and suggested that citizen members could be added in addition to the current appointed Councillors.

Councillor Dale advised that in the 1990s the structure of the CVC included citizen representation and totalled over 20 members. He noted that the in the past citizen members were appointed by the Province of Ontario. Councillor Dale advised that the CVC went through organizational changes, which resulted in the elimination of the executive, and a reduction of members on the CVC, and described the current composition of the CVC, with respect to its regional representation. Councillor Parrish

advised that she is in support of the recommendation in the Corporate Report and suggested that in future, there could be a two year term, with an option for renewal.

Councillor George Carlson moved approval of the recommendation in the subject Corporate Report. The motion was voted on and carried.
