1. <u>CALL TO ORDER</u>

The meeting was called to order at 9:09 a.m. by Mayor Hazel McCallion, with the saying of the Lord's Prayer.

3. <u>MINUTES OF PREVIOUS COUNCIL MEETINGS</u>

4. <u>APPROVAL OF THE AGENDA</u>

(a) At the request of Councillor Carolyn Parrish, a motion with respect to the sale of land to United Lands (Wintor Equities Inc.) at the southwest corner of Creditview Road and Eglinton Avenue for the development of Assisted Housing, was added to the Agenda.

5. <u>PRESENTATIONS</u>

Ross Mayot, VP of Community, Canadian Association of Retired People (CARP) and Ms. Saskia Wijngaard, Mississauga Carp Chair, presented Mayor Hazel McCallion the first and only Honorary Lifetime Membership in CARP. An award was presented and a photograph was taken.

6. **DEPUTATIONS**

(a) <u>Tax Apportionments</u>

There were no persons in attendance to address Council regarding tax apportionments.

(b) <u>Mississauga Corporate Security</u>

Ursula Keuper-Bennett addressed Council with respect to "Matters of Insecurity. Reference was made to the questions attached to the Agenda (I-3) relating to Corporate Security practices of banning and arresting youth on City Property to which she was awaiting answers. She made reference to the City's policy with zero tolerance and expressed concern that security guards are granted the power to ban or trespass at their own discretion. Ms. Keuper-Bennett advised that she was preparing a list of specific questions relating to the database through an appeal to the Privacy Commissioner. Ms. Keuper-Bennett provided Council with a list of reports/queries that she wished addressed.

Brenda Breault, Commissioner, advised that she was of the understanding based on e-mails from Ms. Keuper-Bennett to her staff, that Ms. Keuper-Bennett had withdrawn her request and no longer wished to receive responses to her questions with the exception of question 15 and an additional question. Ms. Breault advised that she would now again ask staff to prepare a response with a copy to all of Council.

In response to a request for confirmation by Mayor Hazel McCallion, Ms. Keuper-Bennett confirmed that the meeting be held with the Mayor and the City Manager in response to her issues, could wait until January 2010 at the latest, as she wished to gather more information. She advised that she needed to wait until January at the latest as she wished to have her questions answered and some of this information required access to the database and her request under the Freedom of Information has been appealed.

Councillor Nando Iannicca asked Ms. Keuper-Bennett what Council could do communally in the meantime towards what she hoped to achieve. Ms. Keuper-Bennett reconfirmed that she wished to wait until January for the meeting with Mayor McCallion.

(c) <u>Olympic Torch Relay Celebration at the Civic Centre</u>

Bob Williams, District Manager, Recreation and Parks, along with sponsors addressed Council with respect to of the Olympic Torch Relay Celebration at the Civic Centre. They explained the torch route, plans for the ceremony starting at the annual tree lighting event. He thanked the steering committee on this event which included Councillors Dale, Carlson and Parrish. Hats, scarves and medals were distributed to members of Council and the Leadership Team.

Melisa Agius, My Mississauga Program Manager, provided further highlights of the program.

Ms. Tammi Lisson, RBC, an official sponsors addressed Council to explain their highlights of the event. She advised that RBC will continue to announce the torchbearers. The final route will be announced two weeks before the event. Also, at the event, there will be an artist who will paint a 2010 themed piece which will be left as a lasting legacy for the community. She listed the highlights of their segment of the event.

Mr. Layth Azar from Coca-Cola, another major sponsor, explained their contribution to the event. Photographers will be in attendance to take pictures.

Councillor Frank Dale advised that the Steering Committee had suggested that a local school in the City Centre closest to the event be included in the event, and hence Corpus Christie Catholic School has been asked to participate. Councillor Frank Dale requested that the principal of Corpus Christie School be presented with one of the hats to acknowledge their wholehearted participation in the event.

(d) <u>Anti-bullying</u>

Mr. James Valitchka arrived at 10:05 .a.m. and hence his deputation was heard at the end of the deputations.

James Valitchka, Author and Speaker, addressed council with respect to Antibullying. He spoke about the bullying of kids and adults every day in schools and workplaces and urged Council to pass by-laws against bullying. He provided free tickets to his Anti-bullying concert on November 5/6, 2009 and requested Members of Council to encourage students and youth to attend the concert.

Councillors Mullin, Iannicca and Adams congratulated Mr. Valitchka who is 14 years old, for how much he has achieved and how much he is doing towards a safe environment. Mayor Hazel McCallion congratulated his mother for her support and advised that she has requested the Mayors Youth Advisory Committee to take on anti-bullying as a project and work with Mr. Valitchka.

 - (a) <u>Crematorium Benisasia Funeral Home, Ward 5</u>

Glen Broll, Glen Schnarr & Associates, addressed Council with respect to the petition from residents on Justine Drive against the proposed addition of a crematorium to the Benisasia Funeral Home in Malton, Ward 5

Mr. Broll indicated that the application is in circulation for comment and has not come before the Planning Committee yet. The Crematorium will be an addition to an existing Funeral Home. An Air Quality study for the emissions will be undertaken as part of the application. He advised that the process will be lengthy and assured Council that they will undertake any required studies and go through a thorough public process, adding that a license for the crematorium will be required. Further, Mr. Broll explained that currently a crematorium was not a permitted use on these lands, the legislation is anticipated to change in January 2010 and hence the rezoning was taking place simultaneously.

Councillor Eve Adams also assured that she would have consultation with the community, however, at this time, a community meeting is premature.

WHEREAS on September 30, 2009 the Ontario Power Authority announced that TransCanada Company was selected to design, build and operate a 900 Megawatt natural gas-fired power plant, in the Town of Oakville at Royal Windsor Drive which is a location close to the western boundary of the City of Mississauga;

AND WHEREAS the Ministry of the Environment ("MOE") has completed Parts I, II and III of the Clarkson Airshed Study in which the Clarkson Airshed Study Area encompasses an area approximately 20 square kilometres around the former Town of Clarkson which includes the western area of the City of Mississauga and eastern area of the Town of Oakville;

AND WHEREAS the location of the selected 900 Megawatt natural gas-fired power plant is within the Clarkson Airshed Study Area;

AND WHEREAS the Ministry of the Environment ("MOE") has determined through the Clarkson Airshed Study, that the air quality in the Clarkson Airshed is "taxed" as it is comprised of elevated levels of air contaminants;

AND WHEREAS the proposed power plant will certainly be a large industrial emitter of air pollution into the Clarkson Airshed Study Area and as such add more air pollutants to an already "taxed" airshed;

AND WHEREAS the Trans Canada Company will be required to obtain a Certificate of Approval from the MOE under the *Environmental Protection Act* and its regulations prior to the operation of the gas fired power plant;

AND WHEREAS the Statement of Environmental Values for the MOE include the following principles:

The Ministry adopts an ecosystem approach to environmental protection and resource management. This approach views the ecosystem as composed of air, land, water and living organisms, including humans, and the interactions among them.

The Ministry considers the cumulative, additive and synergistic effects on the environment; the interdependence of air, land, water and living organisms; and the relationships among the environment, the economy and society.

The Ministry considers the effects of its decisions on current and future generations, consistent with sustainable development principles.

The Ministry uses a precautionary, science-based approach in its decision making to protect human health and the environment.

The Ministry's environmental protection strategy will place priority on preventing pollution and minimizing the creation of pollutants that can adversely affect the environment.

The Ministry endeavours to have the perpetrator of pollution pay for the cost of clean up and rehabilitation consistent with the polluter pays principle.

AND WHEREAS the MOE shall take into account its Statement of Environmental Values when it is considering an application for an approval under the *Environmental Protection Act* ("EPA") such as a certificate of approval; AND WHEREAS the Provincial Government has recently announced that it "is launching a plan to help improve air quality in the southwest Greater Toronto Area following concerns raised in the community. The measures are designed to reduce emissions as well as reduce industrial energy consumption."

AND WHEREAS the Provincial Government's plan to help improve air quality in the southwest GTA includes, among other things, the following measures:

(i) That the MOE will launch a new task force that will develop and report back by the end of June 2010 on a detailed action plan to improve air quality through the reduction of emissions from local industrial, vehicular, and residential sources in the southwest GTA. It will include air quality improvement targets, timelines, strategies and reporting requirements; and

(ii) The establishment of a Working Group on Cleaner Energy and Industrial Efficiency with cement company Holcim Canada Inc., along with MEI and OPA, to examine cleaner industrial emission.

AND WHEREAS this Council has already adopted Resolutions No. 0078-2009 and No.0192-2009, which addressed City concerns about adding any further air pollution to an already "taxed" airshed, in which Council resolved in the most recent resolution that:

(i) The City called upon MOE to take into account the principles in its own Statement of Environmental Values if it is asked to consider any approval under the EPA, such as a certificate of approval, for any proposed industrial use in the airshed area;

(ii) The City called upon the Provincial Government, the Chief Medical Officer of Health and the MOE to assure the residents that the findings in the Clarkson Airshed Study will be taken into account in the review of any approval under the EPA for an industrial user in the airshed area;

(iii) The City called upon the Provincial Government, the Chief Medical Officer of Health and the MOE to review the Certificates of Approval in the Clarkson Airshed for existing major polluters whenever expansion is considered taking into account the existing regulatory standards, the cumulative effects of their emissions and background pollutant concentrations;

(iv) The City called upon the Provincial Government and the MOE to consider applying the "polluter pay" principle by attaching to any approval a condition that the industrial user pay the costs of any increase in pollution level in the Clarkson Airshed, including any increase in health care costs attributed to the rise in pollution; and (v) The City called upon the Provincial Government and the MOE to ensure that strict monitoring and public reporting requirements be attached to any approval under the EPA such as a certificate of approval.

AND WHEREAS on June 25, 2009 the Region of Peel adopted Resolution No. 2009-765 calling upon the Minister of Energy and Infrastructure to terminate the procurement process to site an electricity generating facility in the Clarkson airshed area because of the adverse impact such a facility will have on ambient air quality in the vicinity;

AND WHEREAS on July 15, 2009 Halton Regional Council adopted a similar resolution because of the potential impacts the air contamination in the area identified by the Clarkson airshed study, can have to human health;

NOW THEREFORE BE IT RESOLVED THAT:

1. The City of Mississauga calls upon the Government of the Province of Ontario, the Chief Medical Officer of Health and the Minister of the Environment, to assure the residents of the City of Mississauga that the Provincial Task Force which will be established to develop and present a comprehensive action plan for improving air quality in the southwest GTA will state as one if its goals the improvement of the air quality in the Clarkson Airshed Study Area and that the Task Force be appropriated sufficient funds by the Provincial Government to carry out all the work that it is necessary to complete its comprehensive action plan;

2. The City of Mississauga calls upon the Government of the Province of Ontario, the Chief Medical Officer of Health and the Minister of the Environment, to assure the residents of the City of Mississauga that the City will be provided with representation on the Provincial Task Force and that the Provincial Government will ensure that the necessary environmental, health and engineering experts are retained by the Province to provide the necessary expertise required by the Task Force to carry out its mandate of developing and presenting a comprehensive action plan for improving air quality in the southwest GTA;

3. The City of Mississauga calls upon the Government of the Province of Ontario, to implement the recommendations from the Provincial Task Force necessary to improve the air quality in the Clarkson Airshed Study Area and to monitor and report to the public any change in the air quality;

4. The City of Mississauga calls upon the Government of the Province of Ontario and the Minister of the Environment, to assure the residents of the City of Mississauga that it will not consider for approval any certificates of approval for large industrial users in the Clarkson Airshed Study Area, including the proposed gas-fired plant in the Town of Oakville, until the recommendations from the Provincial Task Force to improve the air quality in the southwest GTA have been implemented and it can be verified through further airshed study that the air pollution in the Clarkson Airshed has decreased to a level where the airshed is no longer a "taxed" airshed;

5. That a copy of this Resolution be forwarded to the Premier of Ontario, Chief Medical Officer of Health, Minister of the Environment, Minister of Energy and Infrastructure, Medical Officer of Health for Peel Region, Medical Officer of Health for Halton Region, all local MPPs, Region of Peel and Region of Halton.

Councillor Pat Mullin spoke to this resolution (listed in the Agenda under Notice of Motion) and explained the need for assurance to the residents that the Provincial Task Force will state as one of its goals the improvement of air quality in the Clarkson Airshed Study area. Also, she asked the Province provide sufficient funds to carry out all the work necessary to complete the comprehensive action plan and report back by the end of June 2010.

Councillor Mullin also expressed the importance of having local representation on this Provincial task force and that the necessary environmental, health and engineering experts are retained to provide the expertise required by the task force to carry out their plan for improving air quality in the southwest GTA. Further, she urged assurance that the Province implement the recommendations of the Provincial task force and monitor and report any change in air quality in this area and further that the Ministry of the Environment not consider for approval any Certificates of Approval for large industrial users in the Clarkson Airshed Study Area which would include the proposed gas fired plant in the Town of Oakville until the recommendations of the Provincial task force have been implemented and it can be verified that pollution in the Clarkson Airshed has decreased to a level where the airshed is no longer a "taxed" airshed.

Whereas the waiting list for assisted housing in the Region of Peel is variously calculated at between 13 and 21 years,

Whereas up to 65% of those desperately needy residents are from the City of Mississauga,

Whereas December 2008 Regional Council unanimously supported a motion to invest \$67 million of provincial infrastructure money in social housing, resulting in an announcement of 250 units for Mississauga and 200 units for Brampton, *Whereas* the Region entered into discussions with United Lands (also known as Wintor Equities Inc.) for an appropriate site on the south-west corner of Creditview and Eglinton in Ward 6 which could accommodate 250 assisted housing units, *Whereas* the above parcel of land is owned (63.2%) by United Lands and (36.8%) the City,

Whereas the City portion of land is a small remnant piece of a larger parcel on Eglinton Avenue purchased from Kaneff Properties in 1991 for \$1.535 million for the construction of the CP Rail grade separation, the remnant piece having no easement or access, being frontage property of less than a half hectare (0.48 hectare),

Whereas the United Lands property does contain an easement extension from their phase one townhouse development on South Parade Court,

Whereas on December 9, 2008, a public meeting was held to amend the zoning on the United Lands property: "Existing zoning on the property RA3-28 (Apartment Dwellings – Exception) which permits apartment dwellings, long-term and retirement dwellings with a minimum of FSI of 1.0 and a maximum FSI of 1.5 on application by Wintor Equities Inc.",

Whereas at that same public meeting it was also noted "The proposed development of the site would require the conveyance of these lands [the City parcel] to the developer",

Whereas negotiations with the Region were always premised on the Region's buying the City lands and putting the two required parcels of land together, as well as the easement from the townhome owners on South Parade Court, *Whereas* the Region abruptly altered its position on September 28, 2009 placing full responsibility on United Lands to purchase the City portion and to secure the necessary agreements with the residents of South Parade Court to extend easements and other matters, putting the required start time for the project in serious jeopardy,

Whereas the project will be built with \$30 million infrastructure funding and \$25.2 million mortgage from Regional reserves,

Whereas calculations have projected the first year end balance as a net loss for the project of \$179,500, necessitating a total reduction in costs for the project of \$3.1 million,

Whereas United Lands have voluntarily reduced their land and construction cost projections by a total of \$1.9 million – provided construction begins no later than February of 2010 – assuming responsibility for 60% of the required reduction, *Whereas* transfer of the City-owned parcel of land to United Lands for the purpose of constructing a 250 unit turn-key building to be managed by Peel Housing – would reduce the total cost by \$1.2 million and bring the projected first year end balance to zero,

Whereas the City will gain development charges of \$1.75 million and parkland dedication of \$1.76 million as well as other fees,

Whereas the task of negotiating with the owners for South Parade Court can be initiated immediately if United Lands is the sole owner of the required property, *Whereas* time is of the essence for the families and seniors who so desperately need the proposed 250 units,

Therefore be it resolved that the City transfer ownership of the 0.48 hectares of street-front land required to complete the building site to United Lands subject to the requirements of the Municipal Act for the sum of \$2.00 plus legal costs for the sole purpose of constructing a 250 unit assisted housing building to be owned and managed by Peel Housing, construction to begin in early 2010.

At the request of Councillor Carolyn Parrish, the above resolution was added to the Agenda under "Approval of the Agenda" and copies were distributed to all members of Council.

Councillor Carolyn Parrish spoke to the motion. She stated that the approval of this resolution would result in 250 units of much needed assisted housing.

In response to questions, Mary Ellen Bench advised that she has reviewed the motion and since it deals with the sale of City lands, it would need to have the necessary clauses so as not to contradict the provisions of the Municipal Act, particularly relating to declaring the lands surplus and giving appropriate notice.

Councillor Maja Prentice requested further clarification with respect to the Region not wishing to purchase the lands for the purpose of assisted housing. Councillor Parrish provided Council with the background information. She pointed out that the property in question would be the City's contribution towards providing much needed assisted housing and it was a timing issue as well. Councillor Parrish agreed to provide members of Council with copies of correspondence she had on this matter to confirm that this was a Regional staff decision and that the matter did not come before Regional Council for consideration.

Councillor Prentice requested confirmation that this approval would not set a precedent and was advised by the City Manager that it would not.

Councillor Pat Mullin spoke in support of the resolution but wished some answers relating to the Region not purchasing the land. Mayor Hazel McCallion offered to speak with the Chair of the Region of Peel on this matter.

The draft motion was amended to reflect that this sale was subject to the provisions of the Municipal Act.
