## **DEPUTATION**

A. Steven Bell, Urban Designer, Planning and Building presented an overview of the Downtown 21 Master Plan.

Mr. Bell indicated that the Downtown 21 Master Plan provides an overarching vision for the City of Mississauga downtown core. The plan focuses on pedestrian accessibility, and emphasizes walking, cycling and public transportation in the downtown core.

Diana Simpson, Accessibility Coordinator provided comments earlier in the year with regard to incorporating accessibility into the plan. Ms. Simpson advised of the need for rest areas and audible signals at crosswalks in the downtown core.

Mr. Bell indicated that there is an implementation strategy for the Downtown 21 Masterplan that will see the Mainstreet district addressed first, and the rest of the downtown core in layers. Mr. Bell assured that the Facility Accessibility Design Subcommittee of AAC would have a voice during implementation.
