Ms. Jones presented information on several programs offered by the Region of Peel to persons with disabilities. Discussion ensued regarding the Passenger Assistance Program, the Community Bus Program, the Public Transit Access Initiatives Program, and the Taxi Scrip Program.

A video was viewed on Accessible Transportation in the Region of Peel. Nigel Roberts indicated that the video could be uploaded onto the City of Mississauga website or a link to the youtube video could be placed on the site.

Rabia Khedr related an incident involving her sister that occurred on Mississauga Transit, for which a complaint has since been filed.
