#### PRESENTATION

A. Pina Mancuso, Project Manager, Elections, presented information with regard to Accessible Elections in the City of Mississauga; and Election Systems & Software provided elections equipment for testing by members of the Accessibility Advisory Committee.

Ms. Mancuso reported that the City of Mississauga is ahead of the requirements of the province's Accessibility Standards and that accessible election units have been available in Mississauga before it was required under the provincial legislation. Ms. Mancuso advised that all elections workers are required to pass an accessibility test.

Elections Systems & Software demonstrated the use of the accessible elections units to be utilized in the Mississauga election. Ms. Mancuso reported that 22 accessible elections units will be available city-wide at the advanced polls. Ms. Mancuso advised that these units have been used extensively in the United States, and will be used by the City of Toronto and other 905- municipalities in the upcoming election.

Glenn Barnes, Citizen Member asked whether there was an opportunity for online voting in Mississauga. Ms. Mancuso indicated that there could be an opportunity for online voting in the future, but that further research must be completed and the electors and politicians must be comfortable with online voting before it is implemented.

Naz Husain, Citizen Member asked whether there would be advertising of the accessible voting units. Ms. Mancuso indicated that there would be some messaging from the Elections team and that the unit locations would be listed on the Mississauga Votes webpage, but that they are also looking to politicians and city staff to advertise the units.

Kristine Beavis, Citizen Member recommended that Ms. Mancuso approach Rogers Cable, the Weather Network, and City TV to advertise the accessible voting units in the City of Mississauga.

## NEW BUSINESS

## ACCESSIBILITY FOR ONTARIANS WITH DISABILITIES ACT, 2005 (AODA) – ACCESSIBILITY STANDARDS

2. <u>Accessible Transportation Standard/Accessible Employment Standard/</u> <u>Accessible Information and Communications Standard</u>

Diana Simpson, Accessibility Coordinator provided a verbal update on the Proposed Integrated Accessibility Regulation under the Accessibility for Ontarians with Disabilities Act, 2005.

Ms. Simpson indicated that the province listened to municipalities when it integrated all the remaining accessibility standards. Ms. Simpson reported that the regulation is brief and does not include any detailed requirements. Ms. Simpson advised that the province is trying to obtain informal public feedback by October 16, 2010.

Ms. Simpson advised that the various Standards Development Committees members representing the Association of Municipalities of Ontario (AMO) will meet at the AMO office to provide feedback on the integrated regulation on September 15, 2010, and that she would be in attendance at the meeting as a representative of AMO on the Accessible Built Environment Standards Development Committee.

Glenn Barnes outlined many issues with changes made to the Integrated Standard. Ms. Simpson indicated that she would forward Mr. Barnes' comments

at the meeting with AMO, but recommended that Mr. Barnes also provide feedback on the integrated regulation as a private citizen.

## 3. Ontario Regulation 429/07 - Accessible Customer Service Standard

No update at this time.

## 4. Accessible Built Environment Standard

Diana Simpson, Accessibility Coordinator provided a verbal update on the Accessible Built Environment Standards Development Committee Meeting #11 – May 25<sup>th</sup> and 26<sup>th</sup>, 2010. The final Proposed Accessible Built Environment Standard (July 2010) was posted on the Ministry's website.

## 5. <u>Facility Accessibility Design Subcommittee Report from the meeting of June 21,</u> 2010

Ray Lau, Roadway Programmer advised that with regard to the Sheridan College Park Roadway, the City is not at the detail design stage yet, but will present the detail design to FADS, once complete.

## 6. Region of Peel Accessibility Advisory Committee

Naz Husain, Citizen Member and Glenn Barnes, Citizen Member provided a verbal update on an Affordable Housing project located at Eglinton Avenue and Creditview Road. Ms. Husain reported that the Peel AAC was able to increase the number of accessible units in the 250-apartment building from one accessible unit and a few barrier-free apartments to 14 fully accessible apartments and 13 barrier-free apartments.
