#### 2. <u>Site Inspection Reports- Plum Tree Park Public School (Ward 9)</u>

These items were referred back to Traffic Safety Council at the General Committee meeting which took place on July 7, 2010, by the Ward Councillor, who has requested more detailed information relating to the safety of the school walking route.

Site Inspection Reports for the inspections conducted on May 12, 2010 to review pedestrian safety and the warrants for a crossing guard at the intersections of Tenth Line West and Battleford Road and Tenth Line West and Aquitaine Avenue.

#### **RECOMMENDATION:**

That in light of changes initiated by Student Transportation in calculating the walking routes for students attending Plum Tree Park Public School, and the Traffic Safety Council being advised that the students in Grades 4 and under are now eligible for bussing, that the request for a crossing guard at the intersection of Tenth Line West and Battleford Road for the students attending Plum Tree Park Public School, 6855 Tenth Line West be denied as the warrants have not been met.

#### 3. <u>Site Inspection Report- Plum Tree Park Public School (Ward 9)</u>

Site Inspection Report for the inspection conducted on July 10, 2010 to review the school walking route through Eden Woods Park to Miller's Grove for the students attending Plum Tree Park Public School.

#### RECOMMENDATION:

- 1. That the Traffic Safety Council Site Inspection Subcommittee, having conducted a walk of the route from the Plum Tree Park Public School, 6855 Tenth Line West, south along Tenth Line West to Battleford Road, then east along Battleford Road to Millgrove Trail Park, then north along the park path through Eden Woods Park to Aquitaine Avenue, then across Aquitaine Avenue continuing northerly along the park path to Plum Tree Park Crescent at the rear of Plum Tree Park Public School, has determined that no pedestrian safety concerns exist with the condition of the park pathway and the walking route.
- 2. That the Principal of Plum Tree Park Public School be requested to advise students living south of Battleford Road who are not eligible for bussing, of the following alternative walking routes to Plum Tree Park Public School:
  - a. Walk westerly along Battleford Road to Tenth Line West and cross to the westerly side of Tenth Line West at the traffic control signal, then walk north along the sidewalk on the west side of Tenth Line West to Aquitaine Avenue, the cross to the east side of Tenth Line West at the traffic control signal and continue walking north along the sidewalk to the school, or
  - b. Walking easterly along Battleford Road to Edenwood Drive, then walk north along Edenwood Drive to Aquitaine Avenue, then walking westerly along Aquitaine Avenue to Millgrove Trail Park and then north to the rear of the Plum Tree Park School property or alternatively continue west along Aquitaine Avenue to Tenth Line West and then north on Tenth Line West to the front of the school property.

#### **RECOMMENDATION:**

The Site Plan Review Subcommittee has reviewed the memorandum and circulation from Planning and Building regarding the DARC Agenda Item for September 1, 2010 in regards to 1194 Matheson Boulevard East and recommend the following:

That the Commissioner of Planning and Building be advised that with respect to the Official Plan Amendment and Rezoning to permit a student and staff residence in association with an existing mosque at 1194 Matheson Boulevard East, that Traffic Safety Council requires additional information be provided as to the nature of the proposed school, the ages of the students and the proposed hours of operation. Specifically, is the school a religious school or an elementary school teaching the Provincial curriculum.

Further, should the proposed school teach the Provincial curriculum in an elementary context, then the Traffic Safety Council recommends that the site plan be revised to provide a Kiss and Ride drop-off configuration and that a school bus drop-off and pick-up area be designated on-site.

#### **RECOMMENDATION:**

- 1. That "Entrance" signage with "Do Not Enter" signage on the reverse side be installed at the designated entry locations.
- 2. That "Do Not Enter" signage be installed at the designated exit location.
- 3. That pavement markings be drawn to demarcate the bus drop-off area reading "BUS LANE ONLY", as per attached diagram.
- 4. That pavement markings be drawn to demarcate the Kiss and Ride lane reading "KISS AND RIDE LANE", as per attached diagram.
- 5. That pavement markings be drawn to demarcate the drive thru lane reading "THRU LANE", as per attached diagram.
- 6. That a staggered stop bar be installed in the bus lane, 3 metres before the Kiss and Ride stop bar.

- 1. That a meeting take place between the Traffic Safety Council Site Plan Review Subcommittee, the project architect, and a Peel District School Board representative to address the issues relating to the proposed drop-off locations relative to the school entrances.
- 2. That zebra striping be drawn at the roundabout location for crossing pedestrians, as per attached diagram.
- 3. That a railing/fence be installed beginning at the roundabout location to prevent drop-off along the edge of the sidewalk next to the driveway, as per attached diagram.
- 4. That pavement markings be drawn to demarcate the Kiss and Ride lane reading "KISS AND RIDE LANE", as per attached diagram.

- 5. That pavement markings be drawn to demarcate the drive thru lane reading "THRU LANE", at the five locations shown on the attached diagram.
- 6. That directional arrows be drawn to facilitate the flow of traffic through the parking lot, as per attached diagram.
- 7. That a stop sign and a stop bar be installed at the pedestrian walkway from the parking lot to the main entrance, as per the attached diagram.
- 8. That pavement markings be drawn to demarcate the bus drop-off area reading "BUS LANE ONLY", as per attached diagram.
- 9. That pavement markings be drawn to demarcate the student pick-up location, as per attached diagram.

#### 9. Mississauga Road Pedestrian Underpass (Ward 2)

#### **RECOMMENDATION:**

That the Commissioner of Transportation and Works be advised that with respect to the Mississauga Road Pedestrian Underpass that Traffic Safety Council has reviewed the site plan and would recommend the following;

- 1. That a railing/fence be installed on the road side of the sidewalk on the south side of the pedestrian underpass to ensure that all pedestrians are 'funneled' into the pedestrian underpass.
- 2. That the Transportation and Works Department consider moving the painted vehicular stop bar and the painted pedestrian crossing markings on Kane Road closer to the intersection to provide better sight lines for vehicles without conflicting with crossing pedestrian traffic.
- 3. That zebra striping be used for the pedestrian crossing across Kane Road.
- 4. That signage be installed directing pedestrians walking southbound on Mississauga Road at Kane Road to the pedestrian underpass.
- 5. That the sidewalk on the south side of Kane Road in the area of the intersection be modified to align with the pedestrian crossing across Kane Road and that a railing/fence be installed at the end of the sidewalk to prevent pedestrian traffic from continuing on the sidewalk towards Mississauga Road.
- 6. That the pedestrian walkway on the south side of the railway tracks be modified to create a smoother transition to the existing sidewalk on the west side of Mississauga Road.
- 7. That the Transportation and Works Department provide the Traffic Safety Council a repair schedule for the sidewalk on Mississauga Road in the vicinity of the underpass.
