

11. Walk to School Subcommittee- School Criteria for Participation in the School Walking Routes Program

On April 14th, 2010, the Walk to School Subcommittee reviewed the issue of School Participation Criteria for the School Walking Routes Program.

Discussion ensued regarding the goals and value of the School Walking Routes program. David Brown, Chairman, Traffic Safety Council advised that the Walk to School Subcommittee's work with school staff has produced demonstrable results. For example, Kiss & Ride usage and traffic congestion was down at the School Walking Routes Launch at Edenrose Public School. The institutionalization of the Kiss & Ride has inadvertently led to an increase in driving. The goal of the Walk to School Subcommittee is promote walking once again, which is in line with the mandate of Traffic Safety Council.

David Raakman commended the great work of the subcommittee.

RECOMMENDATION:

Where the Traffic Safety Council reviews or considers an elementary school (Grade levels Kindergarten to Grade 5 or 8) for participation in the School Walking Routes Program, the Traffic Safety Council will consider the following areas:

- 1. A minimum of 500 students attending the school
- 2. Very few students travelling by student transportation
- 3. A majority of students living within walking distance to the school
- 4. An ideal walking area, which includes, but is not limited to:
 - a. a sidewalk on at least one side of the street for every street in the school's catchment area
 - b. sidewalks that are unobstructed and in good repair in the school's catchment area
 - c. good pedestrian controls in place
 - d. no arterial roads that need to be crossed to reach the school
 - e. no major issues with traffic volumes, speeds and collisions
 - f. where a school is adjacent to a park, park paths are continuous and provide access to school property

- 5. A supportive Principal, School Trustee and/or Councillor
- 6. An active Parent Council interested in participating in the program
- 7. A Kiss & Ride and Dismissal Program in place
- 8. Crossing guards and/or student patrol program in place, if warranted.
- 9. Evidence of traffic congestion around the school.
- 10. A commitment from the school's administration to undertake follow-up surveys once the School Walking Routes Program has been implemented

John Fraser Secondary School

Andy Bate, Supervisor, Traffic Operations advised that he attended a meeting on April 28th, with Councillor Pat Saito at John Fraser Secondary School to address the issue of students crossing Erin Centre Boulevard. Mr. Bate advised that there is no way to control the way that students are crossing. There is a pedestrian island built to help students cross. However, officers have been issuing pedestrian offence warnings to students who are impeding traffic and failing to cross properly at the pedestrian centre in front of John Fraser Secondary School. Traffic Safety Council is limited in their ability to address this issue. The location is signed correctly. Students are required to wait for a gap in traffic before they attempt to cross at the pedestrian centre. However, if they do not do so there is not much that Traffic Safety Council can do.

Mr. Bate advised that a site inspection at this location is not presently required. He will contact the school's Principal and the Peel Regional Police to attempt to resolve the situation. Mr. Bate recommended that the scheduled site inspection be delayed until the following month, when he can report back to the Traffic Safety Council.
