

A. Bike lanes in residential areas - Camilla Road, North Service Road to Dundas

Mr. Roger Coote, representing the Cooksville Munden park Homeowners Organization (CMPHO) and its residents, addressed the Committee with respect to the new addition of north and south bike lanes on Camilla road between North Service Road and Dundas Street East. Mr. Coote requested that the new bike lane painting be placed on hold for the winter till there is further dialogue to resolve the concerns from the local residents.

Jacquelyn Hayward Gulati, Manager Cycling Office updated the Committee on a pilot project for new bike racks in the Port Credit Cultural Node as contained in her Memorandum dated October 11, 2011 (Agenda Item 7).

Members commented on the durability of the bike racks material.

Sidewalk eyelists face crackdown – Article from the Toronto Star of September 1,
 2011, referred by Councillor Pat Saito.

Councillor Chris Fonseca advised that this matter was discussed at General Committee. Concerns have been raised by seniors with regard to educating cyclists on the sharing of pathways with other users.

Dorothy Tomiuk commented on the need for a change in terminology of the Highway Traffic Act to reflect the appropriateness of having bells on bicycles.

Jacquelyn Hayward Gulati advised that the Cycling Office is in the process of preparing educational material during the winter months which will be released in 2012 spring.

Discussions ensued focussing on:

- the use of sidewalks for pedestrians rather than for moving vehicles;
- speed limits for cyclists in Mississauga;
- need for increasing signage, specifically "Cyclists give way to pedestrians".

3. Budget Update

John Britto, Legislative Coordinator updated the Committee on the status of the Cycling Advisory Committee Budget for 2011. The Committee was in agreement that cycling jerseys should be sold through the City's website. The Committee also agreed to allocate funds for promotional material and display improvements.

SUBJECT:

2011 Cycling Network Program: Year-End Report

The City of Mississauga Cycling Master Plan outlines a strategy to build an integrated on-road and off-road cycling network as part of a multi-modal transportation system, as well as a wide range of accompanying programs and policies to enhance cycling.

The 2011 Cycling Network Program included the development of bicycle lanes, sharrows and multi-use trails in several locations. The project locations were aligned with the criteria contained within the Cycling Master Plan. For each location, consultation with the respective Ward Councillor and area residents was completed, where required.

This report provides a year-end summary of the status of 2011 cycling network projects. This work represents projects completed by the City's Transportation and Works Department and Community Services Department, as well as projects completed by the Region of Peel and the Toronto Region Conservation Authority where indicated.

Please note that the above locations do not include proposed development of off-road multi-use trails (in parks and open spaces) managed by the Community Services Department.

It is anticipated that upon completion of the work indicated above, an additional **43 kilometres** of cycling facilities and improvements to 1.5 kilometres are proposed to be introduced to enhance the cycling experience in Mississauga. Updates regarding the status of projects within the Proposed 2012 Cycling Network program will be provided to the Mississauga Cycling Advisory Committee on a quarterly basis.

CYCLING WAYFINDING SIGNAGE PROGRAM

Cycling wayfinding signage will continue to be introduced during the implementation of the 2012 Cycling Network Program, with priority on routes that are at least 3 km in continuous length.

In addition to the proposed routes above, the cycling wayfinding signage will continue to be introduced on existing routes. It is the staff recommendation that the following routes take priority for new wayfinding signage in 2012:

- Burnhamthorpe Trail (east section)
- Britannia Trail
- Confederation Parkway
- Culham Trail
- Etobicoke Creek Trail
- Waterfront Trail

The **Phil Green Recognition Award** is presented annually by the City of Mississauga Council to a person or group of people who have demonstrated exemplary effort to the cause of promoting or furthering cycling or other forms of sustainable transportation in the City of Mississauga over the preceding year.

Eligibility

Any resident(s) of Mississauga of any age can be considered eligible for the **Phil Green Recognition Award**, provided that:

- 1. They or any member of their immediate family are not a current member of, or have not been a member of, the Mississauga Cycling Advisory Committee for at least the past two years
- 2. They or any member of their immediate family are not employed by the City of Mississauga or the Region of Peel in any capacity related to cycling or sustainable transportation.

A difficulty is that many manufacturers repeat serial numbers, making these numbers hard to use as a means of identification. A license might work better. The difficulty, of course, is that license plates, stickers, or other means of identification can be stripped from the bike, making a license hard to use as a reliable means of identification. BACK TO TOP Compliance with the law The need to identify a cyclist who has broken a traffic law or been involved in a collision has been identified as a key concern by many. The various studies that have looked at licensing for cyclists have determined that there are many problems with issuing licenses to cyclists. Police believe they have adequate tools to address cyclists who break traffic laws. The most important was the 1989 addition of Section 218 to the Highway Traffic Act (PDF). BACK TO TOP Section 218 of the Highway Traffic Act (HTA) A police officer who finds any person contravening any provision under this Act [HTA] or any municipal by-law regulating traffic while in charge of a bicycle may require that that person stop and to provide identification of himself or herself. 2. Every person who is required to stop, by a police officer acting under Subsection (1), shall stop and identify himself or herself to the police officer. For the purposes of this Section, giving one's correct name and address is sufficient identification.

4. A police officer may arrest without warrant any person who

does not comply with Subsection (2).

Cost

The cost of obtaining a license to drive a motor vehicle is considerable. Much of that cost covers the administrative costs of maintaining an accurate database, and processing licenses. The costs of developing a system for cyclists would be similar. When asked to consider such a move in the past, the Ministry of Transportation has rejected it. If cyclists were asked to cover the cost of licensing, in many cases, the license would be more expensive than the bicycle itself.

BACK TO TOP

Many children cycle, in fact most cyclists are young people. It would be difficult to create one standardized test that could be used by adults as well as children as young as five years old. There is an argument to be made that licensing would allow an opportunity for education, but again the bureaucracy of such a mandatory system has been seen as too cumbersome to develop.

BACK TO 10P

Jurisdiction

Those who have looked into licensing cycling have determined that the only natural jurisdiction to license is the province, which has rejected licensing. Historically, municipalities have licensed bicycles in Ontario. Today, many cyclists cross municipal boundaries.

BACK TO TOP

Enforcement

The discussions about cyclists and the law have raised the question about how we want our police to spend their time and limited resources. Do we want them checking up on and enforcing licenses, or do we want them enforcing traffic laws? Most people would argue that enforcing traffic laws is more worthwhile. Police who have been involved in the studies of licensing have determined that the HTA already gives them the necessary tools, such as Section 218, to do the enforcement job.

BACK TO TOP

Effectiveness

In each of the above cases, major problems and difficulties arise in establishing a licensing system. The studies asked what is the goal that licensing cyclists is attempting to achieve? If the goal is to increase cyclists' compliance with traffic laws, and to reduce the number of conflicts with pedestrians and other road users, then licensing as an approach needs to be compared with other possible





initiatives. Is the creation of the major bureaucracy that licensing would require worth it? The studies have concluded that licensing is not worth it. Other solutions: blitz enforcement of rules on riding on sidewalks, public awareness campaigns, skills training through CAN-BIKE, and the provision of bicycle-friendly facilities, such as bike lanes, while not perfect, are more effective in meeting the goals of cyclist compliance with traffic laws than the investment in licensing.

BACK TO TOP

Public policy considerations

Concerns over cyclist compliance with traffic laws are real, and require ongoing attention. If, however, major investments are to be made by governments or by cyclists themselves, then the overall public policy goals behind that investment need to be addressed. For example, there is a strong public policy case to be made for licensing motor vehicle drivers. Hundreds of lives are lost each year because of motor vehicle crashes and collisions, and many thousands more are injured. Cyclists are involved in a smaller number of incidents, which must be addressed. However, given the benefits of cycling to health, the environment, and the community, on-going efforts to increase cycling compliance with traffic laws must be a part of an overall strategy to promote safe cycling.

Cyclists had to apply for a license through City Hall. Then the cyclist was required to go to Licensina a police station and have a police officer inspect the bicycle and fill Purpose out paperwork. That paper work was returned to City Hall and a license was granted. The cyclists then had to return a duplicate SSUES -listory license to the same Police Inspector where the bicycle was examined. Then a metal plate was issued for the year and affixed to the mudguard of the bike. Any time the cyclist moved or transferred or exchanged his bike, the new information had to be filed. The cost of the yearly license was 50 cents and the fine for not having a license on your bicycle was \$5.00. On February 4, 1957, City Council repealed the bicycle licensing bylaw in the City. At that time, there was a communication from the Canada Cycle and Motor Company Limited suggesting the City use the services of the Bicycle Guild Incorporated to administer bicycle licensing. At that time, the City opted out of bicycle licensing, stating amongst other issues that "licensing of bicycles be discontinued because it often results in an unconscious contravention of the law at a very tender age; they also emphasize the resulting poor public relations between police officers and children". Nathan Phillips was the Mayor at the time and it is his signature on the by-law amendment. The City of Toronto has investigated licensing cyclists on at least three occasions in the recent past: . 1984: focus on bike theft 1992: focus on riding on sidewalks, traffic law compliance and 1996: focus on riding on sidewalks, traffic law compliance and Licensing in the nineties has been most often discussed in response to concerns for pedestrian safety on sidewalks, where incidents of collisions, near misses, and a lack of courtesy have made many pedestrians, including seniors feel insecure. Each time the City has rejected licensing as a solution to the problem under discussion. The major reasons why licensing has been rejected are: The difficulty in keeping a database complete and current The difficulty in licensing children, given that they ride bikes Licensing in and of itself does not change the behaviour of cyclists who are disobeying traffic laws. 

3. Obstructive New Info Pillars - Have Your Say!

Fully grown and festively lit trees aren't the only things sprouting up around the city lately. Dozens of new infoTOgo pillars are being installed, impeding pedestrian flow, blocking sightlines, and causing concern from people who rely on city sidewalks as a mode of transportation.

Beyond violating established <u>Vibrant Streets Guidelines</u>, the hindrance to movement of the pillars is amplified for those using mobility devices such as wheelchairs and by winter conditions. For images of some of the issues and impacts (taken by previous TCAT Steering Committee

member Gord Brown) see here.

On January 4th, the motion will return to the Public Works and Infrastructure (PWIC) committee with Adam Vaughan and Janet Davis requesting additional controls on the information pillars, including mitigating the destruction of historic and local paving treatments. More meeting information is here, along with the Notice of Motion. The PWIC meeting agenda is not currently up to date but is available here.

4. Urban Traffic Calming + Health: A Literature Review

National Collaborating Centre for Healthy Public Policy published a <u>literature review</u> exploring the impacts of traffic calming in urban areas. Featuring an original approach, the document compares individual measures with systematic area wide interventions and their impacts on-road collisions, air quality, noises, and the physical activity associated with active transportation.

The appendix also features a nice illustrated glossary of traffic-calming measures
