A. <u>Mississauga Transit Operators Announcing All Stops</u>

Mickey Frost, Manager, Transit Operations, introduced the video that has been utilized to train the Mississauga Transit Operators about announcing all stops. The video began with an introductory message from Rabia Khedr, Chair, on behalf of the Accessibility Advisory Committee, then proceeded with an overview of the legislative background pertaining to the AODA. The video continued at length with operational instructions for Mississauga Transit drivers on announcing forthcoming bus stops.

In response to a question about the whether low compliance of this policy has resulted in any disciplinary action, Mr. Frost responded that disciplinary action does not take place until a third incident of low compliance occurs through the audit process. Due to the number of transit drivers, the likelihood of a third incident will possibly occur during the next audit.

Mr. Frost also described the intricacies involved in the implementation of this program taking into account Ministry of Labour and union requirements in meeting the expectations of the Ontario Human Rights Commission.

Jim Hardman noted that he hopes that after completion of this temporary program, the "next stop" signs are left in place as a visual cue for people with hearing loss. Mr. Frost said that a decision has not been made about the signs, but the automated system will have both audio and visual components to announce upcoming stops.

Committee members concluded by emphasizing that they are still committed to working with Mississauga Transit to achieve an attitudinal shift. A suggestion was made to remind patrons to thank drivers for calling out stops.

Antonietta DiSalvo spoke to the corporate accessibility training program entitled "May I Help You?" Staff consulted with Diana Simpson as well as the AAC's Corporate Policies and Procedures Subcommittee regarding the program. Staff hope to launch the e-learning in late June or early July. Those staff members who do not have access to a computer will have face-to-face training arranged for them.

- 9. Other Business
 - 9.1 Portable washroom facilities in City parks

Rabia Khedr expressed concern about the lack of accessible washrooms at some outdoor recreational facilities. She also mentioned a concern about hygiene issues. Lori-anne Bonham explained that washroom facilities are provided in City parks as: 1) permanent facilities built in highlevel community destinations (locations determined through Washroom Study and formal assessment process); 2) portable units provided in conjunction with sports organizations; and 3) event groups making arrangements for specific special events. Ms. Bonham indicated that washrooms are visited daily to ensure sufficient supplies and are cleaned several times per week. Any concerns about washroom cleanliness should be reported to the city's Customer Service Line.

Rabia indicated that she would speak to the Sports Association about ensuring accessible units.

9.2 The Hurontario Street Main Street study

Diana Simpson reminded committee members about the Hurontario Street Main Street Study taking place on June 10, 2009 with an update on bus and rapid transit routes.

9.3 The upcoming Wheels in Motion event

Glenn Barnes reminded committee members about the upcoming Rick Hansen Wheels in Motion event taking place at the Lakefront Promenade Park on June 14, 2009. The website for the event is: www.wheelsinmotion.org.

9.4 <u>Secondary Dwellings in Homes</u>

Al Cormier mentioned that secondary dwellings will be allowed in detached homes as required by the Provincial Growth Plan. He indicated that the disability community may look for more affordable housing and more intensity and ultimately more transit through this initiative. The AAC may be interested in receiving more information on this topic. Finola Pearson noted that there will be public consultation on this issue in the fall. Lawrence Franklin indicated that he would investigate arranging a presentation on the topic.
