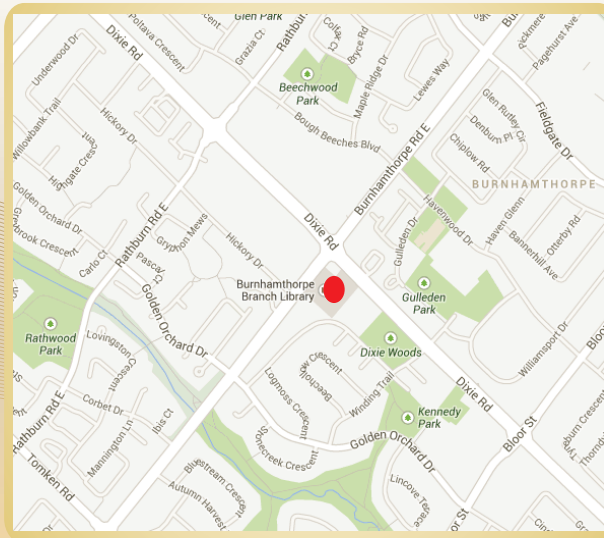

## What Is Conflict Resolution?

**Conflict Resolution** is a free and confidential service that helps residents resolve conflicts, disagreements, and concerns/problems through mediation.

**Community Mediation** is a collaborative and structured process of problem solving, in which neutral mediators help two or more parties discuss their differences and reach a mutually acceptable solution.

### **MEDIATION HELPS YOU:**

- Explain your perspective
- Understand each other's point of view
- Come to a resolution quickly

### **MEDIATION WILL NOT:**

- Give you legal advice
- Determine who is right or wrong
- Provide therapy or counselling

## Mediation Is Simple

### **HERE IS HOW OUR SERVICE WORKS:**

**Call us** at (905) 629-1873 ext.311. We will listen to your concerns and explain the process.

**You make the decision.** If you decide to proceed, we will contact the other party to see if they will participate.

**Meet the mediators.** You will have an individual intake meeting with the mediators to discuss your concerns.

**The mediation:** The mediators will meet with all parties to help them discuss concerns and find a mutually acceptable solution.

## Why Use Mediation?

### **IT WORKS**

Three out of four mediations reach an agreement.

### **IT IS PRIVATE AND CONFIDENTIAL**

The mediators will hold all proceedings in strict confidence.

### **IT IS QUICK AND FLEXIBLE**

Mediation happens at a time and place that is convenient for everyone involved.

### **IT IS INFORMAL**

The process is comfortable and suited to your needs.

### **YOU ARE IN CONTROL**

There is no agreement until you are satisfied.
