## A Update – Bus Rapid Transit (BRT) Project

Scott Anderson, BRT Sr. Project Manager, Scott Bowers of McCormick Rankin Corporation and Lisa Dabbondanza of Stevens Group Architects Inc. gave a PowerPoint presentation to provide an update on the development of the bus rapid transit project in Mississauga.

Discussion was held regarding the indoor air quality projections for the proposed stations, as well as heating and air conditioning needs and timed lighting for the interior. The use of solar or wind powered energy for the transit shelter and station lighting and advertising panels for environmental products was suggested, along with other suggestions for other 'green' construction applications.

The provision of storage for bicycles and motorcycles at transit facilities in future was suggested. Mr. Anderson advised that connection to pedestrian and cycling pathways is proposed, with note of the bicycle storage facilities being implemented on Eglinton Avenue.

# 2. Tour of Region of Peel Recycling Plant

Edward Nicolucci, Acting Manager of Environmental Management gave a verbal report regarding the planning of the suggested tour of the Region of Peel recycling plants for the Members of the Environmental Advisory Committee. Mr. Nicolucci explained that two locations are options for the tour, namely the Peel Integrated Waste Management Facility (PIWMF) and/or the Community Recycling Centre (CRC). Region of Peel Education Specialist Damian Mac Seáin from Peel's Environment, Transportation and Planning Services, advised that there is an education room at the PIWMF facility and that Peel waste management staff will guide subject tour.

Subsequently, Dr. Brad Bass moved that staff be directed to plan the proposed tour for the meeting of this committee scheduled for January 12, 2010, and arrange for group transit to the recycling facility(s).
