### **DEPUTATIONS**

### A Item 2.1 <u>Living Green Master Plan – Update</u>

Jeff Evenson, Principal of the Canadian Urban Institute gave a PowerPoint presentation about the approach being taken to develop the City of Mississauga Living Green Master Plan. The organizational structure and framework for the strategic partnerships both internally and externally were reviewed as well as the communication tactics proposed. The involvement of this Committee was reviewed, and the messages received from the stakeholders that attended the October 22<sup>nd</sup> work shop were presented.

Citizen Member Peter Orphanos opined that intensified development should relate to development charges by the developer to offset the cost of energy uptake and equitable provision of green space for the residents of intensified development, and subsequently put the following motion for committee's recommendation:

1. Whereas Natural Heritage was identified at the work shop regarding the proposed Living Green Master Plan on October 22, 2010, as a 'number one' priority;

And whereas over 100,000 citizens of Mississauga participated in the public consultation.

And whereas over 100,000 citizens of Mississauga participated in the public consultation and expressed that Natural Heritage is their 'number one' priority for the City's strategic plan "Our Future Mississauga" which was adopted by Council in April 2009;

And whereas the Living Green Master Plan will recommend reasonable strategies to achieve the goals that reflect the public will;

And whereas Members of the Environmental Advisory Committee feel that the percentage of natural areas to land mass in Mississauga needs a serious increase from its current status of seven percent, which is the lowest in the Greater Toronto Area;

#### DEPUTATION A cont'd...

- (1.) Be it resolved that the goals and strategies of the upcoming Living Green Master Plan be supported with full funding and the human resources required to implement the Natural Heritage component of that Plan.
- 2. That staff update the Environmental Advisory Committee on the status of the implementation of the Natural Heritage directions set out in the upcoming Living Green Master Plan.

Mike DeWit initiated discussion about municipal tax levy classes being created to fund the acquisition and retention of natural areas. Councillor Carlson explained that the province legislates how municipalities may levy taxes and that changes would have to be sought to allow local taxation to fund payback for the impacts of intensified development, LEED standards being applied, etc.

Dr. Bass of the University of Toronto in Mississauga and Citizen Members Mike DeWit and Peter Orphanos offered to meet with consultant Jeff Evenson to discuss the proposed Living Green Master Plan in regard to 'decision making' tools and application of that Plan around the directives and policies in other Plans.

The motion carried. Recommendation EAC-0018-2010

### B Smoke-Free Outdoor Spaces Policy Options

Paul Callanan, Director of Environmental Health and Andrea Chiefari, Manager of Environmental Health with the Region of Peel gave a PowerPoint presentation regarding the Region's Policy Options for Smoke-Free Outdoor Spaces.

The complexities of educating the public which comprises people with variable cultural backgrounds and attitudes about tobacco use and finding ways to encourage cessation of smoking were discussed. It was noted that the literature available to date does not address the issue of exposure to second-hand smoke being experienced where smoking is permitted outside buildings. Citizen Member Hassaan Basit referenced his work with Conservation Halton and spoke to the issues of enforcing restrictions of outdoor smoking in open areas at conservation areas.

The issues of media being issued by the tobacco industry, and whether the covering of cigarette products in store displays have reduced smoking, were discussed. Mr. Callanan advised that subtle advertising campaigns are still being issued by the industry. Ms. Chiefari advised that statistics indicate that the coverage of tobacco products has not resulted in a reduction of smoking activity. Further discussion addressed the need to encourage smokers to properly dispose of their butts was discussed in regard to reduction of litter.

### <u>DEPUTATION B</u> cont'd...

In response to the question by Councillor Carolyn Parrish on whether tenants of Regional subsidized housing program are required to sign an agreement that they will not smoke inside those dwelling units, Mr. Callanan advised that the Region of Waterloo has implemented this type of agreement. Discussion was held regarding the ability to enforce that restriction.

Mr. Callanan referenced the information item attached to this agenda which addresses the program being considered by the City of North Bay to allow the owners of multi-unit residential buildings to voluntarily designate their buildings as smoke-free.

Citizen Member Mike DeWit noted that some shopping malls are posting signage that indicates their parking lots are 'smoke free'.

Discussion was held about filtration of roadway run-off being possible. Dr. Bass advised that he has students currently working on a model that would filter road / bridge drainage, and offered that once it's completed, this project might be presented to a future meeting of EAC.

Councillor Parrish suggested that the Province be approached to change codes to require filtration of road run off as well as provide funding retrofits and installations as means of precluding river pollution.
