### MATTERS TO BE CONSIDERED:

1. Request for an Election Campaign Finances Compliance Audit of Bonnie Crombie's Election Campaign Finances

The Committee reviewed and addressed the request for an election campaign finances compliance audit, dated January 19, 2012, of the election campaign finances of Bonnie Crombie (the Respondent), Candidate, Ward 5, submitted by Mark Cashin and Cecil Young (the Applicants).

The Applicants made submissions outlining their reasons for filing the application requesting that the Committee grant an election campaign finances compliance audit of the Respondent's election campaign finances.

The Committee considered the submissions and asked questions of the Applicants.

Legal Counsel for the Respondent outlined submissions for the Respondent in response to the request for an election campaign finances compliance audit of the Respondent's election campaign finances.

The Committee considered the submissions and asked questions of the Respondent.

#### **Procedural Motions:**

- <u>7:05 p.m.</u> Legal Counsel for the Respondent raised concerns with respect procedure and objected to the filing of the Compliance Audit application and asked that the matter be dismissed. Discussion ensued with respect to the eligibility of the application. The Chair noted that the current application brought to the Committee for their review would be considered as a fresh application and noted that the Committee would proceed with the review of the application. Legal Counsel for the Respondent requested time to review the submissions of the Applicants, and requested that one of the Applicants speak to the matter. The Committee made the decision to adjourn for one half hour to allow for time to review submissions.
- <u>7:20 p.m.</u> The Committee adjourned for a one half hour recess to give Legal Counsel for the Respondent the opportunity to review the Submissions Binder submitted by the Applicants to the Committee.
- <u>7:50 p.m.</u> The Committee reconvened the meeting. The Committee requested that the Applicants appoint one spokesperson to speak to the matter.
- <u>7:52 p.m.</u> Legal Counsel for the Respondent noted an objection to procedure and an objection to the compliance audit request. The Chair noted that the objections had been recorded.
- <u>7:53 p.m.</u> The Applicant presented submissions with respect to the request for a compliance audit of the Respondent's election campaign finances.
- <u>7:54 p.m.</u> Legal Counsel for the Respondent notes an objection to the Applicant presenting information regarding the Respondent's extension of time to file her financial statements. The Chair allowed the Applicant to carry on with their submissions.
- <u>7:55 p.m.</u> Legal Counsel for the Respondent notes an objection to the Applicant interpreting comments made by the Respondent in his submissions. The Chair requests that the Applicant be clear and only bring forward the allegations.
- <u>8:00 p.m.</u> Legal Counsel for the Respondent noted an objection to the Applicant presenting a quote from a book as part of the Applicant's submissions. The Chair allowed the Applicant to continue and noted the objection.

- <u>8:03 p.m.</u> Legal Counsel for the Respondent noted an objection to 93.e. The Applicant requested that objections be made following the Applicant's submissions. Legal Counsel for the Respondent noted that all objections must be made for the record.
- <u>8:05 p.m.</u> Legal Counsel for the Respondent noted an objection with respect to the fact that the Submissions Binder provided to him by the Applicant did not include all of the material referred to by the Applicant, notably Tab 14. The Chair noted that all materials should have been provided to all parties and allowed the Applicant to continue with his submissions.
- <u>8:19 p.m.</u> Roderick Chung, Vice Chair raised a point of order and noted that references to the last Election Campaign Finances meeting to review the first application for a compliance audit in October 2011 were not relevant and requested that arguments be kept to what is relevant to the current application.
- <u>9:15 p.m.</u> The Committee adjourned for a five (5) minute recess.
- <u>9:25 p.m.</u> The meeting reconvened and Legal Counsel for the Respondent noted that he may not be able to group all matters together adequately due to time constraints.
- <u>9:30 p.m.</u> Legal Counsel for the Respondent proceeded to make submissions in response to the Applicant's request for a compliance audit of the Respondent's election campaign finances and the Applicant's submissions.
- <u>9:43 p.m.</u> Legal Counsel for the Respondent noted his objection to references made to Mr. Thomas's withdrawal.
- <u>10:18 p.m.</u> Mahmood Nulla, Citizen Member, excused himself. Proceedings were suspended until Mr. Nulla's return.
- <u>10:20 p.m.</u> Mahmood Nulla, Citizen Member returned to the meeting and Legal Counsel for the Respondent continued with his submissions on behalf of the Respondent.
- **10:41** p.m. The Committee adjourned for a five (5) minute recess to allow the Applicant and Legal Counsel for the Respondent to prepare final submissions.
- **10:46 p.m.** The Committee reconvened the meeting and the Applicant proceeded to present final conclusions and submissions.
- **10:53 p.m.** Legal Counsel for the Respondent presented final conclusions and submissions.

<u>10:58 p.m.</u> - Mahmood Nulla, Citizen Member, moved a motion for the Committee to move In Camera to seek legal advice. Roderick Chung, Vice – Chair seconded the motion.

11:25 p.m. – The Committee moved from In Camera into public session. Richard Do, Citizen Member, moved a motion to defer the matter. The motion was not seconded and failed. The Chair moved a motion to grant the Applicant's request for an election campaign finances compliance audit of the Respondent's election campaign finances. The motion was not seconded and failed. Roderick Chung, Vice – Chair, moved a motion to reject the request for a compliance audit of the Respondent's election campaign finances. Mahmood Nulla, Citizen Member, seconded the motion. The motion was voted upon and carried. The Chair voted against the motion. Mr. Chung noted that the Committee's decision to reject the application was made on the grounds that sufficient and credible evidence had not been presented. It was noted that the Committee would take no further action with respect to this matter.
