MATTERS CONSIDERED

2. <u>MiWay Customer Satisfaction Survey and Market Research Results Summary</u>

Corporate Report dated August 20, 2012 from the Commissioner of Transportation and Works with respect to the MiWay Customer Satisfaction Survey and Market Research Results Summary.

Ms. Johnston spoke to the customer satisfaction survey and explained the purpose of the survey. She advised that the results of the survey indicated a high overall satisfaction score. She further advised of the key findings from the research and noted that in 2011 MiWay recorded its highest ridership.

Mr. Fisher spoke to the importance of good quality and reliable transit service. He suggested that weekend service should be extended to a later time and that MiWay move to being available 24 hours a day.

RECOMMENDATION

That the report dated August 20, 2012 from the Commissioner of Transportation and Works on the MiWay Customer Satisfaction Survey and Market Research Results Summary be received for information.

3. Paid Parking – Pay and Display Equipment Maintenance Options (Wards 1, 2, 4, and 7)

Corporate Report dated September 5, 2012 from the Commissioner of Transportation and Works with respect to pay and display equipment maintenance options.

Councillor Mullin enquired if there would be a cost savings for implementing a solution for the maintenance costs. Geoff Wright, Director, Transportation Project Office explained that the City would enter into an Asset Protection Renewal Program. The value of the program over time would provide a cost benefit with the aging machines that would require maintenance.

Councillor Tovey enquired about the maintenance costs of each parking machine. Martin Powell, Commissioner, Transportation and Works advised that the maintenance costs would continue to increase as the machines age. Mr. Wright explained the cost of maintenance for each machine and the additional provisions in the contract.

Direction was given to staff to bring forward a report to a future General Committee meeting to look at the information that was presented before the decision was made to proceed with the Pay and Display machines.

RECOMMENDATION

That the Purchasing Agent be authorized to increase the upset limit for the City's contract with Precise Parklink (#4600011972), for the Asset Protection Renewal Program (APRP), from \$2,113,923.34 to \$2,600,000.00 which will cover the maintenance costs associated with the City's 115 on-street pay and display machines, as well as consumable costs (i.e. ticket paper) and miscellaneous costs (vandalism) as outlined in the report to General Committee dated September 5, 2012 from the Transportation and Works Department.

Mr. Hruska spoke to EAC-0039-2012 in the Environmental Advisory Committee Report. He noted that Peel Region is a major hub in Canada for plastics and bag manufacturing, and that a plastic bag ban would severely affect jobs in the plastic sector. He further spoke to the environmental issues with plastic bags and noted that majority of waste comes from other sources. He requested that Committee consider the intended and unintended consequences with a ban on plastic bags.

Members of Committee spoke to the matter and noted the importance of research prior to considering a ban on plastic bags, concerns about job loss and that people are more aware of reducing waste.

COUNCILLORS' ENQUIRIES

Councillor Mullin spoke to a walking event for donations to the Compass Food Bank.

Councillor Ron Starr arrived in the meeting at 9:46 a.m.

Mayor McCallion spoke to an initiative in Great Britain to turn off all the lights at midnight in the residential areas as a cost savings.

Councillor Tovey spoke to a resident that had to pay back-taxes 3 years after an addition was made to their home. Brenda Breault, Commissioner, Corporate Services and Treasurer advised that the Municipal Property Assessment Corporation (MPAC) receives building permit information from municipalities, but the timing for properties to get on the assessment roll can take up to 3 years.

Councillor Saito spoke to an issue that was brought forward at a previous meeting with respect to excess lighting on a building that affects the surrounding residential homes. Mayor McCallion noted that she spoke with the company and they advised that the issue was resolved. Councillor Saito noted that the lights are turned off at 11:00 p.m., but it still creates an issue for the area residents.

Councillor Crombie advised that a private member's bill would be introduced at the Provincial Government level regarding a ban on tanning beds and noted that the City should continue to proceed with a ban as it may take some time before it becomes provincial legislation.

Councillor Crombie spoke to the proposed electoral boundary changes. Mary Ellen Bench, City Solicitor advised that a report would be coming forward. Mayor McCallion spoke to the timely nature that the electoral boundary changes should be addressed. Ms. Bench advised that representation on behalf of the City would attend the October 31, 2012 hearing for the proposed electoral boundary changes.
