CALL TO ORDER - 9:05 A.M.

DECLARATIONS OF DIRECT (OR INDIRECT) PECUNIARY INTEREST

Councillor Bonnie Crombie declared a conflict of interest with the In Camera item related to the Hershey Centre Lease Amendments due to the St. Mike's Majors.

APPROVAL OF THE AGENDA

Councillor Nando Iannicca moved approval of the agenda, as presented. This motion was voted on and carried.

DEPUTATIONS

A. Athena Tagidou with respect to National Flag of Canada Day 2012

Ms. Tagidou appeared before Committee to speak to National Flag of Canada Day, February 15, 2012. She noted that the digital screens at the Mississauga Celebration Square will have display images of the Canadian flag as well as a flag in the Great Hall to raise awareness of National Flag of Canada Day. She suggested that councillors incorporate National Flag of Canada Day celebrations with Family Day events in 2013 as they will both be on the same date. Ms. Tagidou noted that the main goals are to create awareness of National Flag of Canada Day and to have it celebrated at every school.

Members of Committee spoke to the matter and noted the importance of what Canada and the flag means and spreading the message in our schools.

PRESENTATIONS

Dianne Morgan, Mississauga Board of Trade and members of the Mississauga business made a presentation to Mayor Hazel McCallion in honour of her birthday.

DEPUTATIONS

B. Jean Overell, Ward 2 resident with respect to a petition submitted to Council on June 8, 2011 requesting the installation of curbs and sidewalks on Gregwood Road.

Ms. Overell spoke in support of a sidewalk on Gregwood Road and noted that there are other issues such as drainage problems that were outlined in a petition that was submitted to Council on June 8, 2012 that need to be addressed. She further explained the drainage issues, encroachment notices to residents and the lack of curbs on Gregwood Road. Ms. Overell requested that Gregwood Road be considered for a rebuild to address the drainage issues and to construct curbs. She further requested that during the interim, that residents on Gregwood Road be permitted to encroach to protect the grassy areas from vehicular damage.

Mayor Hazel McCallion and Councillor Pat Mullin spoke to the matter and noted the actions taken by staff to address the drainage issues. Martin Powell, Commissioner, Transportation and Works also spoke to the issues on Gregwood Road and noted that it would be at least 10 years before the road would be rebuilt. He advised that staff could go back and look at temporary solutions. He further advised that there were safety issues for cyclists with the encroachments and that staff could review other options.

Members of committee spoke to the matter and noted that staff should arrange a meeting with the residents on Gregwood Road to discuss the drainage issues and the sidewalk.

RECOMMENDATION

That the deputation by Jean Overell, Ward 2 resident be received and that staff arrange a meeting with the residents on Gregwood Road to discuss drainage related issues on the street and a sidewalk.

2. <u>Downtown On-Street Paid Parking Expansion (Wards 4 and 7)</u>

Corporate Report dated January 18, 2012 from the Commissioner of Transportation and Works regarding the expansion of on-street paid parking in the downtown area.

RECOMMENDATION

- 1. That a by-law be enacted to amend By-law 555-2000, as amended, to implement paid parking anytime on the south side of Square One Drive from a point 20 meters (65 feet) east of Confederation Parkway to a point 75 metres (245 feet) easterly thereof.
- 2. That a by-law be enacted to amend By-law 555-2000, as amended, to implement paid parking anytime on the west side of Duke of York Boulevard between Square One Drive and Prince of Wales Drive.
- 3. That a by-law be enacted to amend By-law 555-2000, as amended, to implement paid parking anytime on the east side of Duke of York Boulevard between Square One Drive and Prince of Wales Drive.
- 4. That a by-law be enacted to amend By-law 555-2000, as amended, to implement paid parking anytime on the north side of Elm Drive West between Hurontario Street and Kariya Drive.

3. Mentor College School Bus Loading Zone – Briarwood Avenue (Ward 1)

Corporate Report dated January 26, 2012 from the Commissioner of Transportation and Works with respect to a implementing a school bus loading zone on Briarwood Avenue for Mentor College.

RECOMMENDATION

1. That a by-law be enacted to amend By-law 555-2000, as amended, to add a school bus loading zone on Briarwood Avenue from a point 12 metres (39 feet) north of Forest Avenue to a point 13 metres (42 feet) northerly thereof.

2. That a by-law be enacted to amend By-law 555-2000, as amended, to add a school bus loading zone on Briarwood Avenue from a point 45 metres (147 feet) north of Forest Avenue to a point 41 metres (134 feet) northerly thereof.

That the City of Mississauga assume the municipal works as constructed by the developer under the terms of the Servicing Agreement for 43M-1753, The Erin Mills Development Corporation (lands located south of Erin Centre Boulevard, east of Misty Pine crescent, west of Tenth Line West, and north of Perennial Drive, known as the Churchill Meadows – Neighbourhood 403 (Block 26) Subdivision), and that the Letter of Credit in the amount of \$534,903.05 be returned to the developer and that a by-law be enacted to establish the road allowances within the Registered Plan as public highway and part of the municipal system of the City of Mississauga.

COUNCILLORS' ENQUIRIES

Parking Petitions

Councillor Pat Saito noted that a resident on Edenwood Drive submitted a petition to Council to permit parking on the boulevard, but did not receive a response from staff as to the results of the traffic survey. She enquired how residents can find out results of a traffic survey i.e. lower boulevard parking, and if the information is available online. Martin Powell, Commissioner, Transportation and Works responded that he would have staff review the matter on Edenwood Drive and review the best way to advise residents of results from a traffic survey.

Budget Information for Digital Boards

Mayor Hazel McCallion enquired about free advertising time on the Digital boards at the Mississauga Celebration Square. Paul Mitcham, Commissioner, Community Services advised that the banner on the boards is free and a select number of spots on the full screen. Mayor McCallion requested that staff include budget information on the digital boards. In response to the Mayor's request, Janice Baker, City Manager and CAO noted that staff would review including budget information on the digital boards at the Mississauga Celebration Square.

Cell Towers

Councillor Pat Mullin spoke to a letter received from the Mississauga firefighters expressing concerns about cell towers and requesting that no towers be located at any fire stations. Janice Baker, City Manager and C.A.O. spoke to the matter and noted that it is a labour relations issue. Mayor Hazel McCallion spoke to the matter and noted that it should be on the next Council agenda.
