DECLARATIONS OF DIRECT (OR INDIRECT) PECUNIARY INTEREST

APPROVAL OF THE AGENDA

Councillor Ron Starr moved approval of the agenda as presented. This motion was voted on and carried.

DEPUTATIONS

A. Dr. Jamie Garvey, resident to request an exemption to the Animal Care and Control Bylaw 0098-04 at 3075 Kirwin Avenue (Ward 7)

Dr. Garvey appeared before Committee to request an exemption to the Animal Care and Control By-law 0098-04 to keep a goat at a chiropractor clinic located at 3075 Kirwin Avenue.

Councillor Nando Iannicca spoke in support of an exemption to the Animal Care and Control By-law as he has not received a complaint about the goat. He requested that the matter be referred to staff for a report back to General Committee.

Recommendation

That the request from Dr. Jamie Garvey for an exemption to the Animal Care and Control By-law 0098-04 to permit a billy goat at 3075 Kirwin Avenue be received and referred to staff for a report back to General Committee.

B. Kristina Zietsma, Supervisor, Community Programs, Joanne Foote, Youth Plan Coordinator and Dana Wilson, Research Coordinator, Peel Children and Youth Initiative with respect to the Youth Friendly Community Application, Tracie Stevenson

Ms. Foote advised that an application was submitted to The Play Works Partnership to have Mississauga recognized as a youth friendly community. Ms. Zietsma explained The Play Works Partnership and noted that the City would qualify pending meeting set criteria. Ms. Wilson noted that Mississauga is one of the largest cities in Ontario to attain gold level status as 14 of the 16 criteria were met. Ms. Zietsma reviewed the next steps as recommended by the organization.

Members of Committee spoke to the matter and congratulated staff on their work.

MATTERS CONSIDERED

1. <u>Management Agreement – Boat Launch at Lakefront Promenade Park and Credit Village</u> <u>Marina (Ward 1)</u>

Corporate Report dated May 23, 2012 from the Commissioner of Community Services with respect to a Management Agreement for a boat launch at Lakefront Promenade Park and Credit Village Marina.

Mr. Kendell spoke about the Credit River Anglers Association, the Credit River watershed projects and the launch ramp programs.

Members of the Committee spoke to the importance of the work being done by the Credit River Anglers Association and the positive impact on the environment and Mississauga economy.

RECOMMENDATION

That a by-law be enacted to authorize the Commissioner of Community Services and the City Clerk to execute an agreement between the City of Mississauga and the Credit River Anglers Association covering management of the boat launch ramps at Lakefront Promenade Park and Credit Village Marina, in a form satisfactory to the City Solicitor.

2. <u>Recreation Division Aquafitness Fees</u>

Corporate Report dated May 25, 2012 from the Commissioner of Community Services in response to a petition received by Council in regards to the older adult rate for the Aquafitness program.

Councillor Bonnie Crombie expressed concern as seniors in Malton are opposed to the aquafitness rates. Councillor Pat Mullin spoke to the matter and noted that the City needs to take into consideration that it costs money to offer aquafitness programs. Mayor Hazel McCallion noted that the City has a subsidy program for residents that can't afford the program and meet the criteria. Discussion ensued with respect to the matter.

Councillor George Carlson noted the matter should be referred back to staff to consult more on the type of feeding and not the number of feeders that attract a large flock of birds. Councillor Katie Mahoney spoke in support of the referral for more information.

Councillor Chris Fonseca spoke in support and noted the importance of workshops on cycling safety.

- 2. That the Commissioner of Transportation and Works be authorized to negotiate with EHMS the terms and conditions of a new 5-year renewal term for the provision of Streetlighting Services; and
- 3. That the new agreement negotiated with EHMS for the provision Streetlighting Services commencing January 1, 2014 be brought to General Committee for approval.

8. <u>Proposed Street Name</u>

That the name **Smittys** be approved for use in the City of Mississauga, and be added to the City of Mississauga Approved Street Name Reserve List.

9. <u>Adoption of Private Street Names at University of Toronto – Mississauga Campus</u>

Corporate Report dated May 28, 2012 from the Commissioner of Transportation and Works with respect to the adoption of private street names at University of Toronto-Mississauga Campus.

Councillor Katie Mahoney spoke to the matter.

That the names Inner Circle, Outer Circle, Middle Road, Five Minute Walk, Residence Road, Principals Road and The Collegeway be approved as street names for the private roads within the University of Toronto Mississauga campus, located north of Dundas Street West and East of Mississauga Road.

10. <u>Request for Traffic Control Signals – Erin Centre Boulevard at Churchill Meadows</u> <u>Boulevard (Ward 10)</u>

Corporate Report dated May 24, 2012 from the Commissioner of Transportation and Works with respect to a request for traffic control signals at the intersection on Erin Centre Boulevard and Churchill Meadows Boulevard.

Councillor Sue McFadden noted that a traffic control signal should be implemented at the subject intersection as there was a serious traffic accident at the intersection due to speeding from Ninth Line to Tenth Line West.

Councillor Katie Mahoney spoke to the gap in reporting information about accidents and staff sometimes don't receive the information that an accident took place when they are investigating an intersection. Martin Powell, Commissioner, Transportation and Works explained that the Peel Regional Police will not provide the information about accidents publicly before their report is finalized.

Mayor Hazel McCallion expressed concern that the warrants have not been met for the traffic control signals and the cost associated with implementing them. Al Sousa, Manager, Traffic Engineering and Operations spoke to the matter and noted that staff performed a technical review and looked at the collision history. However, staff did not review the speeding concerns along Erin Centre Boulevard.

Discussion ensued with respect to the budget to install and maintain traffic control signals at the intersection and concerns that no police report has been provided on the serious accident at the intersection.

RECOMMENDATION

That the Corporate Report dated May 24, 2012 from the Commissioner of Transportation and Works with respect to a request for traffic control signals at the intersection on Erin Centre Boulevard and Churchill Meadows Boulevard be referred back to staff for more information and report back to General Committee.

Councillor Jim Tovey spoke to legislation for parental responsibility that would allow the City to sue the graffiti offender's parents for compensation. Mary Ellen Bench, City Solicitor noted that she was not sure of the status of the legislation.
