With Mr. Duic's indulgence, Committee concurred to bring forward Deputation B, as Mr. Webb was due to attend a hearing.

B Item 8 Ron Webb, Peel District School Board legal counsel, with respect to proposed addition to the Heritage Register, Russell Langmaid School, 170 Church Street.

Committee concurred to deal with Item 8 in conjunction with Deputation B.

8. Proposed addition to the Heritage Register, Russell Langmaid School, 170 Church Street

Corporate Report dated September 11, 2009 from Commissioner of Community Services with respect to the proposed heritage designation of Russell Langmaid School located at 170 Church Street, in Ward 11.

HAC Chair and local Ward Councillor, Councillor Carlson commented that he would support deferral of this matter until the June 2010 HAC meeting. He added that the School Board is involved in a lengthy hearing at this time and the school will be in use until the end of the current school year (June 2010) and therefore will not be demolished in the meantime. He noted that the City of Mississauga and the Region of Peel have first rights of refusal to purchase this school.

#### 5. <u>Proposed addition to the Heritage Register, "Vision '62,", 1352 Nocturne Court</u>

Corporate Report dated October 16, 2009 from Commissioner of Community Services with respect to the proposed addition to the City's Heritage Register of "Vision '62," located at 1352 Nocturne Court, in Ward 2.

Mr. John Duic, the homeowner, asked questions with respect to the affect of a heritage listing on property value, taxes, potential for resale and alteration or demolition. Heritage staff explained the process for listing a property on the City's Heritage Register as well as requirements of the property owner. Staff also explained the Heritage Designation process as well as the City's Heritage Granting program.

Committee members commented on the heritage significance of this property and expressed support for staff's recommendation for listing on the City's Heritage Register.

Subsequently, Committee members commented on the misconception of heritage in the community and hoped that they could work together with Heritage property owners to improve this issue overtime.

## 4. Request to alter a Heritage Designated Property, 40 Stavebank Road, Port Credit Memorial Arena

In response to Committee questions, Facilities & Property Management staff explained the consideration given to this Committee's previous comments on the designs with respect to the retaining wall. Committee members offered various possible solutions to address their concern such as glass, masonry, mural, landscaping or graphic imaging. It was suggested that perhaps the Streetsville arena could be used as an example in this regard.
