

# RULES & REGULATIONS FOR THE TEAM INCENTIVE PROGRAMS AT ICEBREAKERS

## HOW TO JOIN

1. Fill out the team promotion form on line or at Icebreakers. Ensure all fields are complete to avoid delay in your teams enrolment or be deemed not eligible.
2. The team must select a "team representative" for coordination of the Incentive Program(s), arranging end of season team parties, and collecting the team awarded prizes.

## WHO CAN ENTER

1. All team incentive programs are open to teams, in good standing, that practise or participate in a team setting at Iceland Arena and are 19 years of age or older.
2. City Employees, family members, or friends of Employees are permitted to participate in the Incentive Program(s) as part of a team but must be on a team roster and have played a minimum of 5 games.
3. Multiple team members are encouraged to provide their contact information to be placed on our distribution list for on going and future promotions at Icebreakers Sports Café.

## INFORMATION ON THE INCENTIVE PROGRAM(S)

1. Every pre-tax dollar spent at Icebreakers is equivalent to one (1) point towards the program. The team that has earned the most points during the Incentive Program(s) will be awarded the first (1) place prize. The second (2) place and third (3) place ranked teams by points will be awarded prizes accordingly.
2. Teams that do not qualify for the top three prizes are still eligible to redeem their points towards a voucher for an end of season team party at Icebreakers Sports Café. Vouchers will be issued to the registered team representative in the amount of 10% of all pre tax **food purchases** during the incentive program timelines.
3. Contact information from at least one active team member must be provided to be enrolled in the Incentive Program(s).
4. Track your teams progress by visiting our website at [www.mississauga.ca/iceland](http://www.mississauga.ca/iceland) or view the leader board at Icebreakers Sports Café.
5. Accumulated point results will be updated Friday of each week. On Monday if Friday is a holiday.
6. All receipts must be validated by their server at the time of payment. Icebreakers will keep a copy of the receipt for tracking in the team matrix.
7. Teams that join the Incentive Program(s) no later than Sunday, November 16, 2011 will receive 200 BONUS points with their first purchase at Icebreakers Sports Cafe. Team registering after this date may participate in the program but will not be awarded any BONUS points.
8. There will be three top prizes awarded. See Prizes description for further details.
9. End of season team parties must be pre arranged with Cris Brown, Supervisor of Food and Beverage 905-615-4680 .2032.
10. Program starts Tuesday, September 24 at 5 PM and will end March 1, 2011 at 12 AM.

## PRIZES

1. There are a total of (1) first place prize, one (1) second place prize, and one (1) third place prize to be awarded.

### *1st Prize -*

1 Hour of Free Team Ice and \$50.00 towards an end of season team party at Icebreakers Sports Café

### *2nd Prize -*

\$150.00 Voucher for End of Season Team Party at Icebreakers Sports Café

### *3rd Prize -*

An additional 15% off of a pre booked end of season team in addition to the standard 10% allotment.
