

#### NOTICE OF DECISION

#### of the

#### MISSISAUGA APPEAL TRIBUNAL

established pursuant to section 23.5 of the Municipal Act 2001

IN THE MATTER OF a Notice of Appeal dated June 4, 2008 to the Mississauga Appeal Tribunal by Margaret Teixeira, 814 Catcay Crescent, Mississauga, Ontario of an Order to Muzzle a Dog having a lifetime license number 31137 issued by the Manager of Animal Services on April 15, 2008, under the City of Mississauga By-law 0098-2004, as amended (the "Muzzle Order").

AND IN THE MATTER of the Hearing of the Appeal by the Mississauga Appeal Tribunal on October 28, 2008 in accordance with the provisions of the City of Mississauga By-law 0098-2004, as amended, and the *Statutory Powers Procedure Act, R.S.O. 1990, c. S.22*, as amended.

BE ADVISED THAT it is the decision of the Mississauga Appeal Tribunal to:

Uphold the Order to Muzzle a Dog having a lifetime license number 31137 pursuant to the City of Mississauga By-law 0098-2004 issued by the Manager of Animal Services on April 15, 2008 to Margaret Teixeira subject to the following amendments to the Muzzle Order:

- 1. Paragraph 1 the words "leashed and" are deleted; and,
- 2. Paragraph 8 is hereby deleted and replaced with "The provisions of the Animal Care and Control By-law 0098-2004 shall continue to apply."

The reasons for this decision are as follows:

- 1. On balance, it is the view of the Tribunal that the Muzzle Order satisfies the interest of public safety. However, removing the "leashing requirement" in paragraph 1 of the Muzzle Order, gives the owner the opportunity to take the dog to off-leash parks in Mississauga.
- 2. Pursuant to Subsection 33(1) of the By-law 0098-2004 the Manager of Animal Services may issue a Muzzle Order where the Manager has reason to believe that a dog has bitten a person or an animal. Although the Tribunal would have liked to have heard evidence from the City of Mississauga Manager of Animal Services regarding the foundation upon

which the decision was based to issue the Muzzle Order, the Tribunal feels that based on the evidence heard the City of Mississauga Manager of Animal Services discharged the onus set out under Subsection 33 (1) of the subject By-law 0098-2004. That is, the Tribunal heard evidence that a bite occurred and this was not contradicted.

- 3. The Tribunal heard oral and written evidence that the dog under the Muzzle Order was not wearing a muzzle, growling and off leash at other times. The Tribunal also heard evidence that the dog under the Muzzle Order is well behaved and does not pose a threat. It was noted that some of the written evidence was hearsay in nature and the Tribunal weighted this evidence accordingly in consideration of their decision.
- 4. On the balance of probabilities and attempting to reduce any potential for harm to public safety, the Tribunal was persuaded that the Muzzle Order was fair and reasonable.
