3. Hearing Procedures - Witness Statements (Business Arising: November 18, 2008)

MOTION: by Rafiq Rokerya

- 1. That a Practice Direction be adopted as follows.
 - a. The best evidence in a hearing is oral evidence. The Parties are encouraged to present their evidence orally at the hearing.
 - b. Where it is impossible or presents a hardship for a witness to attend in person, a witness statement in the form of an affidavit may, at the discretion of the Tribunal, be presented in accordance with Rule 6 of the Mississauga Appeal Tribunal Rules of Practice and Procedure.
 - c. At the discretion of the Tribunal, such other document or other thing may be presented.
- 2. That the Practice Direction be provided and available in the same manner as the Rules of Practice and Procedure.

4. <u>Legislative Requirements for Paralegal Representation – Impact on representation before</u>
Tribunal

5. Report to General Committee – A Review of Licensing Appeal Body Transition from Committee to Tribunal
