PRESENTATIONS/DEPUTATIONS:

At this time Mark Oldrychski from the Glengarry, Mavis, Queensway Residents Association noted concerns about the Queensway Trail and suggested a connection from the Trail to Glengarry Road. Jeff Wachman, Chair and Jacquelyn Hayward Gulati spoke to the Cycling Master Plan and noted that the connection is part of the Plan. Discussion ensued with respect to the Traffic Calming Pilot Project. Mr. Wachman suggested to Mr. Oldrychski to send a letter to the Ward Councillor regarding improvements to the cycling connections as it helps with setting priorities for the budget.

2. <u>Tour de Mississauga Subcommittee Update</u>

Dorothy Tomiuk, Citizen Member to provide a verbal update on the status of the Tour de Mississauga event.

Ms. Tomiuk provided an update on the new logo for the Tour and a future review of branding for the event. Discussion ensued with respect to sponsorship for the event. Don Stephens spoke to the origin of the new design for the cycling jerseys. The committee reviewed the design for the t-shirts and jerseys and provided comments. Further discussion ensued with respect to the sponsorship package to be distributed to prospective sponsors.

Recommendation:

That the design for the Tour de Mississauga logo and cycling jersey be approved as presented at the July 12, 2011 Mississauga Cycling Advisory Committee meeting.

3. <u>Proposed 2011 Cycling Network Work Plan</u>

Memorandum dated July 12, 2011 from Jacquelyn Hayward Gulati, Manager, Cycling Office regarding the 2011 Cycling Workplan.

The committee discussed the cycling network work plan. Jeff Wachman, Chair suggested that a letter be prepared to thank Councillor Katie Mahoney for agreeing to the cycling connections on Mississauga Road between Dundas Street and The Collegeway/UTM Driveway. Jacquelyn Hayward Gulati suggested that the letter be sent following completion of the cycling network connection.

Discussion ensued with respect to funding for the projects listed in the memorandum. Councillor Chris Fonseca suggested that in future it would be helpful to list the ward numbers for each location. Ms. Hayward Gulati noted that some of the locations would require an opening event such as the Britannia Road facilities and the committee would be advised of the event. Jeff Wachman, Chair suggested that there be a quarterly update to the committee on the status of the projects listed in the memorandum.
