4. <u>REPORTS OF SUBCOMMITTEE</u>

4.1 <u>Collections and Storage Subcommittee - Canadian Conservation Institute Report</u> on Museums' Storage

Canadian Conservation Institute Report on Museums' Storage dated February 16, 2009 with respect to the Museums of Mississauga collections storage ("CCI Report").

Annemarie Hagan, Museums Manager, emailed a copy of the CCI Report to Committee Members prior to the meeting and distributed hardcopies at this meeting. She reviewed the report and noted the suggestion for a purpose built facility for Museums' collections. She indicated that such a facility may cost approximately ten-twelve million dollars (\$10,000,000-\$12,000,000) and there may be grant opportunities from the Provincial and Federal governments. Ms. Hagan explained that the CCI Report contained a facility concept for a warehouse type facility with spaces for quarantine, exhibit / gallery, archival collections, archaeology collections, dark spaces and compact art storage. Ms. Hagan advised of preliminary discussions with respect to the feasibility of a joint facility with the Art Gallery of Mississauga.

4.3 Report of the Collections and Storage Subcommittee meeting on May 19, 2009

Recommendation: CASS-0008-2009

Committee referred the CASS recommendation back to CASS for review and expression of support and requested that the final recommendation be presented to General Committee in conjunction with the Corporate Report prepared by staff.
