Hurontario-Main Light Rail Transit Project NOTICE OF COMPLETION Environmental Project Report



The Project

The City of Mississauga, the City of Brampton and Metrolinx, as project co-proponents, have completed an Environmental Project Report (EPR) for the introduction of Light Rail Transit (LRT) in the Hurontario-Main Street corridor.

The Hurontario-Main Light Rail Transit (HMLRT) Project involves the development and operation of a high frequency LRT service in the segment of the Hurontario-Main corridor between the Port Credit GO Station and the GO Station in Downtown Brampton, as shown on the accompanying Study Area map. The LRT line is proposed to have 26 stops on the 23 km corridor, including stops within the Downtown Mississauga City Centre. A 7 hectare maintenance and storage facility, including the LRT control centre, will be located south of Highway 407 between Hurontario Street and Kennedy Road. The Hurontario-Main corridor was included in the Metrolinx Regional Transportation Plan (November 2008) and was identified as a priority project.

The Process

The environmental impact of the Hurontario-Main LRT Project was assessed and an Environmental Project Report was prepared in accordance with the Transit Project Assessment Process prescribed in Ontario Regulation 231/08, Transit Projects and Metrolinx Undertakings (Transit Projects Regulation). The EPR is now available for a 30-day review period, starting **June 19, 2014**, on the project website (www.hurontario-main.ca) and at the following locations

There are circumstances where the Minister of the Environment has the authority to require further information on the transit project, or impose conditions on it. These include instances where the Minister is of the opinion that:

- The transit project may have a negative impact on a matter of provincial importance that relates to the natural environment or has cultural heritage value or interest; or,
- The transit project may have a negative impact on a constitutionally protected Aboriginal or treaty right.

Before exercising the authority referred to above, the Minister is required to consider any written objections to the transit project that he or she may receive within the 30-day public review period after the Notice of Completion of the Environmental Project Report is first published. The Minister has 35 days following the 30-day public review to make his determination and advise the Cities of Mississauga and Brampton and Metrolinx.

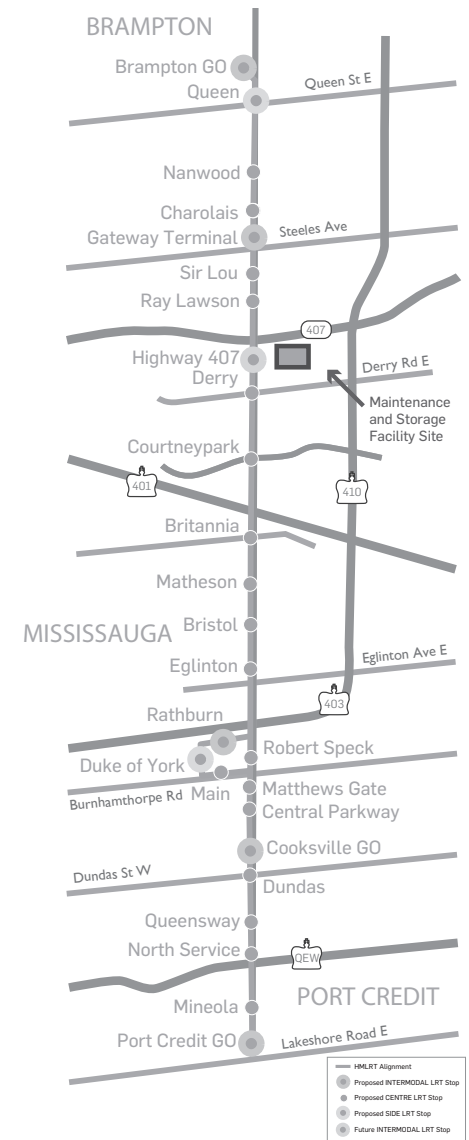
If you have discussed any concerns you have with the Cities of Mississauga and Brampton and Metrolinx, and you object to the project, you may provide a written submission to the Minister of the Environment no later than **July 18, 2014** at the address provided below. All submissions must clearly indicate that an objection is being registered and describe negative impacts to matters of provincial importance (natural/cultural environment) or constitutionally protected Aboriginal or treaty rights.
