8. School Zone Safety (Kiss & Ride) Report – October/November 2008

Jim Wilde advised that he conducted an inspection at Bristol Road Middle School, 210 Bristol Road East to review the Kiss & Ride area. He further advised that he observed problems with traffic in the parking lot and that late parents worsened the traffic situation in the Kiss & Ride area. Doug Fryers commented if anything could be done if parents are not permitted to park on the school property or on the street. Councillor Sue McFadden noted that schools are in walking distance for a majority of students, but some parents choose to drive their children to school. David Brown, Chair commented that Traffic Safety Council needs to focus on the walking school routes program to change the behaviour of some parents and their way of thinking.

Mr. Wilde advised that he met with Dave Marcotte, Peel District School Board and the Principal at Port Credit Secondary School, 20 Mineola Road East to discuss possible modifications to the driveway to implement a formal Kiss & Ride area. He further advised that modifications to the driveway should be implemented at the school in Spring 2009.
