The undersigned hereby acknowledges that in issuing any building permit or permit for swimming pool construction or swimming pool enclosure, the Corporation of the City of Mississauga is in no way permitting or approving any changes to the grades or non-compliance with any lot grading plan, which is at variance with any such agreement or contract.

The undersigned hereby acknowledges that the sole responsibility for lot grading and drainage and the compliance with any contracts or agreements in existence rests with the undersigned as owner of the property.
