## Infrastructure Stimulus Fund (ISF) in Ward 1

I am pleased to share some good news for Ward 1 residents! Since the 2004 Library Master Plan was released five years ago, we documented the fact that both Lakeview Library and Port Credit Library needed a significant redevelopment due to age, mechanical lifecycle issues and functionality. Now, with funding available through the Infrastructure Stimulus Fund (ISF) program, we will get this well-deserved redevelopment for two buildings that are an integral part of our community.

ISF is a joint investment by the federal, provincial and municipal governments to fund infrastructure projects, which will create jobs and help stimulate the economy. Each level of government is contributing up to one third of eligible costs. Mississauga's 132 approved ISF projects must be completed by March 31, 2011 to be eligible for funding.

We are appreciative of the partnership with the federal and provincial governments that has made these major infrastructure improvements possible.

The plans for both libraries are quite extensive and include numerous upgrades and functionality improvements. At \$2.5 million for each library, the project will enable the buildings to remain in good repair while meeting customer needs. The economic life will be extended; energy savings will be realized; closed circuit cameras will increase safety; staff and public areas will be designed to accommodate today's technology; and customers will have an updated, welcoming facility to gather, borrow materials and use resources.

These improvements are expected to increase library usage, especially among youth and older adults. The current construction schedule for Lakeview Library is January 2010 to July 2010 and for Port Credit Library, June 2010 to March 2011.

## CLEANING UP GRAFFITI

It's easy to miss some of the smaller, yet important, changes that can happen in our community as we go about our busy lives. One such noticeable, yet often overlooked change, is the presence, or impact of, graffiti. Graffiti has been known to literally change the face of a community, causing citizens to avoid certain areas that in turn attract criminals. Yet, very few people see it as a problem when it appears small and manageable.

Graffiti is a premeditated, and sometimes highly organized, form of vandalism with a very well-developed subculture behind it. It's often motivated by a desire for fame which accounts for the same "tag" (stylized signature or marker) or "masterpiece" being seen over and over again.

The general public often attributes tagging to the work of gangs. While tagging can be gang-related, it's generally not the case. This makes little difference in the minds of the public, which simply chooses to avoid areas with excessive graffiti. This will ultimately affect profits and, if left unchecked, the viability of businesses and communities.

Graffiti must be dealt with before it has a chance to "breed". This means removing graffiti as soon as possible and thereby depriving the graffiti vandal of their most basic reward - fame. This may mean taking additional measures in highly visible and accessible locations that are particularly prized by graffiti artists.

The insidious nature of graffiti and the determination of these vandals make this a formidable and expensive form of criminal mischief that the community can't ignore. By reporting suspicious behaviour, we can stop graffiti before it happens.

## Mississauga 3-1-1 is Now in Service

The City of Mississauga has officially launched its 3-1-1 telephone service as of the week of October 5th. For the first time ever, Mississauga residents will be able to access City and Region of Peel information, programs and services through a simple 3-digit phone number.

By calling 3-1-1, callers will access an Interactive Voice Response (IVR) menu that provides the option of selecting either city or regional services. Regional calls about waste and recycling, water, health or social services will be routed to the Region of Peel customer contact centre. Callers inquiring about City of Mississauga information and services will be assisted by a trained Mississauga Customer Service Advisor.

The Tax Self-Service Centre allows online users access to a variety of tax services with only the click of a mouse. ## Did You Know?

### Mississauga's Sign By-Law Governs ALL Signs

- Banner, sidewalk, window, directional, new development, construction, inflatable signs, sandwich and plywood boards, as well as portable (mobile) signs;
- The by-law includes regulations governing the size (sign area, sign height and set-backs), location by zoning category and duration (if the sign is to be displayed on a temporary basis);
- It's the responsibility of business and property owners to ensure compliance with sign regulations;
- Provided that all signs comply with the sign by-law, property owners may decide the types and number of signs they will allow on their property.

### Signs Require a Permit

- All signs displayed, erected or altered on private or public lands within the City of Mississauga require a sign permit;
- Signs may also require a separate building permit.

### Signs on Public Land

- Signs on public lands are prohibited unless specifically allowed under the Sign By-Law.

## In the Know About Snow

Every year, the City and its residents face the same challenge of dealing with snow clearing and getting through the winter season. The City of Mississauga establishes snow clearing standards, taking into consideration public safety and budget availability. It is important to note that levels of snow clearing service differ from municipality to municipality.

### We ask our residents to:

- **ensure that you are prepared**, if you know that there is a major snowfall forecasted
- **remove parked cars from the street** prior to and during plowing or clearing operations
- **clear snow and ice from sidewalks as soon as possible** after a snowfall to ensure that they are safe for all residents
- **help others, especially seniors and disabled persons**, to clear their driveways and sidewalks
- **not place snow on the roadways** - this could lead to a fine under City By-Law No. 23-79 which prohibits the placement of snow from private property onto the public right-of-way.

Be patient and thoughtful. The City is out there working on your behalf. A little consideration and common sense can go a long way when weather conditions are difficult.

### Assistance With Snow Clearing

- A snow clearing subsidy program is available for disabled persons who currently receive assistance under the Ontario Disability Support Program Act, 1997 or the Ontario Works Act, 1997

or seniors who currently receive the guaranteed income supplement under Part 2 of the Old Age Security Act (Canada).

- To qualify, the applicant must be a Mississauga resident who resides as owner or legal tenant in the residential property for which the snow removal subsidy is required. Residents living in a highrise or similar multi-unit building will not qualify.

Those currently registered in the program will receive their winter claim forms in the mail.

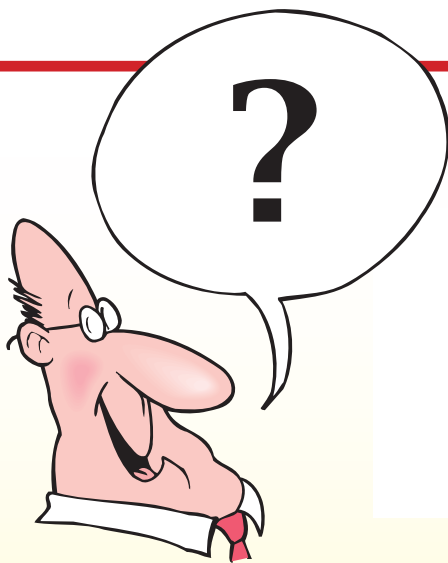
### Need More Information?

## Frequently Asked Questions:

- Is it an offence for my neighbour to allow litter and debris to accumulate on his property? **YES**
- Can my neighbour have an unlicensed car visible on his property? **NO**
- Can I call By-Law Enforcement on the weekends? **YES**
- Can my neighbour create, cause or permit any unusual noise that disturbs me? **NO**
- Can I park longer than 3 hours on the street, if it's not signed? **NO**
- Can I request overnight, special permission to park on the street? **YES**
- Can the City inspect my private tree? **NO**
- Can the City inspect my neighbour's private tree, if I feel it is unsafe? **YES**
- If I remove more than 4 trees (in a calendar year) on my property, do I require a permit? **YES**
- Does the City have information on the procedure to determine the cost of a division fence? **YES**
- Is there a fence height restriction? **YES**
- Can I call the City for a dog running at large? **YES**
- Can I build a shed, deck, driveway, etc. without a permit? **You should always check with the City.**

Did you know that motorists and pedestrians are responsible for creating between 30 and 50 per cent of all litter? The balance of litter comes from household or commercial garbage, construction sites, loading and delivery areas, and uncovered trucks.

### How Can You Help?

Your business, sports organization, service club, school, community group or neighbourhood can become a LitterNot Leader by adopting a street or park through the Volunteer Clean-up Program.

The Volunteer Clean-up Program involves a two-year commitment with a minimum of three clean-ups per year. The City will support your group by providing necessary training, safety equipment, garbage bags and garbage pick-up.

For your efforts, a special sign will be erected in your adopted location, your group's name will be included in annual newspaper advertisements, and a Certificate of Recognition from Mayor McCallion will be presented at the completion of each two-year term.
