CALL TO ORDER

David Raakman, Vice - Chair, called the meeting to order at 5:00 p.m.

DECLARATIONS OF DIRECT (OR INDIRECT) PECUNIARY INTEREST

David Raakman, Vice- Chair declared a conflict of interest with respect to any Agenda items specific to Ward 10 due to his temporary position in the Ward 10 office and in accordance with Council Resolution Number 0301- 2011. He left the meeting when the Ward 10 matter concerning McKinnon Public School was heard by Traffic Safety Council.

PRESENTATIONS/ DEPUTATIONS

A. Lisa DeFrancesco, Member, Lorne Park Watercolours Residents Association, Resident, Ward 2, with respect the Lorne Park Watercolours Residents Association's objection to the installation of maze gates (off set gates) at Fresco Way and Canyon Street for students attending St. Luke Catholic School, 1280 Cobalt Street.

David Raakman, Vice – Chair outlined the mandate of Traffic Safety Council and welcomed the delegation to speak to the matter regarding the intersection of Cobalt Street and Canyon Street

Ms. DeFrancesco outlined the reasons why the Watercolours Residents Association objected to the installation of the maze gates (off set gates) at Cobalt Street and Canyon Street. The reasons were as follows: a crossing guard was not warranted based on Traffic Safety Council's site inspection report, the volume of traffic at the intersection was light and therefore traffic calming measures were not required, the visibility for crossing pedestrians is clear, maze gates had not been requested in the original email, no conflicts were observed during the site inspection and maze gates could serve as a barrier which could detract from the use of the park and would hinder community interaction. She further requested that the recommendation to review the feasibility of installing maze gate not be approved by Traffic Safety Council.

Ms. DeFrancesco also read a letter dated February 21, 2012 from Craig Serjeant, Principal, St. Luke Catholic Elementary School, confirming that he had received no complaints or concerns regarding the intersection of Cobalt Street and Canyon Street.

David Brown, Chair, noted that while the intersection has a low volume of traffic and does not warrant the placement of a Crossing Guard, the recommendation regarding the installation of maze gates was intended to mitigate safety issues that could arise in the future.

Andy Bate, Supervisor, Traffic Operations, noted that when conducting a feasibility study to determine if maze gates were necessary, Traffic Operations would consider engineering and safety concerns related to the intersection.

Discussion ensued with respect to the intersection and it was noted that if Traffic Safety Council perceives a possible safety concern, it must be addressed for the record. In addition, the importance of Traffic Safety Council being proactive rather than reactive was discussed.



February 7, 2012 Shelter Bay Public School Ward 9 rartic Safety Committee

No conflicts were observed at this dismissal assessment. Many students were observed walking from Shelter Bay Public School. Dismissal works relatively well at the school. There is a chain link fence across front of property preventing students from crossing driveway. Parents park on both sides of Shelter Bay Road during "Dismissal Period" in spite of the posted signage.

School is immediately north of a Tee intersection which is an "All Way Stop" intersection offering protection to all pedestrians and students crossing at this location.

The Vice Principal raised a concern with respect to the area where a pathway, east of the school, intersects with Shelter Bay Road. Congestion and parking infractions which occur in this area have been an ongoing problem.

Recommendation

That Parking Enforcement be requested to enforce parking infractions in front of Shelter Bay Public School, 6735 Shelter Bay Road, and at the pathway east of the school, between 3:05 p.m. and 3:30 p.m.

March 9, 2012 Father Daniel Zanon Catholic School Ward 7

There was a heavy volume of vehicles during the dismissal period. Congestion was increased as parents attempted to be close to the door in the School Zone Safety (Kiss and Ride) lane. Instead of parking in the generous parking lot and walking to the school to pick up students, vehicles were circling the driveway. Parking on the north side of Hillcrest Avenue, opposite the school, becomes hazardous as parents and students attempt to cross the road although there is a high volume of traffic along Hillcrest Avenue. Students observed crossing Hillcrest Avenue were accompanied by a parent.

Numerous walkers were observed during this inspection and dismissal works relatively well at this school. There is a Crossing Guard in place at Hillcrest Avenue and the school. No conflicts observed.

Recommendation

- That Parking Enforcement be requested to enforce parking infractions in front of Father Daniel Zanon Catholic School, 450 Hillcrest Avenue, between 3:15 p.m. and 3:40 p.m.
- 2. That the Walk to School Subcommittee of Traffic Safety Council be requested to consider Father Daniel Zanon Catholic School as a possible participant in the School Walking Routes Program.

March 19, 2012 Mineola Public School Ward 1

The access to Mineola Public School is at Crossfield Bend, and the exit is via Wendy Oaks. While this is a circuitous route, it is manageable. Many children were observed walking home from school. No safety walks were observed on any of the local streets and are likely not wanted by residents; however, there may be pedestrian safety issues because of this.

There is a large recreation and play fields to the rear of Mineola Public School. No volunteers were observed managing the School Zone Safety (Kiss and Ride) storage area during the dismissal period. The parking lot was chaotic and drivers were observed parking in random locations. No conflicts were observed during this inspection.

The south parking lot was recently paved and is painted with only an island. Dave Marcotte and the Principal, R. Manners were contacted regarding their concerns.

Dismissal works fairly well but will be vastly improved when the south parking lot is painted with the appropriate School Zone Safety indications, including lanes, wording and directional arrows. Dismissal would be further improved if staff monitored the south parking lot.

Recommendation

- That the Peel District School Board be requested to paint the School Zone Safety (Kiss and Ride) with lane designations, directional arrows and stop bars in the spring of 2012 at Mineola Public School 145 Windy Oaks.
- That the Principal of Mineola Public School be requested to arrange for volunteers, to monitor the School Zone Safety (Kiss and Ride) during the dismissal period.

March 20, 2012 St. Raymond Catholic School Ward 6

Many students were observed walking home and no conflicts were observed during the inspection. The school has a well laid out school and driveway. There is a chain link fence along east street line of Whitehorn Avenue to ensure that students cannot randomly cross the driveway. There are safety features in place such as pedestrian walkways and pavement markings. Most parking spots on site were filled by 2:45 p.m. There is an early release of kindergarten students at 2:55 p.m. Staff assisted with bus loading and monitored student conduct during dismissal. Dismissal works well at St. Raymond Catholic School. This school will implement the School Walking Routes program in April 2012. Consulted with the Vice - Principal regarding her concerns during dismissal and driver conduct, similar to that at most schools, is an issue.

Recommendation

That Parking enforcement be requested to enforce parking infractions in front of St. Raymond Public School, 5735 Whitehorn Avenue, between 2:45 p.m. and 3:10 p.m.

March 21, 2012 St. Luke Catholic School Ward 2

The school has one cube bus and two full size buses temporarily parking in the through lane of the exit driveway as the driveway adjacent to the curb is not long enough to accommodate the buses. Vehicles are parking illegally and contravening traffic laws on Cobalt Street and Indian Road during the dismissal period because vehicles are parking on both sides of the road waiting for dismissal bell. School staff monitor student movement and vehicles on school grounds during dismissal. Few students were observed walking home from this school. No conflicts were observed during this inspection. There is a Crossing Guard in place at the intersection.

Recommendation

- That the Transportation and Works Department review the No Stopping and No Parking signs on Cobalt Street and Indian Road in the vicinity of St. Luke Catholic School, 1280 Cobalt Street.
- 2. That Parking Enforcement be requested to enforce parking infractions along Cobalt Street, in the vicinity of St. Luke Catholic School, between 2:45 p.m. and 3:10 p.m.

March 22, 2012 St. Gertrude Catholic School Ward 5

Most of the parking spots were occupied by 2:45 p.m. No conflicts were observed during this inspection. Many students were observed walking home. There is a Crossing Guard in place at the exit driveway opposite Mirage Place. Many parents park on both sides of Mirage Place, Esprit Crescent and Patriot Drive causing congestion and traffic difficulties. Numerous vehicles are also parked on both sides of Ceremonial Drive even though there are prohibitive signs on both sides of the roadway opposite the school. Staff members wearing vests monitor students during the dismissal period. Dismissal works well at St. Gertrude Catholic School.

CALL TO ORDER

Heather Relf, Chair, called the meeting to order at 10:40 a.m.

ITEMS FOR DISCUSSION

Verbal Update – Traffic Safety Council DVD Project

David Raakman, Traffic Safety Council Vice - Chair, outlined the history of the Traffic Safety Council DVD project and highlighted the goals of the project.

Mr. Raakman outlined the vision of the DVD contest and how the contest is intended to run. He specified that high school students would be asked to create short videos that would highlight traffic safety such as how to safely cross the road, how to use a School Zone Safety (Kiss and Ride) etc. He noted that the videos would be uploaded to the internet and that the public would have the opportunity to vote for the best videos. He then outlined the awards available.

2. Discussion with Communications

Catherine Monast, Team Leader, Media External Communications and Kimberley Hicks, Public Affairs Consultant noted ways in which Communications could help with the promotion of the project. They noted that Communications could issue media advisories, draft letters to schools, and use City of Mississauga social media such as Facebook and Twitter to promote the contest. It was also suggested that the official launch of the program and the awards ceremony take place at a Council meeting.

Discussion ensued with respect to legalities and Ms. Monast stressed the importance of having a consent form for minors to appear in the Traffic Safety Council DVD and to be involved in the contest. It was also suggested that Traffic Safety Council touch base with schools prior to launching the project to ensure that there is interest and if this type of project could be incorporated into current curriculum.

The Subcommittee discussed how to create a compilation video that would include clips from a variety of the submissions. If was noted that an Audio Visual Company could be used to do this and that the purchasing by-law would be checked to ensure that the correct procurement process is used should Traffic Safety Council decide to use such a company.

3. Next Steps

The subcommittee discussed the next steps involved in the project. It was noted that the subcommittee would (a) create a contest name for approval at Traffic Safety Gouncil; (b) request information from Information Technology to look at how the videos could be posted to the web; (d) contact various schools to investigate possible interest in the contest; (e) review the contest rules, guidelines, timelines and criteria.

4. Traffic Safety Times

Discussion ensued with respect to the creation of a Traffic Safety Times Newsletter which addresses compliance with road signs in school zones and how to safely cross the road, as per Traffic Safety Council recommendations TSC-0190-2011 and TSC-0195-2011. It was suggested that the Legislative Coordinator could compile the appropriate information for the proposed Traffic Safety Times and that David Raakman, Traffic Safety Council Vice - Chair, could format the information into the appropriate document.

5. Dr. Arthur Wood Safety Award

The Subcommittee discussed possible nominees for the Dr. Arthur Wood Safety It was decided that nominations would be discussed at the next subcommittee meeting.

3

Review of the School Zone Safety (Kiss and Ride) Award Process 6.

The subcommittee discussed the School Zone Safety (Kiss and Ride) Award and noted the lack of interest in the award over the years. It was suggested that in lieu of a School Zone Safety (Kiss and Ride) Award, a new award could be created to promote walking to school rather than driving. The subcommittee suggested that the School Zone Safety (Kiss and Ride) Award be awarded to one (1) school in 2012, rather than five (5) schools, and that the remainder of the award money be presented to a school which generates the highest number of student walkers on International Walk to School Day in October of 2012.

The following recommendation emanated from the above discussion and is to be presented to Traffic Safety Council for the committee's review and approval at the March 28, 2012 meeting:

RECOMMENDATION

- That Traffic Safety Council be requested to award the School Zone Safety 1. (Kiss and Ride) Award to one (1) school in 2012 rather than five (5) schools, and that in future an award to promote walking to school be presented in lieu of the School Zone Safety (Kiss and Ride) Award.
- That the Public Information Subcommittee of Traffic Safety Council be requested to create the criteria for an award and the award process for an award related to walking to school which would replace the School Zone Safety (Kiss and Ride) Award.

7. Email dated April 22, 2011 from Doug Fryers

The subcommittee reviewed and discussed the email dated April 22, 2011 from Doug Fryers, Traffic Safety Council Citizen Member, outlining suggestions for the general operation of the Traffic Safety Council. In reference to suggestion one (1) of the email, it was noted that while Traffic Safety Council members should remain inconspicuous during site inspections, members should continue to wear their City of Mississauga identification badges as per Traffic Safety Council recommendation TSC-0139-2011, and should display Official City Business signs on their vehicles when conducting site inspections.

The subcommittee also discussed suggestions two (2) and three (3) outlined in Mr. Fryer's email and noted that no recommendation was required from the subcommittee as these suggestions were Traffic Safety Council practices. Suggestion four (4) of the email was also discussed and the subcommittee suggested that it was outside of their mandate to make a recommendation regarding the suggestion.

The following recommendation emanated from the above discussion and is to be presented to Traffic Safety Council for the committee's review and approval at the March 28, 2012 meeting:

RECOMMENDATION

That for identification purposes, Traffic Safety Council members be requested to display Official City Business signs on their vehicles when attending Traffic Safety Council site inspections.

Posting videos



6. <u>Hillside Senior Public School</u>

David Marcotte requested that the Traffic Safety Council review this site as it is being considered as a possible expansion site.
