## **RECOMMENDATION:**

That the Commissioner of Planning and Building be advised that with respect to the Proposed Site Plan SP 10/087 – New School on Hartsdale Site, that Traffic Safety Council has reviewed the site plan submitted on May 14, 2010 and would recommend the following:

- 1. That further details be provided with respect to the Hartsdale Avenue area beyond the school limits
- 2. That the student drop-off area be converted into a three lane Kiss & Ride system and that the site plan identify delineated lane markings in the Kiss & Ride area in the typical Kiss & Ride design
- 3. That the pedestrian crosswalk be moved southeast to allow for the third Kiss & Ride lane to be extended
- 4. That further details be provided with respect to the type of material that is being utilized for the pedestrian walkway
- 5. That "Do not enter" signage be installed at the Orano Avenue gate
- 6. That reserved parking spaces be allocated for the parents of junior kindergarten and senior kindergarten students
- 7. That directional arrows be painted on the pavement in the turning circle located at Hartsdale Avenue

## 7. Revised Site Plan SP 09/116 – Loyola Catholic Secondary School

Report dated June 15, 2010 from the Site Plan Review Subcommittee with respect to the Revised Site Plan SP 09/116 – Loyola Catholic Secondary School.

#### **RECOMMENDATION:**

That the Commissioner of Planning and Building be advised that with respect to the Revised Site Plan SP 09/116 – Loyola Catholic Secondary School, that Traffic Safety Council has reviewed the site plan submitted on May 25, 2010 and would recommend the following;

- 1. That further details be provided with respect to the anticipated traffic patterns on the site. Specifically in regards to the volume of traffic that will exit turning left turn traffic off the site onto Sladeview Crescent,
- 2. That further details be provided with respect to the reason why the access to Ridgeway Drive was removed and the exit is restricted to right turns only,
- 3. That consideration be given to making the easterly driveway a left and right turn exit on to Sladeview Crescent, alternatively, the easterly driveway exit onto Sladeview Crescent be narrowed to create a single lane exit to restrict turning traffic to right turn only,

- 4. That further details be provided with respect to the location of the Mississauga Transit bus stop that is closest to the school entrance,
- 5. That fencing be installed along the Burnhamthorpe Road West and Ridegway Drive frontage of the school to limit student migration across the property and direct them to the existing sidewalk connections,
- 6. That the entrance to the parking lot from the westerly driveway be relocated to enhance traffic circulation and restrict through traffic within the parking lot,
- 7. That further information be provided with respect to the type of material being utilized for the pedestrian crosswalks, it is recommended that different material be used or alternatively enhanced paint markings be utilized,
- 8. That the pavement markings in the bus drop-off area be flipped and that it read "BUS DROP-OFF ONLY" as opposed to the current configuration which reads "ONLY OFF DROP BUS" when travelling along the driveway,
- 9. That a stop bar be painted across the bus lane and centre driving lane at the bus drop-off area, and that the outer lane be painted with pavement markings indicating "DRIVE THRU",
- 10. That the wording on the pavement in the student parking area drop off area be flipped so that the words read in the proper order when driving in the lane, i.e. "DROP OFF LANE".
