CALL TO ORDER – 5:00 PMDECLARATIONS OF DIRECT (OR INDIRECT) PECUNIARY INTERESTPRESENTATIONS/DEPUTATIONS

Mr. Tom Howe, Manager, Student Transportation of Peel Region (STOPR) advised that in May 2009, Student Transportation moved to a new bus planner software. He explained that the old measurement system included students that were ineligible for the bus and now the new software provides more accurate measurements. He noted that some parents of students that were found to be ineligible for school bus service were concerned that it was not safe for their children to walk to school. Anna Gentile, STOPR provided a demonstration of the bus planner software.

Members of the Committee enquired about the bus planner software and response time to make changes to bus routes. David Brown, Chair noted that he met with the Chairs of both School Boards and together they would outline the responsibilities of Traffic Safety Council, School Boards and parents with respect to getting students to school safely. Discussion ensued with respect to what items Traffic Safety Council could make recommendations on and when the matter should be referred to Council for their input.
