David Brown, Chair spoke on the passing of Jim Wilde, Life Member and the affects it could have on the Kiss & Ride program. He suggested that until the end of the term Kiss & Ride inspection could be conducted on a request basis. He advised that Peter Westbrook, David Raakman and Louise Goegan have volunteered to conduct Kiss & Ride inspections. Mr. Brown encouraged that other members volunteer as time permits.

Boris Swedak advised that Mr. Brown would attend monthly meetings at the Peel District School Board until the end of the term.

4. Site Inspection Report – Vista Heights Public School (Ward 11)

Site Inspection Report for the inspection conducted on January 14, 2010 to review the warrants for a permanent Crossing Guard at the intersection of Vista Boulevard and Sora Drive.

Councillor George Carlson appeared before committee to provide comments on the temporary crossing guard in front of Vista Heights Public School. He advised that he would be amending the recommendation at General Committee on March 3, 2010 to implement a permanent crossing guard. In addition, he would request that a proper stand for the guard and sidewalk be constructed.

David Brown, Chair commented that Vista Heights Public School is in a challenging location and it may take 3-5 years for students to adjust to utilizing the new kiss & ride. However, the warrants were not met for Traffic Safety Council to recommend that the temporary crossing guard remain in place. Jeff White, Trustee, Peel District School Board advised that he would work with the new principal to encourage usage of the new kiss & ride.

Boris Swedak commented that majority of the students crossing at the intersection were from parked vehicles. He further commented that there are no sidewalks on Sora Drive or Vista Boulevard, therefore the guard would be crossing students to no sidewalks. Mr. Brown noted that Councillor Carlson would amend the recommendation to request a sidewalk be constructed in addition to a landing pad for the guard.

RECOMMENDATION:

1. That the temporary crossing guard placed during the construction period at Vista Heights Public School, 89 Vista Boulevard be removed as the construction has been completed, the kiss & ride has been implemented and the warrants for a permanent crossing guard have not been met.
2. That Transportation & Works be requested to install the No Stopping prohibitions on the east and west sides of Sora Drive with corner restrictions.
3. That the Principal at Vista Heights Public School be requested to encourage parents and to utilize the recently completed kiss & ride that can easily accommodate all vehicles currently parking on Sora Drive.

She noted that the width of the road, speed limit, industrial area on the south side of Meadowvale Boulevard as some of the reasons for a traffic signal. She further noted that there is potential for approximately 20 students to cross the intersection at Meadowvale Boulevard and Tottington Drive. Discussion ensued with respect to amending the recommendation to clearly state the issues at the subject intersection.

RECOMMENDATION:

1. Notwithstanding that the warrants for a Crossing Guard at the intersection of Meadowvale Boulevard and Tottington Drive for the students attending Ange Gabriel Catholic School, 1830 Meadowvale Boulevard, have been met, the subject intersection is not safe for the placement of a crossing guard for the following reasons:

 - c) Meadowvale Boulevard is a four lane wide road with a centre turn lane and the traffic volume, truck traffic and observed speed do not create a safe environment for the installation of a crossing guard; and
 - d) The different start and dismissal times of the adjoining secondary school will result in students crossing the road without the protection of a crossing guard creating confusion for motorists, parents and students at the crossing; and
 - e) There are transit stops on both sides of the Meadowvale Boulevard at the intersection of Tottington Drive and students utilizing public transit have to cross the street to access the transit. Further, the transit stops are also utilized by other pedestrians that are required to cross Meadowvale Boulevard which creates a safety concern for the general public crossing this busy heavily travelled road,

Therefore it is recommended that the Transportation and Works Department be requested to install an Intersection Pedestrian Signal or a full traffic signal at the intersection to create a protected crossing for students and pedestrians at the intersection of Meadowvale Boulevard and Tottington Drive.
