



NOTICE OF ADJOURNMENT OF HEARING

IN THE MATTER OF a Notice of Appeal to the Mississauga Appeal Tribunal by Amer Hawchar of 4346 Goldenrod Crescent, Mississauga, Ontario, (Ward 6) received on February 9, 2012, of a Licensing Decision to refuse to issue a tow truck driver's licence under the City of Mississauga By-law 521-04, as amended, a Tow Truck Licensing By-law, **BE ADVISED THAT the Hearing of the subject appeal by the Mississauga Appeal Tribunal scheduled for 9:30 a.m. on Tuesday, May 29, 2012, is adjourned to 9:30 a.m. on Wednesday, September 19, 2012 in the Hearing Room, 2nd Floor, Civic Centre, 300 City Centre Drive, Mississauga, Ontario.**

The subject appeal Hearing will be heard in accordance with the provisions of the City of Mississauga By-law 521-04, as amended, and the *Statutory Powers Procedure Act, R.S.O. 1990, c. S.22*, as amended. If the appellant or their authorized representative is not present at the scheduled Hearing, the Tribunal may proceed in your absence and you will not be entitled to any future notice of the stated Hearing. In accordance with section 9 (1) of the *Statutory Powers Procedure Act, R.S.O. 1990, c. S.22*, as amended, Hearings of the Mississauga Appeal Tribunal are open to the public and any information or documents which are presented to the Tribunal will be received and noted as part of a public record. However, if there is any information that you do not wish the Tribunal to receive in a public manner and to form part of the public record, you should state your concerns at the start of the Hearing and the Tribunal will make an order. Please note that any information or documents that are received by the Tribunal as part of the public record may be subsequently disclosed to any person who makes a request for such information from the City pursuant to the provisions of the *Municipal Freedom of Information and Protection of Privacy Act*.

Be advised that you are subject to the Rules of Practice and Procedure and Practice Direction of the Mississauga Appeal Tribunal. You are also subject to the requirements of the *Law Society Act* with respect to who may appear on your behalf as an authorized representative.

In issuing its decision, the Tribunal may uphold or vary the revocation of tow truck licences or may impose any conditions on the tow truck licences that the Tribunal deems appropriate. The decision of the Tribunal is final.
