## **Low-Income Seniors and Low-Income Persons with Disabilities Tax Rebate Program**

This is an application for a tax rebate under City of Mississauga By-Law 0056-2010. A rebate of \$400.00 is provided to qualified applicants.

### **Eligibility Criteria**

**A** A person may apply if:

- (a) the person is at the time of making the application:
  - (i) 65 years of age and in receipt of the Guaranteed Income Supplement (GIS) under Part II of the *Old Age Security Act (Canada)*; or
  - (ii) in receipt of an allowance, benefits or income support as a person with a disability under the *Ontario Disability Support Program Act, 1997*; and
- (b) has been assessed as an owner of residential property located in the City of Mississauga for at least one year preceding the date of application; and

**B** The property for which they are applying is:

- (a) assessed in the residential or farm property class; and
  - (b) the principal residence within the meaning of the *Income Tax Act (Canada)*, of the owner of the property or of the spouse of an owner; and
  - (c) every owner of the property is either an eligible owner or the spouse of an eligible owner.
- ◆ Applications must be submitted by December 31<sup>st</sup> of each year for which a tax rebate is claimed.
  - ◆ A separate application is required to be completed each year.
  - ◆ No more than one application may be submitted for a property in any year.
  - ◆ An application cannot be submitted by an owner for more than one property per year.
  - ◆ The rebate when approved will be credited to the applicant's property tax account without interest.
  - ◆ Late payment charges that have been applied to the applicant's property tax account in advance of the rebate having been credited to the account will not be cancelled, reduced or refunded.
