2. Request to Demolish a Heritage Listed Property, 1380 Milton Avenue

Corporate Report dated April 16, 2010 from the Commissioner of Community Services.

3. Request to Demolish a Heritage Listed Property, 1248 Vesta Drive

Corporate Report dated April 16, 2010 from the Commissioner of Community Services.

Rick Mateljan, Citizen Member suggested that more detailed drawings be provided for the benefit of the committee, including what is being built to replace the building being demolished.

Corporate report dated April 16, 2010 from Commissioner of Community Services.

It was noted that the streetscape will be altered in a positive way. Also, the alterations will replicate the church prior to its being struck by lightning in 1923.

5. Request to Alter a Heritage Designated Property, Leslie Log House, 4415 Mississauga Road

Corporate Report dated April 16, 2010 from Commissioner of Community Services.

Matthew Wilkinson expressed concerns about the excess ornamentation on the fire door on the rear façade, and whether replicating the door is the right approach.

Questions were asked with respect to the proposed alterations by adding an emergency exit on the west side, which was added at the request of the Building Department to provide easy access to anyone using the washrooms during an emergency. Also, for the purpose of clarification, questions were asked regarding architectural detailing of the windows, lighting, paint, etc.

Discussion ensued with regard to the exterior alteration by adding an emergency exit at the rear with a new door and frame that will match the existing main entrance.

Gay Peppin expressed concerns about conflicting messages by the "No Trespassing" and Trail Signs on the property.

Recommendation:

That the request to alter the Leslie Log House, 4415 Mississauga Road, as described in the report from the Commissioner of Community Services, dated April 16, 2010, be approved, and that the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
