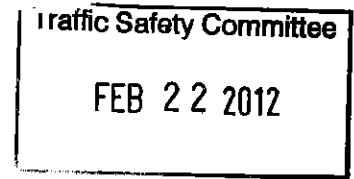

Dear Ms. Wilson,

My name is Lisa DeFrancesco and I am on the Executive Committee of the Lorne Park Watercolours Residents Association. I am writing to you today because we received a summary of the Traffic Safety Council report based on the Site Inspection at Cobalt and Canyon Street from resident Susen Anderson.

On behalf of the Association, I wanted to thank you for taking the time to examine the intersection. The Association respects the decision that the neighbourhood does not qualify for a crossing guard. However, we do have concerns about the second point which states the Transportation and Works Department would be requested to review the feasibility of maze gates at Fresco Way. You had stated that this would be presented for approval at the February 22, 2012 Traffic Safety Council Meeting. Because of the timeline, the Lorne Park Watercolours Residents Association considers this an urgent matter.

The residents of our community would appreciate if you could remove the consideration of maze gates from your agenda on the 22nd. The residents are opposed to this solution. Although a single resident has brought this forward, the LPWRA, its Executive and members fully accept the decision of the city that a crossing guard is not a necessity and consider the matter fully and finally resolved. This is an extremely low traffic area, and on objective facts, it appears that the City's conclusion is correct, and that traffic calming measures are not necessary. For the same reasons, it would appear that pedestrian calming measures are also not necessary.

Thanks for passing this along. I am surprised at the recommendation and disappointed. I find it shocking that they would say there is "light" traffic in the area at those times (I mean if you compare it to the QEW, yes it's light, but for the area I would say it is heavy!) and I sincerely think it is only a matter of time before a child is injured crossing the road there. The fact that vehicles line both sides of the street, making it difficult to see people coming off the sidewalk to cross did not get mentioned in the report. Was any thought given to allowing parking only on the north side of Canyon?

I do not feel off-set/maze gates would help the situation in any way and I have heard from the Lorne Park Watercolours Resident's Association that the neighbourhood does not want these installed. Are you able to pass this on for us or could you direct me to who I should contact to ensure this does not get put into place? Once again, thank you for arranging the site inspection.

I have received the report from the Site Inspection subcommittee of Traffic Safety Council which conducted a site inspection to review the warrants for placing a crossing guard at the intersection of Cobalt Street and Canyon Street on February 10, 2012 and they have made the following recommendation:

1. That the request for a Crossing Guard at the intersection of Canyon Street and Cobalt Street for students attending St. Luke Catholic School be denied as the warrants have not been met.
2. That the Transportation and Works Department be requested to review the feasibility of installing maze gates (off set gates) at Fresco Way and Canyon Street.
