4. **2008-2009 Wildewood Award for School Zone Safety**

Application forms for the Wildewood Award for School Zone Safety were sent to all elementary schools in Mississauga in April 2009. Mr. Jim Wilde, Kiss & Ride Volunteer, reviewed the applications and selected two (2) schools from each School Board. The volunteers and/or staff selected met the criteria and clearly demonstrated a strong commitment toward the Kiss & Ride Program at their school. Each school will receive a cheque in the amount of \$500.00 to directly benefit the students.

Peter Westbrook enquired how the nominations for the Wildewood Award for School Zone Safety are reviewed and commented that he was concerned about the nomination of Whitehorn Public School. Jim Wilde explained the nomination process and the Kiss & Ride procedures at Whitehorn Public School. Louise Goegan explained that she attended a meeting at the school to discuss implementing the Walking School Routes Program and found that the Principal and Vice-Principal were not enthused. However the Kiss & Ride criteria may differ from what is required for the Walking School Routes Program.

Councillor Sue McFadden expressed concern with the nomination of Artesian Drive Public School as the school just reopened the Kiss & Ride after numerous requests from Traffic Safety Council and parents. She further noted that the award is for 2008-2009 and Artesian

Drive Public School did not operate a Kiss & Ride in 2008.

Mona Walrond, Principals'/Vice-Principals' Association Peel District School Board commented that it took a lot of courage for the Principal to reopen the Kiss & Ride as they experienced bad behaviour from some of the parents.

David Brown, Chair commented that due to the very short history of the Kiss & Ride at Artesian Drive Public School, perhaps Traffic Safety Council could review nominating the School for the 2010 Award.

Ivan Sack suggested that schools be suggested based on how successful the Kiss & Ride is without being confined to only considering the schools that applied, as it limits your choices. Mr. Brown commented that schools should apply as the award comes with a \$500 prize and schools should not be rewarded if they have not expressed interest.

Boris Swedak suggested that 3 schools be approved for the Award this year. Mr. Brown expressed the Committee's appreciation for Mr. Wilde's work on the Committee. He noted that the Kiss & Ride at Artesian Drive has been operating for less than a month with no operation in 2008.

2. That should traffic signals not be warranted at the intersection of Duke of York Boulevard and Webb Drive, that an additional Crossing Guard be implemented to ensure safe crossing as the warrants have been met, and that the Transportation and Works Department be requested to do the following:

 - b) Install a Stop Ahead sign on the west side of Duke of York Boulevard.

Councillor Carmen Corbasson advised that there should be staff from the Ministry of Transportation Ontario, Transportation & Works staff and the fire department included in the meeting. Councillor Carmen Corbasson commented that she observed the same problem and agreed that the intersection is a unique situation. She noted that the first priority should be of the safe crossing of the students. She requested that Transportation & Works staff should come back to the next meeting on June 24, 2009 with a report.
