6. Proposed Site Plan SP 11/058 - Plum Tree Park Public School (Ward 10)

Report dated June 22, 2011 from the Site Plan Review Subcommittee of Traffic Safety Council with respect to the Proposed Site Plan for Plum Tree Park Public School.

A letter dated June 21, 2011, from Bruce Stratton Architects, outlining concerns regarding recommendations made by the Site Plan Review Subcommittee of Traffic Safety Council with respect to the Proposed Site Plan, SP 11/058 - Plum Tree Park Public School, was distributed to the Traffic Safety Council members. The concerns detailed in the letter were considered by the Traffic Safety Council when making recommendations with respect to this matter.

It was noted that Dave Marcotte, Supervisor, Preventative Maintenance, Peel District School Board, will review pedestrian traffic on the North East corner of the Plum Tree Park Public School property during and after construction of the parking lot.

RECOMMENDATION

That the Commissioner of Planning and Building be advised that with respect to the Site Plan for Plum Tree Park Public School, that Traffic Safety Council, on May 16, 2011, reviewed the site plan submitted and would recommend the following:

1. That directional pavement markings be added to indicate one way traffic circulation.
2. That School Zone Safety (Kiss and Ride) pavement markings be indicated to create a two-lane Kiss and Ride lane showing a one way student drop off lane and a one way bus drop-off lane. (Note: due to the width of the driveway it is not possible to create a typical three lane configuration.)

3. That the cross walk at the south west side of the school be removed.
4. That cross hatching be painted to delineate the cross walk at the north west side of the school.
5. That a stop bar be added on the west side of the school, at the north end of the island that runs perpendicular to the School Zone Safety (Kiss and Ride) lanes.
6. That Exit Only signs be installed, facing the school, at the north west exits, and that No Entrance signs be installed at the same exits facing Tenth Line West.
7. That Entrance Only signs be installed at the south west entrance of the school.
8. That cross hatching be painted at intervals between the bus and car lanes of the Kiss and Ride for students exiting vehicles and entering the school.
9. That a four foot high, vinyl clad, chain link fence be installed along frontage of the school between the two driveways directing students to the sidewalks to access the property or alternatively that an enhanced landscape buffer be provided to prohibit access directly to the front of the school and direct students to the sidewalks to access the school property.
10. That the existing pre-cast temporary curbs be extended along the centre of the driveway to delineate the bus drop-off lane and car drop-off lane.
11. That the Architect be requested to provide clarification on the manner in which pedestrian traffic will be accommodated around the construction staging area at the north-east corner of the property.
