 7. All purchasers of tickets, and all winners, must be at least 18 years of age. Tickets may not be advertised, offered for sale, sold or ordered from outside of Ontario. However, while they are in Ontario, residents of other countries or provinces may purchase raffle tickets sold under a licence issued in Ontario.
 8. Board, staff, club and family members, and those people living in their homes, **are/are not** eligible to win any prizes.
 9. Winning number will be notified by public announcement at event.
 10. The prize will be awarded to the holder of the winning ticket stub whose number exactly matches the ticket stub drawn.
 11. **Details must be provided regarding the method used for draws ie: what type of container will be used, number of rotations, etc.**
 12. Since the raffle is a 50/50 draw, the purchaser must be present at the draw in order to collect his or her prize. If the holder of the winning ticket number does not come forward when the number is drawn, the licensee will draw another ticket and continue to draw until the prize has been won.
 13. The draw will take place at _____ (time). If the winner does not come forward within _____ minutes of the announcement, that ticket holder forfeits any claim to the prize and another ticket will be drawn. This method will continue until a winner is determined. If necessary, a final ticket will be drawn at _____ and if no claim is made after _____ minutes, the event will end and the prize will be donated to a beneficiary approved by the licensing authority.

Licensee **must** complete, based on information provided in the application and on the licence.

Cheques may not be accepted as there is no time for them to clear the bank.

Licensee must decide and specify in the rules. Please remember to consider the *perception* that may occur if a staff or board member wins. Note that the winner must accept the prize as the licence will be for one draw per event only.

#11.

Licensee **must** provide this information. Note that the drum/box used for tickets must have ample space for all tickets to move around when rotated. A clear container provides ticket purchasers with the most assurance of the level of integrity of the event.

#13.

The licensee must determine how long they will wait before pulling another number. This may depend on the location, the event (if it is a sports event, if draw is made at half-time, etc). Time of the final draw will also be determined by the location and event. Details must be included in your rules.
