

# Mississauga Celebration Square



**Location:** 300 City Centre Drive **Consultants:** CS&P Architects Inc.

Owner: City of Mississauga Janet Rosenberg + Associates

# **Project Description**

Mississauga Celebration Square is one of the City's Infrastructure Stimulus Fund projects. It connects the old Civic Square and the Central Library Square, creating a dynamic space.

The Square employs a common palette of simple elements and materials: plantings, lighting, paving, steel structures and furnishing. Individual spaces have been inserted or redeveloped around this large space to create a framework for diverse activities and events. A new stage, a media wall, raised gardens, an enlarged lawn, a skating rink/fountain, and an elevator to the parking garage are just a few of the new features that have contributed to the creation of a large, coherent and contiguous civic space for supporting a variety of events that can bring the community together.

# **Jury Comments**

The Square is a brilliant urban space that works successfully at a community and city wide scale. It is the heart of the downtown and also the 'great meeting place' for the citizens of Mississauga - a place to celebrate major events, yet versatile and comfortable enough for everyday use. The space is successful at many levels, for its multiplicity of activities, accommodating a variety of people and functions at a variety of times.

Prior to the revitalization the previous space was a good, but today it is a wonderful space that joins the two previous squares into one dynamic and contiguous Square. The scale of the Square has the feel of a grand European plaza, but functions equally as a comfortable and friendly place. It is superbly designed with intimate spaces on its periphery that creates activity and interest even when there no major events. The trees, vegetation, pedestrian lights, arcades, steel structures and furnishings give the Square a human scale. As well, there is always a sense of animation with the fountain/skating rink, media wall, Library pavilion, raised gardens, and generous seating.

Since its completion it has exceed expectations in offering large programmed events and concerts while accommodating smaller, more passive and informal gatherings. The square will be an example for other cities of how to revitalize a central urban space. It is expected that the Square can only get better over time.



# **University of Toronto Mississauga Instructional Centre**



**Location:** 3359 Mississauga Road North **Consultants:** Perkins + Will

Owner: University of Toronto Mississauga Fleisher Ridout Partnership Inc.

# **Project Description**

The UTM Instructional Centre accommodates a wide variety of teaching spaces, study areas, student lounges and food services within the new 150,000 square foot facility at the north edge of the UTM Campus Ring Road. Together with the Hazel McCallion Academic Learning Centre, this building frames a new entry plaza and creates a dynamic new hub for student life. The play of solid and void, along with glazed atria and crush spaces between the towers, creates a porous façade along the campus ring road and encourages views and spatial flow through the buildings, filtered by mature trees, for the façade fronting on the campus playing fields. At the southern façade, a glazed gallery links the three towers and houses student lounges, a café and quiet study areas.

The building's energy efficiency relies on geothermal heating and cooling, as well as a series of photovoltaic awning panels along the southern façade. The panels transfer solar energy while providing shade. Above the student centre is a green roof. The combination of these sustainable systems of daylight and water harvesting, as well as the complementary and rich palette of copper, wood and granite materials, has created a bold material presence in response to its naturalized campus setting, while earning a LEED Gold Standard.

# **Jury Comments**

The building fronts on the campus ring road, while the other three sides of the building are cleverly integrated into the site's contours. The main entrance is reinforced with an appropriate amount of glazing and an entrance canopy. There is no rear or neglected elevation; all of the facades have beautiful building materials, sufficient glazing and generous landscaping and seamlessly fit into the grades of the site. The entrance locations create a pedestrian-friendly environment, which encourages student connectivity and movement. The glazing provides a transparency to the elevations, which makes the building inviting and accessible, while allowing natural light to penetrate the building, and affording views of the woodlot.

Although the building is large and stands out, the well-executed design maintains a human scale that is friendly and generous. The architect has chosen attractive building materials, which are further enhanced by their details, patterns and juxtaposition. The copper, wood and granite provide a harmonious palette that relates to the natural setting in a sophisticated and refined manner. This university building, along with the other newly built structures, demonstrates how an institute of higher learning can create high quality architecture that will be an inspiration and a symbol for future generations of students.

# **Clarkson Community Centre - Pool Addition**



**Location:** 2475 Truscott Drive Consultants: MJM Architects

# **Project Description**

The Clarkson Community Centre features the Clarkson Branch Library, Clarkson Arena, a full size gymnasium, an outdoor children's water play area and a variety of multipurpose rooms. The new addition was one of the City's Infrastructure Stimulus Fund projects. It features a 25-metre lap pool and a warm water/leisure pool.

The new pool addition extends out towards the street, giving increased presence and identity. This is enhanced by the large canopy over the front entrance. A large amount of glazing communicates the function of the building while allowing natural light to penetrate, and enhances the user's visit by allowing immediate visual orientation. The generous plaza and new lobby space extend the public realm from the street to the heart of the Clarkson Community Centre.

# **Jury Comments**

The simplicity and detailing of materials together with the large entrance canopy, overlaps and brings together the existing building and the pool addition. The new building emphasizes and enhances the building entrance and gathering space for the community. The nuances created by the spaces and lines of the glazing, siding, supporting beams and partition walls are beautifully and well executed together with the outdoor seating and planting areas.

# **Malton Community Centre - Pool Addition**



**Location:** 3540 Morning Star Drive **Consultants:** MJM Architects

# **Project Description**

The Malton Community Centre features the Malton Branch Library, a full size gymnasium, a fitness centre, an outdoor children's water play area and a variety of multipurpose rooms. The new addition was one of the City's Infrastructure Stimulus Fund projects. It features a 25-metre lap pool and a warm water/leisure pool. The original community centre building won Urban Design Awards in 1985 for the building itself, and again in 2004 for the building renovations.

Located along the pastoral lands of the Malton Greenway, the addition was constrained by the limits of the top of the bank of the greenbelt lands. Large amounts of glazing add natural light while keeping eyes on the property to deter vandalism. The new large canopy provides a strong sense of place for the community.

# **Jury Comments**

This beautiful pool addition provides well executed improvements to the existing community centre. The transparency through the use of large glass areas communicates the various interior functions of the new pool, extended and relocated entrance area and other rooms to the abutting landscape areas. The new extended canopy over the rear entrance area provides a strong sense of place and a dynamic backdrop to the park, splash pad and open space. The overall layout has considered security issues and provides for connections and surveillance of the various spaces through the large glazed areas, while allowing more natural light into the building and contributing to the quality and scale of the spaces.

# **Burnhamthorpe Library Redevelopment**



**Location:** 3650 Dixie Road **Owner:** City of Mississauga

Consultants: ZAS Architects + Interiors

John George Associates Inc.

# **Project Description**

The Burnhamthorpe District Library was originally constructed in 1974. It has provided a wide range of services with a public library, 201-seat theatre, meeting rooms and storage space. The original building won an Urban Design Award in 1981.

The renovation project was one of the City's Infrastructure Stimulus Fund projects. It addressed lifecycle maintenance needs, and included a modernization of the library space, the removal of accessibility barriers, and a consolidation of service points, including an introduction of self-service technology. The redesign of the entrance and lobby into multi-use spaces has improved its exterior linkages to surrounding parkland and amenities, and enables a partnership with Dixie Bloor Neighbourhood Centre.

# **Jury Comments**

Each element of this redevelopment project was approached as a design opportunity. This has provided an impressive transformation and enhancement to an existing facility. The large canopy feature creates a strong sense of arrival and forms a gathering area while emphasizing the link between the inviting building entrance and the street. The use of light reflective materials and the play of mullions, glass and structural elements provide a comfortable scale and contributes interest to the pedestrian areas. At night, the building and its lighting would be a spectacular show. Both the site and the building incorporate a number of sustainable design features such as underground water storage, green and white roofs, low flow plumbing fixtures and use of low toxicity materials.

**Councillor Nando Iannicca** First elected to City and Regional Council in 1988, Councillor Iannicca was the first politician in the history of the City of Mississauga to represent the constituency in which he was born and raised; he is often referred to as the 'Native Son of Ward 7'.

After graduating from Cawthra Park Secondary School, Councillor Iannicca spent seven years in university obtaining degrees in political science, journalism and economics. He has also completed the Canadian Securities Course and possesses a Registered Representative's Licence, as well as the Stock Options and Futures licences. Nando also completed the Ontario Real Estate Board examinations, and is fluent in French and Italian.

Councillor Iannicca spent two years working as an Investment Executive with a Mississauga investment firm prior to becoming a municipal politician. Prior to this, Councillor Iannicca worked as a special legislative aide to a local MPP and then served as a volunteer in the Premier's Office at Queens Park.

Councillor Iannicca is currently a member of General Committee, the Planning and Development Committee, and at the Region of Peel, Councillor Iannicca is a member of Regional Council and sits on the Accessibility Advisory Committee. He has sat on the Police Services Board, the Mississauga Hospital Foundation, the Salvation Army Red Shield Appeal, Mississauga Enersource/Hydro Board and the Board of the Mississauga Symphony. He is currently Chair of the Public Vehicle Advisory Committee. Councillor Iannicca and his wife Ann Marie are the proud parents of two active sons, Damian and Francis. Ann Marie Iannicca is a homemaker and an active volunteer with the Italian Seniors' Club in Mississauga.



**Mansoor Kazerouni** Mansoor is a design Principal at Page + Steele IBI Group Architects (P+S IBI) and Associate Director at IBI Group. Along with his partners Mansoor leads the P+S IBI practice.

Mansoor graduated with a Masters degree in Architecture from Washington University in St. Louis in 1992 and has since practiced Architecture with large scale projects completed in Canada, the United States, the United Arab Emirates (Dubai and Abu Dhabi), Jordan and India. His work experience of 20 years has covered a wide range of project types including high density urban mixed use developments, residential, commercial, hospitality, institutional and master-planning projects of varying scale and complexity.

Under Mansoor's design leadership the firm has undertaken such high profile projects as the award winning Rose Theatre in Brampton, The Sherman Campus in North York, Delta's new 560 key, 45 storey flagship hotel in downtown Toronto and numerous high density residential, hospitality and mixed use projects.

Mansoor is the recipient of Urban Design and Architectural awards and a member of the Ontario Association of Architects, The Toronto Society of Architects and the Royal Architectural Institute of Canada. Mansoor is also an Executive Committee member of the Urban Land Institute, Toronto.

**Michael McClelland**, OAA CAPHC FRAIC, is a founding partner of E.R.A Architects Inc. He is a registered architect specializing in heritage architectural conservation, and in particular in heritage planning and urban design.

After graduating from the University of Toronto, Michael worked in the municipal government most notably for the Toronto Historical Board, advising on municipal planning, permit and development applications, and on the preservation of City-owned museums and monuments.

Michael is the coordinating architect for the Distillery District and the heritage architect for a number of significant Toronto projects including the ROM Renaissance with Daniel Libeskind Studio, the Art Gallery of Ontario Transformation with Frank Gehry, Bridgepoint Health's conversion of the historic Don Jail, and Evergreen Foundation's adaptive reuse of the Don Valley Brickworks.

John has developed a portfolio of work in the Greater Toronto area and throughout Ontario related to urban design. He is currently the principal landscape architect for the Humber River Hospital project in Toronto, the Niagara Hospital in St.Catharines, the Markham Stouffville Hospital in Markham, the Ripleys Aquarium project in Toronto, the Sherway Gardens expansion project in Toronto, the Quinte Courthouse project in Belleville, the Mars Phase Ill project in Toronto and the Centre for Innovative Engineering at the University of Windsor.

John has worked on many award winning projects including the Shops of Don Mills Retail development in Toronto, Preston Square Mixed Use development in Ottawa, The Durham Courthouse in Oshawa and the ROM project in Toronto.

John holds a Bachelor of Landscape Architecture and is a member of the Ontario Association of Landscape Architecture (O.A.L.A.) and the Canadian Society of Landscape Architects (C.S.L.A.) since 1984.
