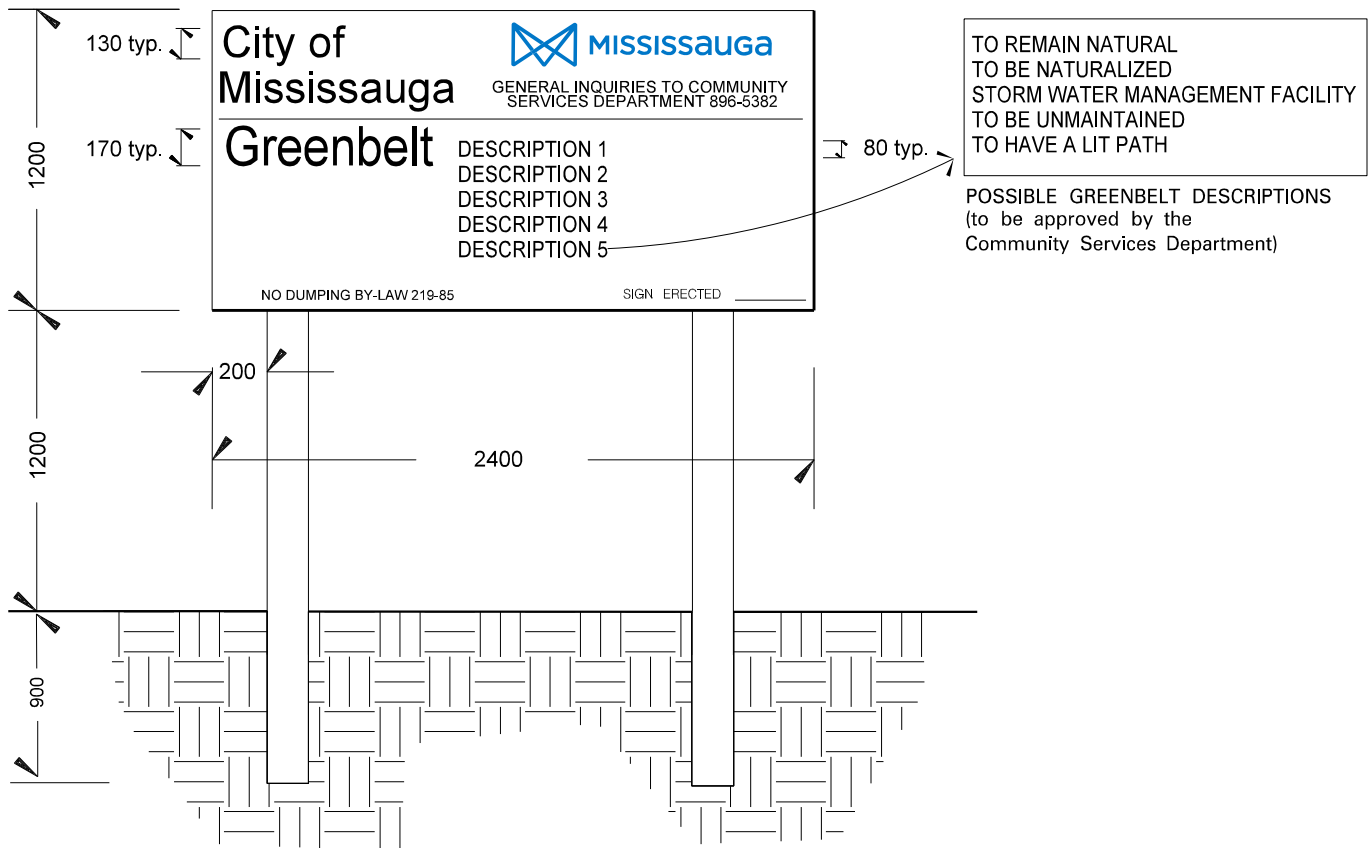

## Notification Signage Greenbelt Notification Sign

### NOTE:

CONDITIONS. ALL SITE SPECIFIC CONDITIONS  
ARE TO BE CONFIRMED BY THE PROJECT  
CONSULTANT.



### NOTES:

1. SIGN IS TO BE ERECTED ALONG EVERY ROAD FRONTAGE OF THE PARK PRIOR TO ENG. SUBMISSION.
2. SIGN INSTALLATION SUBJECT TO COMMUNITY SERVICES APPROVAL PRIOR TO RELEASE FOR REGISTRATION OF THE SERVICING AGREEMENT.
3. CONTRACTOR IS RESPONSIBLE FOR FIXING OF 12.7mm(.5") THICK PLYWOOD (G1S ) PLACARD TO 150mm x 150mm CEDAR (OR APPROVED EQUAL) VERTICAL POSTS USING 4 GAL. 18mm(7") HEX LAG BOLTS AND NUTS WITH FLAT WASHERS BOTH SIDES.
4. ALL WOOD SHALL BE PAINTED WITH ONE COAT OF PRIMER PAINT AND ONE COAT OF WHITE EXTERIOR ENAMEL PAINT IN ACCORDANCE WITH MANUFACTURES PECIFICATIONS.
5. ALL LETTERING SHALL BE BLUE (MATCH PAINT PMS #302) AND IN HELVETICA MEDIUM(M) OR BOLD(B) STYLES.
6. THE SELF-ADHESIVE CORPORATE LOGO DECAL IS AVAILABLE FROM THE COMMUNITY SERVICES - PLANNING AND ADMINISTRATION OFFICE, LOCATED AT THE CIVIC CENTRE. THERE WILL BE A FEE CHARGED FOR THIS DECAL.
7. POST HOLES TO BE 900mm IN DEPTH AND BACKFILLED WITH COMPACTED LIMESTONE SCREENINGS.
8. THE GREENBELT SHALL BE DESCRIBED ON THE SIGN IN ACCORDANCE WITH APPROVED PARK AND GREENBELT MASTERPLAN DRAWINGS AND AS APPROVED BY COMMUNITY SERVICES - PLANNING AND HERITAGE.
9. ALL SIGNS MUST BE REMOVED AT DATE SPECIFIED BY COMMUNITY SERVICES OR AT COMPLETION OF CONTRACT BY THE CONTRACTOR.
10. POST HOLES ARE TO BE REINSTATED BY CONTRACTOR AFTER REMOVAL OF THE SIGN.
11. ALL DIMENSIONS ARE IN MILLIMETERS UNLESS OTHERWISE NOTED.
