

Thank-you for your specific comments, and knowledge of deer sites (below), in addition to the CRAA's preference to Alternative 3 (southern route) regarding the Credit Meadows Expansion Municipal Class Environmental Assessment (MCEA) Study. Your comments will become part of the public record; and will be taken into consideration by the Study Team as they conduct the numerous technical supporting studies. 

From the issue of the notice to expectations of final response for a planning of this nature in three weeks. I think is unfair. In the current crisis of covid and expecting people to get together and voice any concerns this short time needs allot more to be desirable.

In any case I would like to bring forward a few comments and if possible to include in your assessment and planning. I really would appreciate it.

I live in the area and and the proposed pathways would be passing several back yards . I have been resident for over 15 years and bring forward the following points to your attention

- 2)There are several wild coyotes, foxes in the area and can pose potential risk to children walking if the project goes ahead. Similarly the wild life would be driven away but are restricted by the 401 highway and exposing them to danger.
- 3)The entrance from Swinbourne Drive area is already flooded at times with people going into the sanctuary. Creating this plan would increase the traffic to the area .Their are many children in the area and I am concerned for their safety with the potential for increased traffic.
- 4) Allot of the existing traffic is also related to young teenagers and adults and has become a meeting point and smoking gala at times. This project will enhance the venue for more unfavorable behavior
- 5)Privacy to to residents will be affected.Part of the premium paid for these residents was to ensure privacy. Your paths will be directly behind the residents back yards and disturbing the residents privacy and attracting some unwanted behavior again

If I have any voice then I would strongly object to this planning in view of the interference on the wild life sanctuary as well as the encroachment on the residents in the area. Safety due to increased traffic in the area is also a concern.

Finally despite warnings, teenagers always use the pond in winter and are at risk of falling thru the frozen pond.

I wanted to follow up on our conversation about trail accessibility. Please find the link to the <u>2015 Facilities Accessibility Design Standards</u> the City uses when designing trails. In section **4.5.2 Outdoor Recreation and Facilities** under the heading **Recreational Trails and Footbridges**, you will find the standards for accessible trail development. When we spoke last week, I mentioned some of the stages the development of a trail goes through, please find a high-level overview below:

- Once the EA is complete and approved by the Ministry of Environment, Conservation, and Parks our Park Development team and the consultant will begin designing the preferred route.
- The City's Facilities Accessibility Design Standards (FADS) committee will be consulted to review the proposed trail and alignment to ensure it meets the City's accessibility standards; they also provided additional recommendations for accessibility (if required).

Exceptions to the requirements that apply to *recreational trails* are permitted where the requirements, or some of them, would likely affect the heritage, historic, cultural or natural heritage value of an area. Refer to Part IV.1 of Ontario Regulation 191/11 (Integrated Accessibility Standards).

The City's Accessibility Advisory Committee reviews policies, programs, and services to ensure the City remains accessible.

- 1.1.2 There was discussion regarding the trail design and maintenance. The trail is proposed to be 3.5m wide with 1m mowed on either side. A construction area 10m wide has been assumed. The trail will not have lighting. It is not currently known if the trail will be maintained during the winter.
- 1.1.3 The section of trail through the open black walnut woodland would be laid out during detailed design to avoid tree removal to the extent possible. The trail will run along the bottom of the slope and will be located to respect wetland setbacks, limiting interaction with the toe of slope and limiting views form the adjacent housing to the extent possible.
- 1.1.4 It was agreed that the area proposed for the Fletcher's Creek bridge is generally stable, given its previous use as a rail bed. Geotechnical work is required to design the bridge and confirm bank setbacks. There are logistical challenges to get a drill rig to the site. The report further states that "at the time of writing, scour of the 100-year flow condition has yet to be addressed, but will be addressed in the final version, in collaboration with the Burnside water resources team". 7.	As noted with the previously provided comments, there is a valley slope associated with the proposed Credit River crossing No. 2. The	Table 8-1 indicates that "Geotechnical studies, including slope stability analysis will be completed prior

slope appears to be greater than 2 m in height with slope inclinations greater than 3:1 and as such, the proposed bridge crossing No. 2 may also be located within a slope hazard. Please note that a geotechnical investigation and slope stability analysis is to be completed to ensure that the proposed bridge crossing is not located within both the erosion and slope hazards. Slope stability analysis is to be completed in accordance with CVC's Slope Stability Guideline: https://cvc.ca/wp-content/uploads/2012/02/Slope-Stability-Determination-Guidelines.pdf to determine the long term stable slope line (LTSSL) within areas within close proximity to the valley slope. Slope stability analysis may impact the span of the proposed bridge span at Credit River crossing no. 2.

As such, the slope stability analysis should be completed during the EA process and the preferred plan should consider all applicable hazards. Additional comments regarding slope stability may be required during detailed design pending the level of analysis completed during the EA stage.

- 8. The following are comments relating to the preferred trail network plan, as specified within the EA Report completed by R.J. Burnside and Associates:
 - a) As noted in previously provided comments, portions of the preferred trail network (specifically within and around the Credit River crossing locations and/or trails running close to the river) could be impacted by flooding/storm events as frequent as the 5year storm. The proposed trail is located within an urban setting

to Project construction to identify any design and mitigation requirements in, and around, Valleylands. Slope stability will be assessed at the east bank of Crossing #2 and any other steep slope traversed by the trail, in accordance with CVC Regulations."

The following text will be added to Section 7.1:

"As noted in Section 5.3.2, some of the banks along the Credit River are steep. This is particularly the case in the vicinity of Crossing #2. A slope stability assessment will be completed during detailed design and may result in the need for additional bridge modifications, including additional setbacks from the banks for bridge abutments."

It acknowledged that the trail will be located within the Regulatory floodplain however, it is not feasible to place the trail network outside of the regulatory floodplain due to the depth of the floodplain within the valley of the Credit River. The proposed trail network is to be installed to mimic the natural topography of the valley floor whereby using the natural terrain to the best extent possible. This will ensure the trail not only feels like a "natural" trail system but also reduces the

We have provided a floodplain depth summary associated with each return event in the Hydraulic Memo. These floodplain depths are preliminary at this time as the final design of the trail system has not been completed. Impacts should be minimized during detailed design and a commitment to compensate for losses to achieve an overall ecological gain should be made at the EA stage. Thanks for speaking with me today. I've attached a figure showing our study area along the Credit River just south of Hwy 401. We are focused primarily on the blue park expansion area shown.

I wanted to give you some additional background about this site and the work that has been done to date. As I mentioned we reached out to HDI last year a couple of times and didn't hear back. We moved forward with ecological and archaeological work at that time. At this point, most of that work is now complete. However, we ran into some challenges last year with the Stage 2 Archaeological Assessment. There was a significant amount of grass at the site and, even after ploughing, conditions were not suitable to conduct the Stage 2 pedestrian surveys. So, some portions of the site were completed but not all. We are planning to complete the work this August. MCFN field liaisons were present for the work last year and will continue to be present for the upcoming work to finish the pedestrian surveys.

Because of the site preparation challenges last year, MCFN staff will be onsite on July 30th while the ploughing contractor is doing the site preparation. Please let us know if you are interesting in seeing this part of the work. Otherwise, the actual pedestrian surveys are scheduled for mid-August. We will let you know the actual date closer to the time.

First of all, we would like to thank you for respecting our interest in this property and requesting our comments.

Six Nations of the Grand Rivers' Aboriginal and Treaty Rights throughout Southern Ontario are well documented through archaeological findings, historical facts and written Treaty Agreements. The Haldimand Treaty and the 1701 Fort Albany/Nanfan Treaty have been recognized in past court proceedings and are presented as factual evidence in the ongoing litigation from 1995 between Six Nations of the Grand River and the provincial and federal Crowns.

Although this project does not lie within our Traditional Haldimand Tract Treaty area, it does lies within the 1701 Fort Albany/Nanfan Treaty area and Six Nations of the Grand River is concerned about any development relating to land, water, wildlife, and resources which occur throughout our treaty territory and any archeological issues associated with such development(s).

At this time, our two main concerns of course, are the impacts on the natural environment that this project may have and as we have already indicated, the archaeological implications regarding this project. 


