## NOTICE OF STUDY COMPLETION

### Municipal Class Environmental Assessment

The City of Mississauga has completed Phases 1 and 2 of the Municipal Class Environmental Assessment of the Dundas Corridor Study which culminated in a master plan document, titled, Dundas Connects Master Plan. The purpose of this study is to determine an approach to integrate transportation and land use planning, and implement best practices along the corridor to address current and future needs and opportunities. The segment of Dundas Street covered by the study recommendations is between Highway 403 in the City of Mississauga and Kipling Subway Station in the City of Toronto. Three rounds of Public Information Centres were held in April 2016, October 2016 and April 2017 to provide interested parties with an opportunity to review and discuss issues related to the study. Comments received from the public, agencies and other stakeholders during the course of the study have been considered in the preparation of the final report.



The study has followed the approved environmental planning process for a Master Plan under the Municipal Engineers Association Municipal Class Environmental Assessment (Class EA) document, as amended in 2007, 2011 and 2015, which is approved under the Ontario *Environmental Assessment Act*. The Master Plan has been prepared to a level of detail that satisfies the Phase 1 and 2 requirements for each proposed recommendation identified in the Master Plan. The most significant recommendations identified include:

- Supporting mixed use, transit-supportive intensification across Dundas Street and in key areas
- Bus Rapid Transit (BRT) along Dundas Street as the preferred transit solution
- Creating a complete street for all users

Implementation of these proposed recommendations, for which the next step will be the design phase, has not been scheduled.
