

# Dundas Street Right-of-Way Mississauga Official Plan Amendment – Implementing Recommendation from Dundas Connects Master Plan

#### City's Proposal:

To consider changes to the Mississauga Official Plan for the Dundas Street right-of-way width. Proposed changes will widen the Dundas Street right-of-way from generally 35 m to 40-42 m. The wider right-of-way will protect for dedicated bus lanes, four general vehicular lanes, and enhanced pedestrian and cycling amenities.



If a person or public body does not make oral submissions at a public meeting or make written submissions to the City before the by-law is passed, the person or public body is not entitled to appeal the decision of City Council to the Local Planning Appeal Tribunal, or be added as a party to an appeal of the decision to the Tribunal.

The decision of City Council is final if a notice of appeal is not received on or before the last day for filing a notice of appeal.
