



## Facility Background

- Originally built in 1972 formerly known as Cawthra Arena
- Facility modernization and major expansion in 2002
- Re-named in 2012 in honour of former Ward
   1 Councillor, Carmen Corbasson




#### Current amenities

Two indoor rinks, gymnasium, multi-purpose spaces, studio, walking track

## **Existing Site**

- Carmen Corbasson Community Centre
- Mississauga Seniors' Centre
- Cawthra school pool (joint use agreement with the school board)
- Adjacent to Cawthra SS, and nearby St. Paul SS
- Connection to Cawthra Park woodlot
- Within the Lakeview Community



## Project Background

The primary indoor pool for Ward 1 residents is the Cawthra School Pool

- The pool is approximately 45 years old
- Has reached the end of its lifecycle, and requires millions of dollars of upgrades to improve
- Needs accessibility improvements to better meet the needs of the community
- School pool will continue in operation during redevelopment – planned for demolition following the CC re-opening

#### Feasibility Study

In 2018, a Feasibility Study was commenced, which focused on validating and identifying redevelopment needs at the following 3 Recreation locations: Burnhamthorpe CC, *Carmen Corbasson CC* and South Common CC.

This study included detailed facility assessments, expansion location options, design strategies and associated costing for each location.

## Project Background

In 2019, the Recreation Master Plan (Future Directions) was approved by Mississauga Council

- Extensive public surveys about the types of programs and services residents want
- Various stakeholder focus groups
- Members of council and key opinion leader interviews
- Recreation staff surveys and workshops



#### **Priority Project**

Identified Carmen Corbasson CC redevelopment as a priority project, with specific recommendations to include a new aquatics centre and equipment based fitness centre



## Project Background

Existing 90,000 sq.ft facility includes:

- Twin pad arena with change rooms
- Double gymnasium with elevated running track multipurpose rooms, activity rooms
- Admin and support spaces



In 2020, Diamond & Schmitt Architects Inc. and Aquicon Construction were awarded the Design and Construction Management Services.

Diamond & Schmitt Architects are familiar with this facility having completed the 2002 expansion.

#### REDEVELOPMENT SCOPE OF WORK INCLUDES:

- Approx. 48,000 sq.ft building addition
- 6 lane 25M lap pool
- Therapeutic/warm water pool
- Equipment based fitness centre with aerobics studio and change rooms
- Mechanical and Electrical equipment upgrades
- Repurpose/refresh existing spaces as supported by budget

## Design Objectives

- Improve the quality of recreational services provided to the residents.
- Alleviate pressures on existing recreational infrastructure & meet the increasing demand for aquatics in the area
- Address the aging state of municipal infrastructure



Improve accessibility to meet the City's accessibility goals, comply with AODA and the City's Facility Accessibility Design Standards.



Improve site safety to meet the City's Vision Zero objectives - eliminate all traffic fatalities and injuries while increasing mobility and safety for pedestrians, cyclists and drivers.

Vision Zero – City of Mississauga



Design with an environmentally responsible approach, improve energy efficiency and meet the City's Green Building Standards.

#### Site Considerations

- Connection to existing building continuity in the design
- Achieve a "link" to the Seniors' Centre
- Access to Seniors' Centre during construction
- Existing bus loop and interaction with car, bus and pedestrian traffic
- Adequate parking
- Environmental considerations



The massing of the new facility to provide a compact footprint that wraps the south entry lobby



Create strong linkages between indoor and outdoor activity spaces, introduce daylight throughout



Make the most of the natural woodlot amenity to the east and north of the existing building





### Schematic Design Options – Site Plan

Several site plan design iterations were studied with a preferred option selected relocating the bus stop adjacent to the site on Cawthra Road





## Data Supporting Bus Loop Modifications

#### Safety

Anticipate greater traffic on site, limiting mix of vehicular/pedestrian traffic improves site safety. Commitment to Vision Zero – City of Mississauga Vision Zero – City of

Mississauga



#### Cost

Bus Loop onsite costs MiWay Transit an additional \$125,000 per year (over half the trips do not pick up or drop off anyone)


#### Benchmarking

Customers exiting bus at Cawthra Road walk an estimated 160 meters to the Seniors' Centre, comparable based on other similar City destinations

### Schematic Design – Site Plan


#### **KEY FEATURES/ENHACEMENTS:**

- New canopy link, heated bus shelter
- Digital transit screens within both buildings to inform on bus arrival times
- The Seniors Centre will continue to be accessible for TransHelp Drop-off
- Campus Programming Community Centre
   will be a destination for Seniors






#### 1st Floor

- New aquatics centre
- Change rooms for aquatics and fitness
- Customer Service desk relocated for optimal visibility, accessibility, and control
- Enhancements to interior rink viewing




#### 1st Floor – East Side

- 6 lane, 25 m lap pool
- Therapeutic/warm water tank
- On-deck viewing gallery
- Views from the pool out into the woodlot
- Mechanicals, storage and functional staff spaces




#### 1st Floor – West Side

- Expanded lobby space
- Studio converted to multi-purpose space
- Improved public washrooms and change space



#### 2nd Floor

- Equipment based fitness centre
- Fitness studio
- Expansive views while working out, participating in a class
- Good access to existing walking track on this floor



#### 2nd Floor - Fitness

- Open concept design, views below to pool/exterior
- Controlled access elevator for fitness customers from 1st floor changerooms to fitness centre/studio









### Mississauga Seniors' Centre

- Will be open throughout the redevelopment of the community centre
- Access to site changes through school lot during redevelopment



#### Minor updates being considered:

- Sliding doors installed at front, main entrance
- Accessible reception/customer service desk counter
- Front, exterior improvements (seating, planting, covered pathway)
