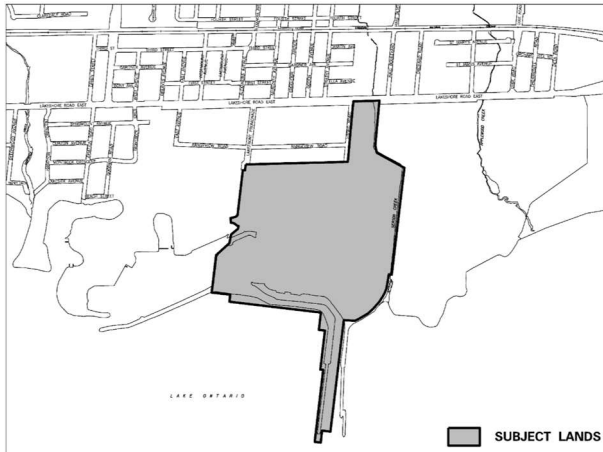

#### **Applicant's Proposal:**

To change the official plan, zoning and to approve a plan of subdivision to permit a mixed-use and multi-phase project that will create a waterfront community of 8,050 residential units (townhouse, mid-rise and high-rise), parks, cultural, employment, and commercial uses.

The remediation of on-site contamination will be evaluated through the review of these applications and addressed in the Corporate Report.

The proposal includes a Class 4 Noise Area classification for part of the site in accordance with the NPC-300 Environmental Noise Guidelines which is addressed in the Corporate Report.

### **Information about Appeals:**

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City before the by-law is passed, the person or public body is not entitled to appeal the decision of City Council to the Ontario Land Tribunal, or be added as a party to an appeal of the decision to the Tribunal.

The proposed Official Plan amendment is exempt from approval by the Region of Peel. The decision of City Council is final if a notice of appeal is not received on or before the last day for filing a notice of appeal.
