TAKE NOTICE that the Council of the Corporation of the City of Mississauga passed the above noted Zoning By-law, under Section 34 of the Planning Act, R.S.O., 1990, c.P.13. There were no written and oral submissions from the public on this matter. This notice is issued in accordance with Ontario Regulation 345/20 under the Emergency Management and Civil Protection Act.

THE PURPOSE AND EFFECT of this By-law is to extend the temporary permissions for temporary outdoor patios accessory to restaurants, convenience restaurants and take-out restaurants in certain Base and Exception Zones including Port Credit, until December 31, 2023.

THE CORPORATION OF THE CITY OF MISSISSAUGA

BY-LAW NUMBER 0241-2021

A by-law to amend By-law Number 0225-2007, as amended.

WHEREAS pursuant to section 39 of the *Planning Act*, R.S.O. 1990, c.P.13, as amended, the council of a local municipality may in a zoning by-law passed under section 34 of the *Planning Act*, authorize the temporary use of land, buildings or structures for such purpose as set out therein, limited to a period of time not exceeding three years;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. By-law Number 0225-2007, as amended, being a City of Mississauga Zoning By-law, is amended by adding the words "temporary outdoor patio" in parentheses and changing the date in Sentence 2.1.9.14.1 contained in Article 2.1.9.14 as follows:

2.1.9.14.1 The provisions contained in Article 1.1.13.3 (**temporary outdoor patio**), Section 1.2 (only **temporary outdoor patio**) and Article 2.1.9.14 of this By-law shall only be in effect for a temporary period from the date of enactment and passing of a temporary use by-law until ~~December 31, 2021~~ December 31, 2023. (0163-2020), (0233-2020)

2. By-law Number 0225-2007, as amended, is further amended by adding Sentence 2.1.9.14.2 to Article 2.1.9.14 as follows:

2.1.9.14.2 Notwithstanding Line 1.0 contained in Table 2.1.9.14 of this By-law, a **temporary outdoor patio** will be permitted on lands identified on Schedules 2.1.9.14(1), (2) and (3) of this By-law.

3. By-law Number 0225-2007, as amended, is further amended by adding Schedules 2.1.9.14(1), (2) and (3), attached to this By-law.

4. The greyed-out text, identified in Section 1 of this By-law, is for information purposes only and does not form part of the amendments contained in this By-law.

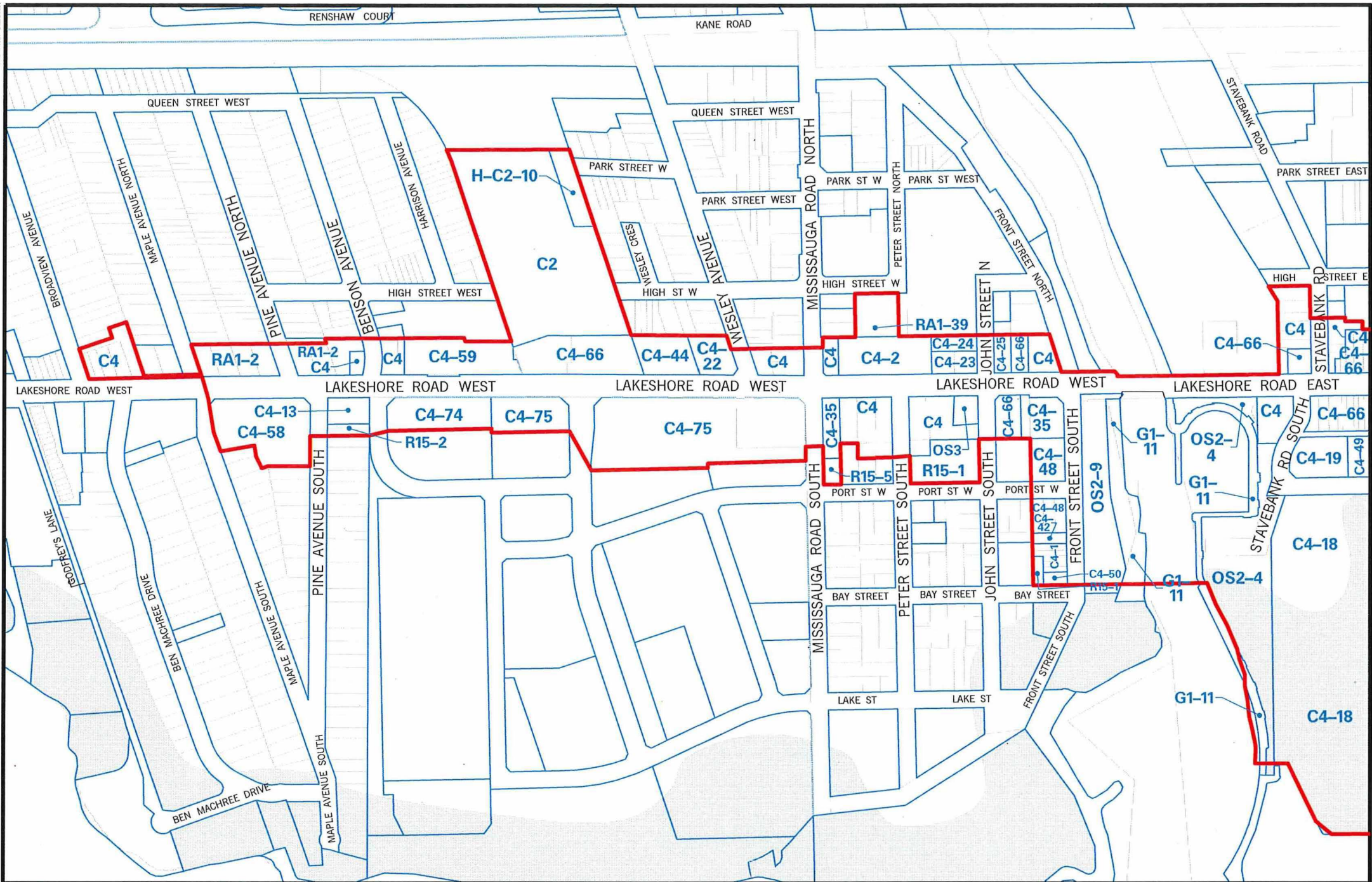

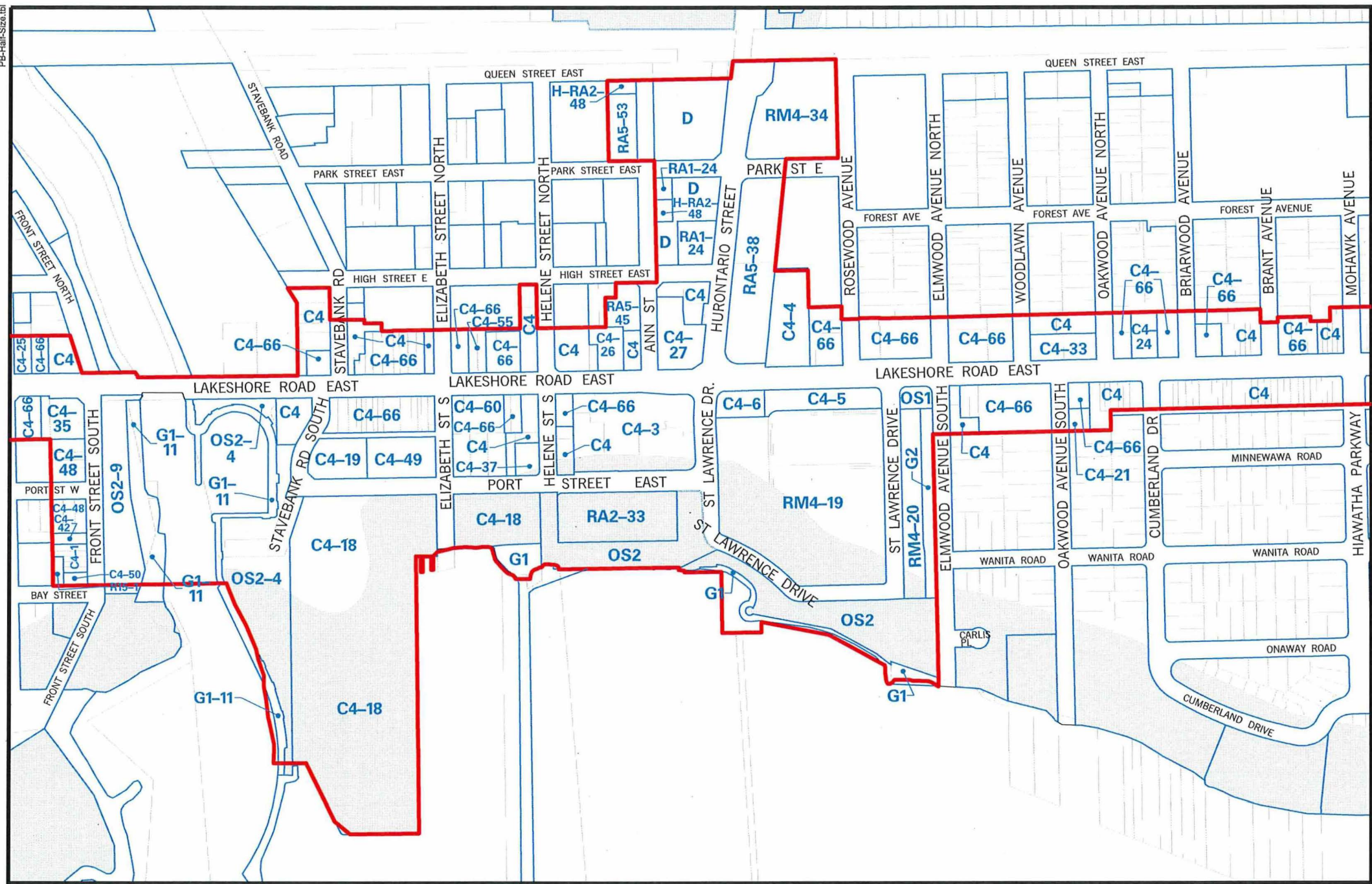

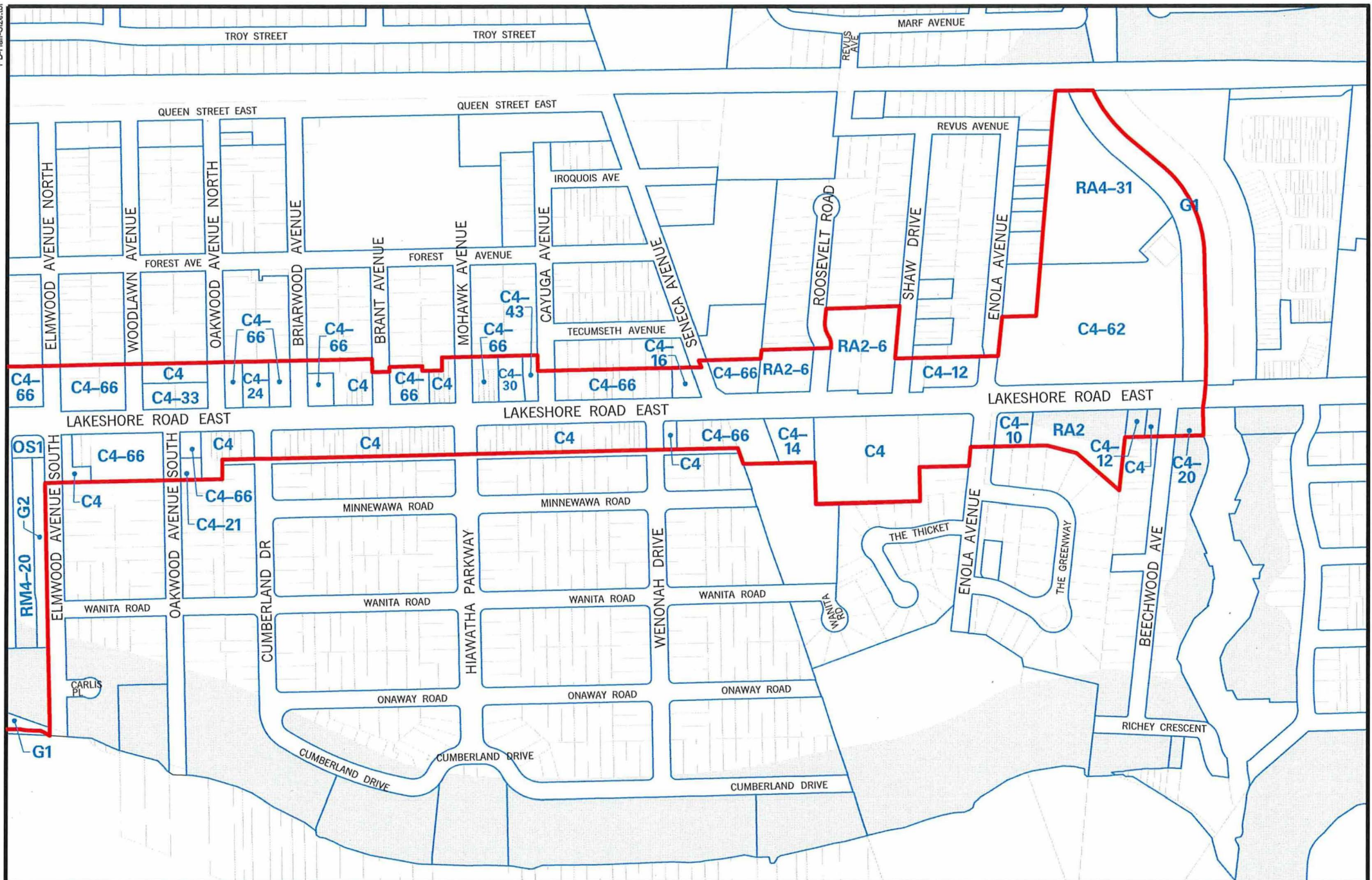
Permitted Zones for Temporary Outdoor Patio
