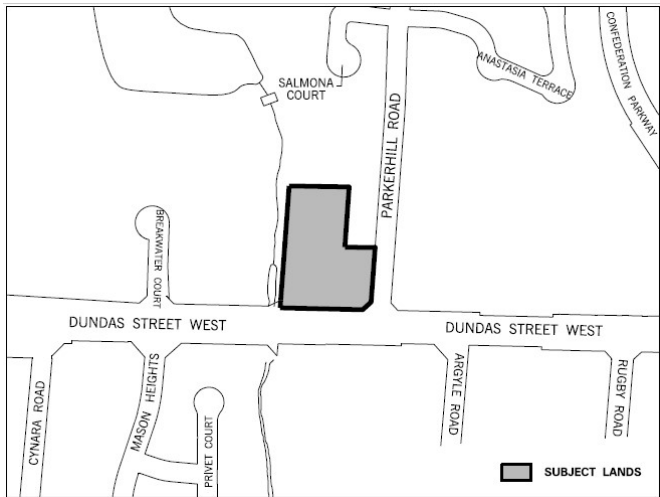

Applicant's Proposal: To change the official plan and zoning to permit a stepped 4 to 14 storey apartment building with 393 dwelling units and ground floor commercial contained in a 6 storey podium along Dundas Street West. The proposed building steps up from 8 storeys at the intersection of Dundas and Parkerhill Road to 14 storeys adjacent to Mary Fix Creek. The proposed building also steps down from Dundas Street West to 4 storeys adjacent to the existing dwellings along Parkerhill Road. Driveway access is proposed from Parkerhill Road. In order to be received by Committee at the public meeting, written comments must be received no later than 48 hours prior to the meeting. Submissions are accepted by email at deputations.presentations@mississauga.ca or by mailing the Planning and Development Committee, 300 City Centre Drive, 2nd Floor, Mississauga, ON L5B 3C1. Please include your name, your address, and application number or address of the property you are providing comments on. Written comments received before, during or after a public meeting but before a by-law is passed receive the same consideration as verbal comments made during a public meeting.

Participate Virtually

Information about Appeals:

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City before the by-law is passed, the person or public body is not entitled to appeal the decision of City Council to the Ontario Land Tribunal, or be added as a party to an appeal of the decision to the Tribunal.

The proposed Official Plan amendment is exempt from approval by the Region of Peel. The decision of City Council is final if a notice of appeal is not received on or before the last day for filing a notice of appeal.
