
Municipal Class Environmental Assessment Study

NOTICE OF STUDY COMPLETION

The Study

The City of Mississauga has completed a study to review opportunities to improve the Lakeshore Road West and Clarkson Road North / Clarkson Road South intersections. The project was completed under 'Schedule B' of the Municipal Class Environmental Assessment process. The City intends to phase the improvements at the intersection by implementing an interim preferred solution in the short-to-medium term and a preferred solution in the longer term. The recommended improvements include:

- **Interim Preferred Solution** – Installation of a raised median between the intersections, and provision of side-by-side left-turn lanes.
- **Preferred Solution** - Realignment of Clarkson Road North opposite Clarkson Road South to create a single four-leg intersection.
- Consolidation and modifications to driveways/accesses on Lakeshore Road West, including provision of a raised centre median.
- Improvements to pedestrian, cycling and transit facilities.



Study Report Review Period

The Project File Report documents the planning, consultation, preliminary design, and decision-making process undertaken for the project and will be available for review for 45 calendar days starting **October 13, 2022 to November 28, 2022**. The report can be reviewed on the City of Mississauga's project website at mississauga.ca/lakeshore-clarkson. Please provide written comments to the Project Manager within the 45-day review period. In addition, a request may also be made to the Minister of the Environment, Conservation and Parks to make an order for a higher level of study (requiring an individual/comprehensive EA approval before proceeding), or that conditions be imposed (such as the requirement of further studies) on the grounds that the requested Order may prevent, mitigate, or remedy adverse impacts on constitutionally protected Aboriginal and treaty rights. Requests should be sent in writing or by email by 4:30 p.m. on **Monday, November 28, 2022** to the address provided below and include the requester's contact information and full name of the Ministry.
