
City's Proposal:

City of Mississauga (Wards 1 to 11)

File: BL.09-PLA (All Wards)

Proposed city-wide changes: The City of Mississauga is proposing to make changes to the Zoning By-law in order to permit and regulate industries that grow and cultivate plants as a part of their manufacturing process, in Employment zones.

Proposed site-specific changes: Minor Zoning By-law amendments will also be introduced to restrict the introduction of new manufacturing uses (Medicinal Product Manufacturing Facility, Medicinal Product Manufacturing Facility – Restricted, and Plant-Based Manufacturing Facility) in order to align with the office-focused Airport Corporate Centre Character Area policies contained within Mississauga's Official Plan.

In order to be received by Council at the meeting, written comments must be received no later than 48 hours prior to the meeting. Please include your name, your address, and application number or address of the property you are providing comments on. Written comments received before, during or after a Council meeting but before a by-law is passed receive the same consideration as verbal comments made during a Council meeting.
