RATHBURN ROAD AND PONYTRAIL DRIVE INTEGRATED ROAD PROJECT

Construction scheduled to commence: On or after September 18, 2023

Construction scheduled to be completed: On or before November 30, 2024

Project Overview

The City is making various road improvements on Rathburn Road East from Dixie Road to Etobicoke Creek and Ponytrail Drive from Rathburn Road East to Burnhamthorpe Road East.

The proposed work includes pavement rehabilitation, intersection improvements, new traffic signals and street lights, curb, sidewalk and catch basin repairs and maintenance, installation of cycle tracks, culvert replacement, and installation of noise walls.

What to Expect During Construction

Impact/ Safety	Dust, noise and other inconveniences may be experienced. The City will make every effort to reduce these impacts. Avoid contact with hot asphalt or any construction material at all times.
Work Hours	Work will occur between 7:00 am and 7:00 pm Monday to Friday . Saturday work will only occur if required. All work is weather dependent and based on the contractor's schedule and may vary.
Sprinkler Systems/ Private Fixtures	Irrigation heads, sprinkler lines and/or other private fixtures (including decorative fencing, flower beds) located on City's property that may interfere with work, must be removed by residents and/or private property owners prior to construction. Irrigation heads and sprinkler lines and/or other fixtures will not be reinstalled by the City and the City accepts no responsibility for any damages to private fixtures placed on City property.
Parking	On street parking is prohibited on Rathburn Road and Ponytrail Drive during construction.

Traffic and Pedestrians	ROADS	Vehicle lanes may be reduced from four lanes to two lanes in sections, throughout construction.			
	SIDEWALKS	Sidewalks will be maintained, with sufficient signage, to guide pedestrians around the work area.			
	TRAILS	Access to ORT 11 (hydro corridor) and Shaver Trail may be closed at times, however the trail will remain open.			
Transit Service	Please be advised that the following transit infrastructure (stops/shelters) will be improved to meet the principles and goals outlined in the Accessibility for Ontarians with Disabilities Act (AODA) and MiWay's Standard Drawings as part of the construction. There is a potential for temporary service disruptions at these stops. Should maintaining this stop not be feasible due to construction impacts, a temporary bus stop location as close to the original stop location shall be proposed if required. If the curb in front of the property is being replaced, the construction crew will remove half of the driveway at a time to allow for access at all times. If you have more than one driveway, at least one driveway will remain open at all times.				
Restoration Works	The construction site will be restored after construction has been completed.
